

## The Third Generation Partnership Project 2 Welcomes the CDMA Certification Forum as Market Representation Partner

16 July 2012 – Arlington, VA – On 23 April 2012, the Third Generation Partnership Project 2 (3GPP2) announced that the CDMA Certification Forum (CCF) was unanimously approved as a Market Representation Partner (MRP) during the 3GPP2 Organizational Partners meeting held in Chicago, IL (USA).

This MRP relationship extends the collaboration between 3GPP2 and CCF in promoting world-class wireless technology standards partnered with test processes and solutions developed for the global wireless industry.

3GPP2's MRPs provide market advice to the entire 3GPP2 organization and bring to 3GPP2 a consensus view of market requirements (e.g., services, features and functionality) falling within the 3GPP2 scope. The CCF has developed and maintains a core global device certification process that improves products' quality through consistent interoperability, conformance and performance testing across the globe.

"In order to facilitate the deployment of fixed-mobile convergence solutions, consensus contributions from industry groups such as the CDMA Certification Forum are essential to ensuring high quality specifications that accelerate multi-vendor interoperability", said Cheryl Blum, 3GPP2 Steering Committee Chair. "We look forward to their contributions and welcome the CDMA Certification Forum to MRP status."
