c. Review and Approve Agenda

The agenda was submitted for review and approved with the addition of a discussion of colocated meetings with T1E1 under Old Business.

d. TIA Patent Policy

The Chair made the attendees aware of the following statement concerning TIA's Patent Policy and the desire for early disclosure of patents, the use of which may be essential to any standard or other document being developed for publication:

There is no objection in principle to drafting a TIA Publication in terms that may require the use of a patent. Participants in the work of the TR-41 are urged to review the Patent Policy in TIA's Engineering Manual. An electronic version of the Engineering Manual is available on TIA's website at www.tiaonline.org, or a copy may be obtained from the TIA Secretariat.

Individual participants are encouraged to notify TIA of any patents or pending patent applications that may be <u>essential</u> to the practice of a proposed TIA Publication. Such notification should be made early in the development process to reduce the possibility for delays and increase the likelihood that the proposed TIA Publication will be approved. The participant making such a disclosure will be requested to have his/her company submit a statement concerning its willingness to license the essential patents as set forth in Annex H to the Engineering Manual. The disclosure need not (but may) identify the specific patents or pending patent applications that may be essential to the practice of the proposed TIA Publication.

Patent searches are not required to comply with the TIA Patent Policy.

e. Chair's Remarks

The chair again emphasized the need to post all contributions on the TIA web site. The use of email distribution is not the answer, particularly when there are very large attachments. Posting the contributions on the website and sending out an email notice to go download them allows people to get them at their leisure. Also, the information needs to be available on the web site for new people who are trying to find out what is going in in various groups.

Training on the requirements for conducting meetings and for balloting and publishing documents was provided to the chairs and editors in a session on Wednesday evening. During that session, we learned of a proposal from the Intellectual Property Rights Working Group (IPRWG) that would require every contribution to have a copyright statement on it. This aroused considerable concern among those present. The chair raised the issue concerning such things as agendas, meeting reports, document lists, draft standards, liaison documents etc. that were not the contributions of any particular TIA member during an IPRWG conference call on Thursday afternoon. He reported there was general agreement to exclude these sorts of things and only require the copyright statement on actual contributions that might find their way into a subsequently published document.

The chair also stressed the need to follow through on commitments. He noted that during the past year there have been occasions where scheduled meetings were not held or were held in an ad hoc manor because the chair did not show up and did not find someone else to run the meeting. There have also been occasions where documents were approved to go to ballot or publication after editorial cleanup but did not go out, and there have been occasions where approval was received to send liaison correspondence that was not sent. It is critical that we follow through on actions concurred with or approved by the plenary if subcommittees are going to continue to operate with autonomy.

5. Old business

The chair opened up discussion with respect to co-location of TR41 and T1E1 meetings. Phillip Havens suggested that every other meeting would prove beneficial. Greg Slingerland concurred. Greg also mentioned that voting rights may become an issue since two consecutive meetings are required to become a voting member. It was the consensus of those present that alternating co-located meetings with separate meetings would be desirable. This proposal will be presented as the TR-41 position during the all-chairs meeting in Denver. The August and November 2002 meetings will be co-located. Alternating co-located meetings could commence in February 2003, with May 2003 not being co-locate, etc.
