#### 7. Subcommittee reports and action items

### 7a. TR-42.1, Commercial Building Telecommunications Cabling 3/4 John Siemon

Documents: TR-42/00-12-056 TR-42/00-12-057

1. Ballot resolution was held on default ballot SP-4425-B-2, *Commercial Building* Telecommunications Cabling Standard: Part 1, General Requirements. There were two "NO" votes which were resolved editorially. Resolution of comments resulted in the document being unanimously approved for publishing. The editor will update the SP-4425-B document from the TR-42.1 ballot resolution (TR-42/00-12-056) and will send the letters to the respondents. John Siemon made a motion to approve publishing SP-4425-B-2 as 568-B.1.

Discussion was held on publishing SP-4425 (568-B.1) inasmuch that 568-B.2 is referenced in the document, yet is not ready for publication. At first, a proposal was made to publish with wording within the document to direct readers to the SP version of B.2. This proposal was

defeated by not meeting a 2/3 majority (7 for; 5 against). Another proposal was made to publish with a cover letter explaining the immediate unavailability of the 56 8-B.2 standard and its pending publication. This proposal was also defeated. A motion was then made by Paul Kish to allow publishing SP-4425 (568-B.1) as a draft if allowed by TIA. Bob Jensen will follow-up with TIA to determine if this is acceptable.

**Plenary action:** The motion made by Paul Kish was approved.

- 2. The Building Automation Systems (BAS) committee ballot resolution (TR-42/00-12-057) was reviewed at the meeting. There were three "No" votes on the document. The document is in dire need of editing which is planned for January 18-19, 2000 in Orlando, FL. The document will not be re-balloted until after the March TR-42.1 meeting.
- 3. A Task Group has been formed to investigate First Mile/Last Mile cabling. This cabling will align with efforts within IEEE 802.3.

### 7b. TR-42.2, Residential Telecommunications Infrastructure 3/4 Bob Jensen

# 7c. TR-42.3, Commercial Building Telecommunications Pathways and Spaces 3/4 Bob Jensen

- 1. The underfloor duct and cellular floor distribution systems addendum (SP-4722-A) ballot was not reviewed in the Subcommittee due that there were not enough ballots returned. A new due date for ballot returns was issued for December 19, 2000. This ballot will be addressed at the March meeting.
- 2. The Task Group on multi-tenant buildings has progressed to the point where a project request and ANSI PINS form need to be approved for an addendum to ANSI/TIA/EIA-569-A. Bob Jensen made a motion to approve the Project Request (TR-42/00-12-047) and the ANSI PINS form (TR-42/00-12-048).

**Plenary action:** The motion was unanimously approved.

3. A review the multi-tenant addendum was accomplished at the Subcommittee meeting. Technical changes were made to the document and editorial modifications are yet to be complete. An editing committee is established and will meet on January 12 - 13, 2001 prior to the BICSI conference. Once the document is edited, the Subcommittee would like to allow the proposed addendum to be industry balloted. Bob Jensen made a motion to approve the industry ballot of the proposed multi-tenant addendum (TR-42/00-12-049).

**Plenary action:** The motion was unanimously approved.

4. Due to the inability to call quorum at the October interim meeting, TR-42.3 did not make any proposals to the NFPA Panel 16 on the Report to Comments of the National Electrical Code.

# 7d. TR-42.4, Customer-Owned Outside Plant Telecommunications Infrastructure 3/4 Donna Ballast

### 7e. TR-42.5, Telecommunications Infrastructure Terms 3/4 Ray Keden

1. The definitions group was active at this meeting in helping resolve ballot comments for multitenant pathways and spaces and building automation systems. Unfortunately, there was not enough time to complete all definitions brought to the Subcommittee.

# 7f. TR-42.6, Telecommunications Infrastructure and Equipment Administration 3/4 Mel Lesperance

Documents: (TR-42/00-12-050)

 The 606-A draft standard is nearing completion. Conference calls are scheduled for December 13<sup>th</sup> and 20<sup>th</sup> and January 3<sup>rd</sup> and 10<sup>th</sup> to complete editing of the document. After the editing process, the Subcommittee would like to issue a committee ballot on the document. Mel Lesperance made a motion to approve the committee ballot of the proposed administration standard (TR-42/00-12-050).

**Plenary action:** The motion was unanimously approved.

### 7g. TR-42.7, Telecommunications Copper Cabling Systems 3/4 Masood Shariff

Documents: TR-42/00-12-053 TR-42/00-08-054a TR-42/00-12-054b TR-42/00-12-055

1. Thirteen "No" votes were received on SP-4426-D, the proposed draft standard of 568-B.2. Five "No" votes remained after going through ballot resolution of 355 comments (123 technical and 232 editorial). The Subcommittee agreed to issuing a default ballot from the resolved of editorial and technical comments (TR-42/00-12-054a; and TR-42/00-12-054b respectively). A couple of items for the default ballot are being referred to Task Groups for comment that will be included in the next ballot. Letters will be sent to those that responded to the ballot confirming the resolution of comments. Masood Shariff made a motion requesting SP-4426-D (TR-42/00-21-053) be forwarded for default ballot (SP-4426-D-1) after editing the document.

**Plenary action:** The motion was unanimously approved.

- 2. The category 6 committee ballot (PN-3727) was reviewed at the meeting, however resolution to comments could not be finished due to time constraints (TR-42/00-12-059). Further work on resolving comments is planned to be completed at an interim meeting.
- 3. An interim meeting was requested by the Subcommittee to continue work on the category 6 ballot resolution. The dates of the meeting are set for January 24-25, 2001 in Phoenix, AZ. Masood Shariff made a motion to approve an interim meeting of TR-42.7. Masood will issue a meeting notice (TR-42/00-12-058) to TIA within the 30-day notification requirement.

**Plenary action:** The motion was unanimously approved.

4. A letter was reviewed by the Subcommittee to send to IEEE 802.3 and the ATM Forum (TR-42/00-12-055). The purpose of this letter is to solicit confirmation that allowing a return loss failure at frequencies where the measured insertion loss is less than 3 dB will not conflict with application requirements. Masood Shariff made a motion requesting the liaison letter be sent to the IEEE 802.3 and the ATM Forum.

**Plenary action:** The motion was unanimously approved.

### 7h. TR-42.8, Telecommunications Optical Fiber Cabling Systems 3/4 Herb Congdon

Documents: TR-42/00-12-051 TR-42/00-12-052

1. The *Additional Transmission Performance Specifications for 50/125 mm Optical Fiber Cables* addendum to 568-B.3 has been progressing within TR-42.8. The document is mature to the extent that the Subcommittee made some technical edits and are allowing an editorial committee to meet and finalize a document for ballot. Herb Congdon made a motion to approve the addendum for industry ballot (TR-42/00-12-051) after the editing process.

**Plenary action:** The motion was unanimously approved.

2. The *Guidelines for Maintaining Optical Fiber Polarity Through Reverse-Pair Positioning* TSB (to become TIA/EIA TSB125) explaining optical fiber polarity has been progressing within TR-42.8. The document is mature to the extent that the Subcommittee is allowing an editorial committee to meet and finalize a document for committee ballot. Herb Congdon made a motion to approve the proposed TSB for committee ballot (TR-42/00-12-052) after an editing session.

**Plenary action:** The motion was unanimously approved.

### 7i. TR-42.9, Industrial Telecommunications Infrastructure 3/4 Bill Sewell

1. Contributions were brought to the committee on three connectors that all have sealing capability for harsh industrial areas. Topologies will be defined by the group and conference calls will then be established to further the work.
