# 2.2 Liaison letters received: None received into TR-42. It was noted that we should be expecting a few in the near future.

# 2.3 Subcommittee reports

- 2.3.1 TR-42.1 Commercial Building Cabling: It was unanimously agreed to release the TIA-942 (Data Center Cabling) Standard for publication. An interim TR-42.1 meeting will be scheduled to conduct ballot comment resolution on the draft DC power addendum (to be Addendum 6 to 568-B.1).
- 2.3.2 TR-42.2 Residential Telecommunications Infrastructure: It was agreed (11 for, 1 opposed and 1 abstention) to create a coaxial cabling study group in TR-42, with John Pryma as Chair. A survey on RJ-11 plug interoperability with RJ-45 jacks will be conducted, likely through BICSI.
- 2.3.3 TR-42.3 Commercial Building Telecommunications Pathways and Spaces: No report.
- 2.3.4 TR-42.4 Customer-owned Outside Plant Telecommunications Infrastructure: No plenary action required.
- 2.3.5 TR-42.5 Telecommunications Infrastructure Terms and Symbols: No report.
- 2.3.6 TR-42.6 Telecommunications Infrastructure Administration: No report.
- 2.3.7 TR-42.7 Telecommunications Copper Cabling Systems: A liaison letter to TIA TR-41.9.2 was reviewed, edited and unanimously approved. A liaison letter to IEEE was reviewed, edited and unanimously approved with two abstentions. A liaison letter to ICEA was reviewed, edited and unanimously approved with two abstentions.
- 2.3.8 TR-42.8 Telecommunications Optical Fiber Cabling Systems: The draft optical fiber components revision (to be 568-C.3) will be edited and go out for committee ballot. The draft array connector polarity addendum (to be Addendum 7 to 568-B.1) will go out for third industry ballot.
- 2.3.9 TR-42.9 Industrial Telecommunications Infrastructure: The draft industrial standard (to be TIA-1005) will go out for committee ballot. A liaison letter to TIA FO-4 was reviewed, edited and unanimously approved.
- 2.4 WLAN Ad-hoc report: It was agreed (11 for, 1 opposed, 2 abstentions) to issue the draft wireless LAN cabling TSB for a "mock" ballot with input from all TR-42 subcommittees. A liaison letter to 802.11 was reviewed, edited and unanimously approved.

- 2.5 Review of Scopes (Engineering Committee and Subcommittees) Bob Jensen 2.5.1 TR-42.7: No proposal received.
- 2.6 Proposed changes to TR-42 Operational Guide: It was unanimously agreed to adopt the four changes to the operational guidelines (posted documents 04-122b, 04-125b, 04-126b and 04-127b).
- 2.7 Program of Work: The Chair again requested the TR-42 Program of Work be updated by all the subcommittee chairs (posted document 05-022).

#### 3.1 Other

- 3.1.1 Chairs conference calls to: 1) discuss/organize content of existing standards 2) investigate quorum: The Chair will schedule a teleconference of chairs, vice-chairs and editors to discuss and plan for the 568-C.0 standard, and to discuss issues related to formalizing the quorum policy.
- 3.1.2 Study Group for Coaxial Cabling: This study group was formed as noted in the TR-42.2 report.

All electronic files shall be provided in either Adobe Acrobat (\*.PDF); Microsoft Word (\*.DOC); Microsoft PowerPoint (\*.PPT); or in Microsoft Excel(\*.XLS). Compressed files shall be accessible using PKUNZIP or WINZIP (\*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting. All contributions shall be posted to the appropriate location on the TIA FTP site no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).

#### LATE CONTRIBUTIONS:

Contributions not posted as described in the timing above shall be classified as "late contributions." They may be considered in the meeting to which they are addressed provided that an appropriate motion receives 50% or greater of a vote.
