

1.8 Meeting report review and approval: The meeting report from Palm Springs (Feb. 2006) was approved unanimously.

2 Old Business

2.1 Liaison letters received: none

2.2 Subcommittee reports

- 2.2.1 TR-42.1 Commercial Building Cabling: During ballot resolution of SP-3-4425-AD6, it was agreed to cancel the project and have a task group finish the work and format the document as an annex to 568C.0. The committee reviewed the 568-C.0 and 568.C.1 drafts and agreed to send the documents out for mock ballot. A draft coaxial cable addendum for TIA-942 was reviewed a revised draft will be provided at the October meeting. Volunteers are requested in support of the Healthcare project.
- 2.2.2 TR-42.2 Residential Telecommunications Infrastructure: Efforts continue on the coaxial cabling addendum.
- 2.2.3 TR-42.3 Commercial Building Telecommunications Pathways and Spaces: A task group was created to study the conduit fill tables. The committee reviewed the pathways and spaces draft addendum to TIA-1005 and agreed to issue as a mock ballot.
- 2.2.4 TR-42.5 Telecommunications Infrastructure Terms and Symbols: The committee worked on definitions in support of 568-B.2 Add10, on "multi-fiber connectors" and on "ferrule".
- 2.2.5 TR-42.6 Telecommunications Infrastructure Administration: The committee worked on developing an approach for the administration of cabling with DTE power and for computer rooms.
- 2.2.6 TR-42.7 Telecommunications Copper Cabling Systems: Reviewed and resolved the comments to the TSB-155 ballot the next draft will go out for committee ballot. 60 pages of comments were received on the Addendum 10 ballot comment resolution will take place in an interim meeting. 568-B.2 Addendum 7 will go out for second default ballot. A liaison letter to IEEE on DTE power was approved unanimously for release. The plenary approved the submission of the project request and PIN forms for the 568-C.2 project.
- 2.2.7 TR-42.8 Telecommunications Optical Fiber Cabling Systems: Reviewed and resolved the 568-C.3 mock ballot comments. The new 568-C.3 draft will go out for committee ballot. A liaison letter to IEEE on unallocated margin was approved unanimously for release.
- 2.2.8 TR-42.9 Industrial Telecommunications Infrastructure: Reviewed contributions. Created a task group for fiber requirements. The next draft will be issued as a fourth committee ballot for resolution in an interim meeting.

2.3 Proposed changes to TR-42 Operational Guide:

Reviewed the modifications to the operational guidelines on consensus (-047). The definition of "Reject" was modified and approved unanimously in the "acceptable resolution" section. A motion to add a definition for a fifth acceptable resolution called "defer" was proposed by M. Shariff and seconded by E. Quinby. The motion failed (1 F, 14 Op and 1 Ab). H. Franc made a motion to add the modified document -047a to the TR-42 operation guidelines, which was seconded by Bob Jensen and approved unanimously.

NEW CONTRIBUTIONS:

Contributions shall use the approved templates and specific wording provided by TIA. Contributions affecting a document are to include a TIA cover sheet, proposed text to be included in the document, and the rationale/substantiation for the contribution. File templates are available on the TR42MAIN FTP site for download. All contributions shall be submitted to the electronic document coordinator (EDC). All electronic files shall be provided in either Adobe Acrobat (*.PDF); Microsoft Word (*.DOC); Microsoft PowerPoint (*.PPT); or in Microsoft Excel(*.XLS). Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting. All contributions shall be posted to the appropriate location on the TIA FTP site no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).

LATE CONTRIBUTIONS:

Contributions not posted as described in the timing above shall be classified as "late contributions." They may be considered in the meeting to which they are addressed provided that an appropriate motion receives 50% or greater of a vote.

All late contributions shall be provided to the EDC and to the committee members on a memory stick or CD-ROM along with sufficient paper copies for those members without a PC.

All late contributions shall be posted to the TIA FTP site no later than one week following the meeting in which they are considered. Notification of the posting shall be made to the group's email reflector list by the EDC.
