- 6. The meeting report of May 31 June 1, 2000 numbered TR45/00.08.30.02 was reviewed. A motion was made and passed with no objections to approve the meeting report.
- 7. In terms of correspondence, the following item was addressed:
 - **Document 30.03** This was information for consideration regarding the resignation of the TR45.6, TR45.7, and TR45 Chairs.
- 8. In terms of Liaisons, the following was reported:
 - a. FCC & IEEE Though not present, S.McConoughy provided Document 30.37 as the written report. The membership was directed to review the report. There were no comments or discussion.
 - b. CTIA K.Condello provided Document 30.11 as the written report. It was reported that the two items of perhaps the most interest to TR45 were activities related to Wireless Number Portability (WNP) and CALEA. Carriers were encouraged to review the July 13, 2000 WNPS Report to the NANC on LNP Phase II. With respect to CALEA and TR45 efforts, CTIA put forth three recommendations as listed in Document 30.11 such as TR45 suspend ANSI publication of the punch list standard. Document 30.11 was remanded to TR45.2 particularly as it relates to the CALEA recommendations.
 - c. T1S1, T1E1 & T1A1 T.Watts indicated that there was no report.
 - d. **T1P1** T.Watts indicated that there was no report.
 - e. TR-46 There was no TR-46 report. C.Wallace was not present.

f. ITU-T – C.Blum provided Document 30.17 as the written report. Highlights mentioned included: (1) The upcoming Rapporteur's meeting September 11-14, 2000 in Schaumburg, IL; (2) The proposed formation of a new IMT-2000 Study Group for the 2001-2004 study period; and (3) Discussion of a proposal for the ITU-T to serve as the harmonizer for All-IP target network requirements and specifications. Document 30.36 was provided for information for consideration.

The Committee recessed for a break at 10:30 AM and reconvened at 11:00 AM.

- g. **ITU-R** Though not present, M.Epstein provided Document 30.18 as the written report. It was noted that an ITU-R WP 8F meeting was held the week of August 21-25, 2000, in San Diego, CA. TR45 members that attended the 8F meeting were asked to provide comments. It was noted that the ITU-R issued Circular Letters that required action by the SDOs relative to IMT-2000. Courtesy copies of the Circular Letters were distributed for information. Document 30.22R1 was provided for information.
- h. **CITEL** B. Slocum, on behalf of G. Gardner, presented Document 30.19 as the written report. Attention was drawn to the table of resolutions, recommendations, and decisions made at the last PCC.I meeting as well as the seminar on IMT-2000 coordinated by the ITU held August 28-September 1, 2000 at the PCC.III meeting in Caracas, Venezuela.
- i. Public 800 Section
 - WCD, TSSC, TC It was noted that the next meetings of the TIA Wireless Communications Division (WCD) and Technical Committee (TC) would be held on September 7, 2000 in Rosemont, IL. Document 30.23 as provided for information. Regarding the new or re-activated TIA groups listed on the agenda, it was agreed that there was no need for further action to be taken by Committee TR45.
 - WCD Technical Regulatory Issues Committee (TRIC) B.Slocum provided Document 30.41 as the written report. It was noted that the proposed TRIC Scope and Charter would be submitted for approval at the next WCD meeting. Clarification was requested on the item addressing smart antennas as it relates to software defined radios. Regarding the EU R&TTE Directive, the TRIC indicated that no action was required by the TRIC and that TRIC members should provide input directly to ETSI. TR45 suggested that going forward any technical documents submitted by TR45.3 and TR45.5 into ETSI relative to the R&TTE Directive be copied to the TRIC.
- j. TIA B.Zidek-Conner provided a verbal report. It was reported that the TIA Engineering Manual was out for 30-day ballot to TIA Technical Committee (TC) member companies with ballot comments due to TIA by September 6, 2000. It was noted that some new forms (e.g. PINS) had been generated and distributed to the TR45 Subcommittee Chairs and were available on the TIA website. Planned for next year are training classes for standard document editors. TIA is seeking feedback from members on the preferred media for published standards documents such as paper or electronic (e.g., CD-ROM).
- k. 3GPP2 J.Kay, on behalf of S.Dennett, presented Document 30.20 as the written report. It was reported that the Mobile Wireless Internet Forum (MWIF) joined 3GPP2 as a Market Representation Partner (MRP). In addition, it was noted that the 3GPP2 TSG-S Terms of Reference were expanded to include OAM&P.
- 3GPP L.Nikkari provided a verbal report. It was reported that 3GPP at its meeting July 18-19, 2000 in Beijing, China, extended its scope to include GSM evolution and created the new TSG GERAN (GSM/EDGE Radio Access Network). The July 19, 2000 3GPP Press Release was provided FYI. It was suggested that TR45.3 coordination and collaboration with 3GPP GERAN be addressed, especially on technical issues to avoid potential disconnects. It was decided that at the next meeting of TR45 November 30-31, 2000 in Atlanta, GA an agenda item would be placed under old business on the relationship between TIA and 3GPP.

The Committee recessed for a break at 10:45 AM and reconvened at 11:00 AM.

- m. Other(s)
 - ATIS E.Hall provided Document 30.21 as the written report. An overview of ATIS was provided. It was noted that ATIS is not limited to wireline telecommunications. The new ATIS Incubator Solutions Program was described. TR45 was encouraged to take the program under consideration. It was reported that ATIS is sponsoring and providing Secretariat support for IFAST as of August 1, 2000. In addition, the upcoming CALEA Legal Summit, hosted by ATIS, would be held September 14, 2000, in Washington, D.C. Going forward, an ATIS Liaison Report to TR45 will be included on the TR45 agenda with E.Hall as Liaison.
- 9. The following Subcommittee and ad hoc group reports were provided:
 - a. TR45.1 Subcommittee J. Kay provided Document 30.04 as the written report. It was reported that TIA/EIA/IS-817, Location on Analog, was forwarded to TIA for publication. Addenda to that standard are being addressed and encouraged. It was noted that work on the 2.5mm jack for TDD/TTY standard was coming to conclusion. In addition, the cut-off for technical contributions to TIA/EIA-553-B was extended to February 2001. Correspondence from TR45.1 to TR45 relative to IMEI (Document 30.04A) indicated that the signaling changes necessary to support IMEI on the analog air interface would be significant. Document 30.24 was provided for information.
 - b. TR45.2 Subcommittee C. Blum provided Document 30.05 as the written report. Attention was drawn to the TR45.2 work on the ANSI ballot of ANS-41-E anticipated for December 2000. Regarding CDMA Packet Data Services, Phase 1 is scheduled for ballot in November 2000 and Phase 2 is scheduled for ballot in December 2000. Regarding IMEI, it was noted that TR45.2 continues to evaluate the technical support for IMEI. It was reported that a proposed mechanism to protect against rogue MS shells was agreed to in principle by TR45.2. As it relates to the recommendations for joint AKA control, Document 30.05 was remanded to TR45.3, TR45.5, TR45.AHAG, and 3GPP S3 for review and comments back to TR45 and TR45.2/AHAG with the expectation of reaching an overall consensus at the next TR45 meeting in November in Atlanta. The recommendation comments will be covered under old business relative to the relationship between TIA and 3GPP. In addition, the appointment of a representative to 3GPP S3 will be an agenda item at the November TR45 meeting. Documents 30.25 and 30.38 were provided for information.

The Committee recessed for lunch at 12:00 PM and reconvened at 1:30 PM.

- c. TR45.3 Subcommittee P. Nurse provided Document 30.06 as the written report. It was requested that all Subcommittees be prepared to share their year 2001 work plans at the next TR45 meeting in November. TR45.3 indicated that planning for the next revision of TIA/EIA-136 would occur at its next meeting in Asheville, NC. It was noted that a series of Revision B and Revision C documents were recommended for ANSI public review. In addition, it was reported that TR45.3 provided updates for the year 2000 RSPC revision to the "Recommendation ITU-R M.1457 Detailed Specification of the Radio Interfaces of IMT-2000."
- d. TR45.4 Subcommittee S. S. Jones provided Documents 30.07 as the written report. It was noted that the TFO TDMA Task Group would meet with TR45.3 at its next meeting in Asheville, NC. The TR45.4 relationships with MWIF and 3GPP2 relative to All-IP activities were discussed. It was reported that TR45.4 plans to designate a liaison to MWIF.
- e. **TR45.5 Subcommittee** F.O'Brien, on behalf of J. Alphonse, presented Document 30.08 as the written report. It was reported that review of the IMEI recommendation was still in process. It was reported that five standards were published since the last TR45 meeting with many standards still in progress. In addition, TR45.5 indicated that it supports the ITU-R WP 8F efforts to maintain and update RSPC on an annual basis. TR45.5 plans to provide updated materials to the ITU-R M.1457 document for the year 2000 revision by the October 13, 2000 deadline.

- f. TR45.6 Subcommittee E. Campbell, provided Document 30.09 as the written report. It was reported that Mark Munson resigned from the position of TR45.6 Chair. E.Campbell, TR45.6 Vice-Chair, has assumed leadership pending the appointment on a new TR45.6 Chair. It was noted that TR45.6 is pursuing ANSI ballot for IS-732 (CDPD). Work continues on the Wireless IP Network Standards and the Wireless IP Architecture Based on IETF Protocols. Concern was raised as to whether these standard documents were technology specific and if so it was suggested that the names reflect the technology to avoid internal and external confusion.
- g. **TR45.7 Subcommittee** J.Marinho, on behalf of F.Stradler, presented Document 30.10 as the written report. It was noted that Thad Kobylarz resigned as TR45.7 Chair. As TR45.7 Vice-Chair, F.Stadler was charged with facilitating the closure of the open TR45.7 work items such as PN-4108. Regarding the CTIA SRD on Network Management, it was stated that CTIA looked to the carriers for guidance and none was forthcoming. Thus, CTIA was not in the position to suggest that work on the SRD on Network go forward. At was agreed that at the next meeting of TR45 in November in Atlanta that the future direction of TR45.7 would be addressed. The current plan of action is to narrow the scope of TR45.7 to finishing up its work on PN-4108. Documents 30.26 and 30.27 were provided as information for consideration.
- h. Ad Hoc Authentication Group (AHAG) C. Carroll provided Document 30.14 as the written report. Documents 30.05 and 30.35 were referenced for information. The recommendations for joint AKA control in Document 03.14 were discussed. It was noted that plans are to share these recommendations for review and comments from 3GPP S3 at the next joint meeting September 12, 2000 in Washington, DC. The AHAG and TR45.2 will work together to ensure that a consistent set of recommendations are provided to TR45.5 and TR45.3 for review. As it relates to proposed meetings every six months, it was noted that the language in Document 30.14 reflects the correct text. Regarding identifying an AHAG representative to the 3GPP S3, the AHAG was directed to identify someone at the next TR45 meeting in November in Atlanta as well as recommend a structure for the relationship between TR45 and 3GPP S3. During a conference call scheduled for September 6, plans are to correct the Section numbers in the Liaison Statement from 3GPP SA-3 in Document 30.35. There was no objection to the request from TR45.5 that the AHAG look at AES (Advanced Encryption System) and come back with recommendations.
- i. AHG on NRM, Acronyms & Definitions, Guide to Standards (NAG) B. Slocum provided Document 30.15 as the written report. Updates to TSB100 Revision A were completed. The latest version of TSB100-A (Document 30.15A) was remand to all Subcommittees for review and comments back to the TR45.NAG by the end of October 2000. Plans are for submission to TR45 for approval for ballot of TSB-100 Revision A at the November TR-45 meeting in Atlanta, GA.
- j. **AHG on Electronic Media Documentation** Documents 30.28 and 30.29 were provided by J.Brownley for information.
- k. AHG on International Standards Development (ISD) B.Kidwell provided Document 30.12 as the written report. An updated version of the TR45 year 2000 work plan based on the Subcommittee reports to TR45 provided at this meeting will be made available on the TIA TR45MAIN ftpsite. All Subcommittees were once again asked to provide timely updates directly to B.Kidwell. TR45.6 and TR45.2 to work with B.Kidwell to ensure that the names of the standards reflect the appropriate technologies.
 - **3G Standards Development Program Report** Covered under agenda item 9k above.

- 1. **AHG on UIM/ESN -** T.Watts provided Document 30.16 as the written report. Regarding the IMEI recommendations, correspondence was received by the AHG on UIM/ESN from all Subcommittees. AHG still investigating the use of IMEI (International Mobile Equipment Identity). Regarding PLMN (Public Land Mobile Network) selection, it was noted that the ETSI Smart Card Platform (SCP) is seeking input from TR45.3 and TR45.5 and the SCP plans to correspondence directly to TR45.3 and TR45.5. TR45 gave the AHG the latitude to communicate directly with 3GPP and 3GPP2 provided that the AHG, at the next TR45 meeting in November in Atlanta, recommend a structure for on-going dialogue with 3GPP. Documents 30.33, 30.34, and 30.40 were provided as information for consideration.
 - ESN Administration J.Willse provided Document 30.13 as the written report. Document 30.16A provided the ESN Guidelines Version 1.7 that reflects the updates to incorporate the 14 bit ESN Manufacture Codes distribution. At the next TR45 meeting a revised copy of the ESN Guidelines will be provided to incorporate the items discussed at this meeting such as clarification to the length of code in Section 5.4. Also at the next TR45 meeting, ESN exhaust will be added as an agenda item. Contributions were encouraged on ESN exhaust considerations.

The Committee recessed for a break at 3:05 PM and reconvened at 3:30 PM.

- 10. Regarding the continuation of old business, the following items were addressed:
 - a. **Recommendations for working with 3GPP S3 re: AKA** The proposed guidelines for TR45 to work with 3GPP S3 on AKA-based ESA were previously discussed under agenda items 9b and 9h. Documents 30.05, 30.14 and 30.35 were referenced for information. To re-iterate the plan of action relative to the recommendations for joint AKA control, feedback and consensus to be sought on the guidelines and the broad topic of the relationship between TR45 and 3GPP will be on the agenda for the next TR45 meeting in November in Atlanta.
 - b. Final CALEA JEM Report Documents 30.39 was provided and contained the final CALEA Packet Surveillance JEM report as submitted to TIA. TIA is expected to use this report to create a white paper for submission to the FCC by September 30, 2000. The transmittal letter that accompanies the report was included in Document 30.39.
 - c. **European Harmonised Standards in Support of the R&TTE Directive** Documents 30.31 and 30.32 were provided for information for consideration. Documents 30.31 and 30.32 were remanded to Subcommittees TR45.3 and TR45.5 to review and take actions as appropriate.
- 11. Relative to new business, the following items were addressed:
 - a. **Determine Candidates for Chair re: TR45.6, TR45.7, TR45 -** Document 30.03 was referenced. TR45.6 to solicit candidates for the new TR45.6 Chair.
