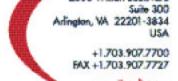

- 6. The meeting report of September 4, 2002 numbered TR45/02.12.04.02 was reviewed. A motion was made and passed with no objections to approve the meeting report.
- 7. In terms of correspondence, the following item was addressed:

- **Document .03** This correspondence was provided for information.
- 8. The following Subcommittee and Ad-Hoc Group reports were provided:
 - a. **TR45.1 Subcommittee** On behalf of J. Kay, C.Ishman presented Document .04 as the written report. It was noted that the ballot of TSB-121 would close on December 17, 2002.
 - b. **TR45.2 Subcommittee** C.Ishman provided Document .05 as the written report.
 - It was noted that TR45.2 plans to hold two meetings independent of 3GPP2 TSG-N in 2003. TR45.2 recommended that TR45 consider the possible impact to its Subcommittee structure following the TSG-N and TSG-P realignment planned for January 2003. It was noted that discussions of the restructure of TR45 maybe pre-mature at the current time. At the TR45 meetings in March and June of 2003 plans are to re-address the impact of the TSG realignment. It was noted that the procedures for joint work between 3GPP2 and TIA were being addressed by TIA.
 - It was reported that there maybe possible wireless call delivery misrouting due to Number Portability/Pooling. It was noted that this had been brought to the attention of TIA and that no further action was required of TR45. It was reported that TIA had issued an alert to the industry and was investigating the possibility of balloting a TSB.
 - TR45.2 requested that a certificate of appreciation be awarded to Greg Schumacher for his many
 years of dedication and commitment to supporting the work of TR45.2. TR45.2 was directed to
 contact TIA to have a certificate of appreciation awarded to Greg Schumacher.
 - Document .37 was provided for TR45 action as appropriate relative to the TR45 Network Reference Model (NRM) in TSB-100-A. Regarding the ITU-T SSG correspondence in Document .37, a conference call of the TR45 NRM Ad-Hoc Group (NAG) would be held in early 2003 to recommend a TR45 response to the ITU-T SSG and to discuss potential TR45 actions relative to the 3GPP2 NAM (Network Architecture Model). TR45 to ask T.Jacobson to convene the NAG conference call. Regarding the NRM, Documents .05 and .37 were remanded to the NAG, TR45.1, TR45.3, and TR45.5. (It was noted that TR45.4 and TR45.6 were cc'd on the original correspondence in Document .37.) TR45 to contact TSG-S for a copy of the latest version of the 3GPP2 NAM for distribution to TR45 prior to the AHG conference call. TR45 plans to respond to the ITU-T to acknowledge the SSG request and to inform the SSG of the TR45 plan to respond further in early 2003 based on NAG input.

The Committee recessed for a break at 9:40 AM and reconvened at 10:00 AM.

- c. TR45.3 Subcommittee P.Nurse provided Document .06 as the written report. Regarding the Mobile Equipment Identifier (MEID), it was noted that TR45.5 had not made a decision, as yet, relative to deriving a pseudo-ESN from a MEID. TR45.5 was directed to confirm a method for deriving a pseudo-ESN from a MEID at the next TR45 meeting in March 2003. Also, it was suggested that TR45.2 endorse the derivation method supported by TR45.3 and the AHAG. Document .31 was provided for information.
- d. **TR45.4 Subcommittee** D.Baldwin provided Document .07 as the written report. It was noted that TR45.4 decided to develop the HRPD Alternate Architecture (Phase 2) as a separate Standards from the original HRPD (Phase 1) Standard.
- d. **TR45.5 Subcommittee** J.Alphonse provided Document .08 as the written report that included several attachments (a-d). It was reported that quite a few documents were published or out for ballot or in the process of ballot resolution. It was noted that TR45.5 approved a final draft of its 2003 Work Plan for acceptance at its December 2002 closing plenary. Document .31 was provided for information.
- e. **TR45.6 Subcommittee** On behalf of E.Campbell, C.Blum presented Document .09 as the written report.

- f. Ad Hoc Authentication Group (AHAG) On behalf of C.Carroll, F.Quick presented Document .10 as the written report. TR45 concurred with the AHAG plans to request a PN for TR45 to ballot the next revision of the Enhanced Cryptographic Algorithms. Plans are to have the ballot text approved by the AHAG before the next TR45 meeting in March 2003. In addition, it was noted that the AHAG plans to hold conference call meetings in 2003 with the possible exception of a July 2003 meeting that would be face-to-face and co-located with the joint 3GPP2 TSG-S WG4 and 3GPP SA3 meeting in San Francisco.
- g. AHG on Electronic Media Documentation There was no report.
- h. AHG on UIM/ESN On behalf of C.Carroll, G.Pelligrino presented Document .11 as the written report. The ESN Manufacturer's Code Assignment Guidelines and Procedures Version 1.8, contained in Document .11a, were approved as amended. Regarding four ESN codes deemed unsuitable for ESN reuse, it was agreed that the recommended language would be incorporated into the ESN Administrator's Report to set aside the identified codes. Furthermore, the companies originally assigned the four identified codes would be contacted by TIA. TIA to distribute for review in early 2003 the revised text regarding ESN exhaust scenarios prior to inclusion in the ESN Administrator's Report. The AHG on UIM/ESN plans to work with 3GPP2 TSG-S on developing MEID Guidelines for consideration at the Global Number Administration meeting in London in February 2003. In addition, the AHG on UIM/ESN Chair plans to contact TSG-S to indicate the AHG's willingness to work on MEID Guidelines. Documents .25 and .28R1 were provided for information for consideration.
 - **ESN Administration** B.Belt provided Document .12 as the written report. It was reported that the projected ESN exhaust timeframe is 3Q05. It was noted that TIA had contacted Hop-On Wireless regarding the disposition of ESNs associated with returned disposable mobiles.
- AHG on LAES T.Brooks provided Document .13 as the written report. Ballot resolution of ANS J-STD-025-A is targeted for the January 2002 LAES meeting. LAES to forward TIA correspondence related to other SDO documents referenced in PN-4465-RV1 (J-STD-025-B). Documents .14 and .26R1 were provided for information.
- j. **TR45 Standards Development Program Report** S.Jones provided Document .39 as an updated version of the TR45 Program Management Report. Document .39 was remanded to all Subcommittees for review and input directly to S.Jones, as appropriate.

The Committee recessed for lunch at 12:05 PM and reconvened at 1:30 PM.

- 9. Regarding the continuation of old business, the following items were addressed:
 - a. **Proposed FCC Rules Changes for ESN** Documents TR45/02.09.04.37 and TR45/02.06.05.38 were provided for information. In addition, the latest version of the FCC Rule Making on the streamlining of Part 22 that eliminates analog service requirements after a five-year transition period and removes the manufacturing requirements governing electronic serial numbers (ESNs) in cellular telephones was provided for information. TIA to inform TR45 when the final version has been placed on the Federal registry. Any further action of TR45 would be based on the final version.
 - b. **MEID Administration Role** Document TR45/02.06.05.17 was referenced. It was agreed that the agenda item would be carried forwarded until the MEID Guidelines including the Administration Role are made available.
 - c. **Ballot of TSB-39-A** The ballot version of TSB-39-A, related to extended protocol facilities, was referenced in Document TR45/02.09.04.21R1. TR45 to submit an application for a 30-day ballot of TSB-39-A.

- d. Draft ITU-T Recommandation Q.1742.1 Documents TR45/02.09.04.24 and TR45/02.06.05.37 were provided for information. The TR45.6 and the AHAG comments on the draft ITU-T Recommandation Q.1742.1 were forward to the ITU-T SSG. Documents .34 and .34a were remanded to TR45.2, TR45.4, TR45.6, AHAG, and NAG to review and provide comments at the next TR45 meeting in March 2003. TR45 to consolidate the comments and forward to the ITU-T SSG.
- e. **TR45 GTSC/GRSC (formerly GSC/RAST) Meeting Preparation** It was noted that TR45 plans to participate and most likely present at the next GRSC meeting on Ottawa in April/May 2003.
- f. **TIA Emergency Network Security-related Work Activities** Documents TR45/02.09.04.35 and TR45/02.12.04.29 were provided for information.
- 10. Relative to new business, the following items were addressed:
 - a. **TR45 Leadership Elections in 2003** It was reported that Cheryl Blum's two-year term as Committee TR45 Chair concludes at the end of year 2003. Pursuant to the TIA Engineering Manual there will an election for TR45 Chair at the next TR45 meeting on March 5, 2003. Nominations and employer support letters should be sent to D.Bart, TIA with copyto B.Zidek-Connor (TIA) and J.Brownley (TR45 Secretary). TR45.6 was directed to hold an election for TR45.6 Chair in early 2003.
 - b. **Transfer of documents from TR46 to TR45** Document .35 was provided for information. It was noted that TR46 plans to rescind many of the listed documents. A revised document list to be provided at the next TR45 meeting in March 2003 before any action need be considered by TR45.
 - c. ATIS Security Summit February 4-5, 2003 Document .32 was provided for information.
 - d. **Number Pooling** Document .15 was provided for information for consideration. Addressed previously under agenda item 8b, it was re-iterated that TIA to issue an alert to the Committee TR45 membership as well as all other TR45 Subcommittees members. It was noted that the alert had gone to the FCC, ATIS, CTIA, USTA, and select industry publications. Furthermore, TIA to give consideration to notifying purchasers of the TIA/EIA/IS-765-A Standard.
 - e. **SID Administration** Document .36 was provided for information. It was noted that there were TIA plans to work with the industry to draft SID Administration Guidelines. TR45 to formally respond to the TIA request for assistance with the offer of TSB29 and the ESN Guidelines as references for input to the TIA initiative to develop SID Administration Guidelines and to indicate regrets that limited time and resources precludes further action from TR45.
- 11. In terms of Liaisons, the following was reported:
 - a. **CTIA** There was no report.
 - b. **T1P1** There was no report. Nevertheless, ATIS agreed to provide T1P1 information of interest to TR45 in the ATIS Liaison Report going forward. It was decided to drop the T1P1 Liaison from the TR45 agenda.
 - c. ITU-T On behalf of D. Thompson, C. Blum provided Document .16 as the written report.
 - d. **ITU-R** There was no report.
 - e. **CITEL, CCT** On behalf of G.Gardner, C.Blum presented the written report in Document .18 for information.
 - f. **Wireless Communications Division (WCD)** B.Belt provided Document .22 as the written report. It was noted that TIA filed comments on the Hatfield Report related to wireless enhanced 911 services.

Key upcoming filings mentioned were related to (1) the FCC's Spectrum Policy Task Force and (2) the proposed licensing and service rules in the 5.9 GHz band for dedicated short-range communications in the ITS radio service. It was re-iterated that the TIA Wireless Communications Division (WCD) meeting was scheduled for Thu Dec 5 at the Biltmore Hotel in Los Angeles, CA.

g. **Technical Regulatory Issues Committee (TRIC)** – B.Belt provided Document .23 as the written report. It was reported that K.Goshia of Ericsson was selected as the new TRIC Chair. Selection of a new SAR Ad-Hoc Chair to be made at the next TRIC meeting in January 2003 in Columbia, MD.

The Committee recessed for a break at 2:45 PM and reconvened at 3:15 PM.

- h. **TIA** S.Hoyler provided several documents.
 - Document .17, Advisory Note 1 issued November 15, 2002 relative to contribution cover language, was provided for information for consideration. TR45 to share with the TIA Technical Committee the concerns raised relative to Advisory Note 1. Until clarification is provided by TIA, all were encouraged continue to use the existing language on contribution covers.
 - Document .20, a PowerPoint overview presentation regarding the TIA IPR policy, was provided for information.
 - Document .40, notes from the TIA WLAN teleconference meeting, was provided for information.
 - Document .41, the participants on the TIA WLAN teleconference meeting, was provided for information.
 - Document .42, related to the TIA IPR policy, was provided for information.
 - Document .43 was provided for information regarding a TIA IPR policy "catch all permission" phrase to be included on all TIA meeting notices and agendas pending TIA Technical Committee action.
 - Document .44, Annex G on contribution template language, was provided for information. It was noted that ballot of the Annex G language was pending TIA Technical Committee action.

It was noted that T.Jacobson of Lucent Technology, an active participant in TR45.2, received the ANSI Meritorious Award. Documents .27 and .30 were provided for information.

- i. **3GPP2** Document .19 was provided as the written report by S.Dennett. It was reported that 3GPP2 approved the merger of TSG-N and TSG-P that would be finalized during 1Q03. It was noted that the 3GPP2 SC Chair and all 3GPP2 TSG Chair leadership terms end December 2002. Transition to new leadership is scheduled for the January 2003 3GPP2 TSG, SC, and OP meetings. Document .38 was provided for information for consideration.
- j. **3GPP** P.Musgrove provided a brief verbal report. Among the items reported, it was noted that the functional content of Release 5 was confirmed and the Future Evolution Workshop agreed on its Terms of Reference. In addition, it was noted that 3GPP would continue to determine work items that are candidates for moving to OMA (e.g., Digital Rights Management (DRM)).
- k. **ATIS** E.Hall provided Document .21 as the written report. Materials on the ATIS Security Summit were provided for information.
- 12. In review of assignments, the assignments were incorporated in the meeting report above.
- 13. Review Meeting Schedules
 - a. **TR45 2003 Schedule** Document .33 was provided for information. It was noted that the Meeting Planner had negotiated complimentary shuttle service between the Ft Lauderdale airport and the hotel for the March 2003 TR45 meeting.
 - b. **Subcommittees and AHG 2003 Schedules** Documents .04, .05, .06, .07, .08, and .09 were provided for information.

14. Open Discussion

Attention was drawn to Document 11aR2 that incorporated revisions to Sections 10.4.3 and 5.13 and a global text change from "expanded" to "replacement". It was agreed to accept Document .11aR2 as amended and to forward to the TIA ESN Administrator to handled, as appropriate.

15. Having concluded the meeting's deliberations, a motion was made to adjourn. The meeting was conducted in accordance with the TIA Engineering Manual and was adjourned at approximately 5:00 PM local time December 4, 2002.
