- 6. The meeting reports of August 15, 2003 and September 3, 2003 numbered TR45/03.12.03.02 and .02a, respectively, were reviewed. A motion was made and passed with no objections to approve the meeting reports as written.
- 7. In terms of correspondence, the following item was addressed:
 - **Document .03R2** This correspondence was provided for information.
- 8. The following Subcommittee and Ad-Hoc Group reports were provided:
 - a. TR-45.1 Subcommittee J.Kay was not present. Nevertheless, Document .04 was provided as the written report. It was noted that the two-year term of J.Kay as Chair of TR-45.1 ended as of November 2003. TR-45 acknowledged and recognized the outstanding contributions of J.Kay to TIA and Committee TR-45. It was agreed that TIA would provide a plaque of recognition to J.Kay. It was reported that the election of a new TR-45.1 Chair was scheduled for the TR-45.1 meeting in November 2003. However, there were no candidates. It was decided that TR-45.1 would be rendered dormant at this time and its status would be re-addressed at the next TR-45 meeting in March 2004. The outstanding TR-45.1 work item related to SP-3-4658 (i.e., to upgrade IS-89 to ANS status) would be balloted by TR-45 once a soft copy was located. In addition, TR-45 seeks to locate copies of any other TR-45.1 legacy documents.

b. TR-45.2 Subcommittee – C.Ishman provided Document .05 as the written report. Document .05a provided TR-45.2 comments on the TIA compendium of emergency communications and communications network security-related work activities. Regarding Document .05a, it was noted that updated document titles were needed to reflect the correct usage of the ANSI designation. Document .05b, TR45.2 correspondence to T1P1 related to comments on J-STD-038-B, was provided for information. Document .05c, announcing the resignation of C.Ishman as Chair of TR-45.2 and TR-45.NAG, was provided for information. Regarding the resignation, Document .03R2 was also referenced.

TR-45 acknowledged and expressed thanks and appreciation to C.Ishman for his years of work and commitment to TIA and TR-45. It was agreed that TIA would provide a plaque of certification to C.Ishman. TR-45 directed TR-45.2 to announce the upcoming Chair election and solicit nominations. There were no objections to put forward a TR-45 recommendation to the TIA Technical Committee at its 17 December 2003 meeting to abolish the odd/even-year election requirement as reflected in Section 3.1.1 of the TIA Engineering Manual.

Regarding Document .27, S.Hoyler agreed to follow-up with D.Bart on the disposition of the proposed TR-45.2 correspondence to the FCC from TIA regarding SID Administration. It was noted that TR-45 supported the proposed TR-45.2 correspondence. E.Hall, on behalf of ATIS, agreed to investigate the status of the anticipated ATIS OBF response to the previous TR-45 correspondence on JIP.

- c. **TR-45.3 Subcommittee** P.Musgrove provided Document .06 as the written report. Document naming convention was discussed as it relates to ANS/TIA/EIA. TIA took an action to generate explanatory text to clarify the correct usage of the terms ANS/TIA/EIA in document titles (i.e., usage going forward) before the next meeting of TR-45. Document .29 was provided for information.
- d. TR-45.4 Subcommittee D.Baldwin provided Document .07 as the written report. TR-45.4 to call for Chair nominations at its December 2003 meeting and conduct the election at its January 2004 meeting. Regarding the TR-45.4 Vice-Chair election, plans are to call for nominations at the TR-45.4 meeting in January 2004 and to conduct the election at the subsequent TR-45.4 meeting (i.e., either February or March 2004.) TR-45.4 reported that MEID standards are targeted the next revision of its standard.
- e. **TR-45.5 Subcommittee** J.Alphonse provided Document .08 as the written report. Discussion of the TIA Addenda policy, particularly as it relates to TR-45.5, was deferred until agenda item 10c.
- f. TR-45.6 Subcommittee P.Yegani provided Document .09 as the written report. Caution was encouraged relative to the language used in informative TSB documents (i.e., no shalls, musts, etc.) to avoid rejection by legal counsel. There was lengthy discussion on TR-45.LAES.AHG working the e-interface as it relates to Release C of J-STD-025. It was noted that TR-45.6 during its meeting in December 2003 would address working the e-interface with the TR-45.LAES.AHG. TR-45 re-iterated its position that all experts from TR-45.2 and TR-45.6 should work with TR-45.LAES to avoid the need for multiple liaisons and reap the benefits from the synergy of working together. TR-45 highly recommends that this work be done collectively and strongly encourages co-located meetings with TR-45.LAES to facilitate expediting this work by having the TR-45.6 and TR-45.2 experts contribute to the work of TR-45 LAES.AHG. TR-45 left it to the affected group Chairs to negotiate the meeting logistics.

The Committee recessed for a break at 10:35 AM and reconvened at 11:05 AM.

g. Ad Hoc Authentication Group (AHAG) – F.Quick, as Acting Chair, provided Document .10 as the written report. It was reported the C.Carroll has taken a new position and is no longer able to serve as Chair. TR-45 expressed appreciation to C.Carroll for the critical Security work that he has done over the years. TIA agreed to provide a plaque of certification to C.Carroll. With no objections, F.Quick was appointed the new AHAG Chair. Correspondence relative to the resignation of C.Carroll and the nomination of F.Quick were provided in Document .03R2. Document .41 was provided for information.

- h. AHG on Electronic Media Documentation (AHEM) P.Nurse provided Document .15R1 as the written report. There were no objections to accept the scope and charter of the AHEM as provided in Document .15R1. TR-45 plans to share the AHEM Scope and Charter with the TIA Technical Committee and suggest that the TIA Technical Committee consider a horizontal Ad-Hoc Group on Electronic Media Documentation patterned after the TR-45.AHEM.
- j. AHG on LAES T.Brooks provided Document .13 with attachments 13a through 13d as the written report. The results of the ballot resolution of PN-4465-RV1 were noted. It was also noted that a default ballot of PN-4465-RV1 was required and that the default ballot comments would be addressed during the TR-45.LAES meeting in December 2003. It was noted that it was still the intent of the TR-45.LAES to have J-STD–025-B ready for publication by the end of 2003. TR-45 scheduled an interim conference call meeting for Thursday 18 December 2003 at 11:00 AM Eastern Time to seek approval of PN-4465-RV1 for publication as J-STD–025-B and to recommend an ANS ballot.

TIA agreed to investigate whether there was a requirement to generate meeting reports of joint meetings that involve TR-45 Ad-Hoc Groups. Based on the TIA Engineering Manual, it is the understanding of TR-45, that meeting reports are not required of TR-45 Ad-Hoc Groups and if a meeting report is generated by a TR-45 Ad-Hoc Group, TIA legal review is optional.

It was noted that the TR-45.LAES is considering a co-located meeting in the U.S. for information sharing with 3GPP SA3 and T1P1 in October 2004. It was noted that the chair of the 3GPP SA3 LI group indicated that there was interest within that group for information sharing with TR-45 LAES. TR-45.LAES was encouraged to explore holding a similar co-located information sharing meeting with 3GPP2. G.Flynn was asked to contact the 3GPP2 SC Chair relative to the possibility of such a co-located information sharing meeting.

Documents .16, .25, .26, .43, and .47 were provided for information.

The Committee recessed at 05:30 PM Local Time on Wednesday December 3, 2003 and re-convene at 08:15 AM Local Time on Thursday December 4, 2003.

i. AHG on UIM/ESN – G.Pellegrino, as Acting Chair, provided Document .11 as the written report. It was re-stated that TR-45 endorsed TIA as the MEID Global Hexadecimal Administrator (GHA). The UIM/ESN AHG proposed updates to the GHA Assignment Guidelines and Procedures, as reflected in Document .11c, were reviewed and approved by TR-45 for the UIM/ESN AHG to forward to 3GPP2 TSG-S. TIA to provide a list, to the UIM/ESN AHG and copyto TR-45, of manufacturers assigned ESN codes that could not be reached via previous mailings. Document .11a, correspondence to the industry concerning migration information related to ESN exhaust, was reviewed and approved as amended by TR-45 for UIM/ESN AHG distribution by Monday 8 December 2003. Document .11b, the ESN Assignment Guidance Plan, was provided for information.

Qualcomm indicated that the MEID presentation in Document .44 was provided for industry use and distribution. TR-45 suggested that the UIM/ESN AHG work with TIA to explore conducting an industry seminar on the migration to MEID that includes frequently asked questions and answers. The Subcommittees and AHGs were polled relative to the status of MEID standards development. The Subcommittees and AHGs were directed to provide detailed MEID standards development status at the next TR-45 meeting in March 2004.

Many expressed sincere appreciation and thanks to the UIM/ESN AHG for its efforts, in particular C.Carroll and G.Pellegrino. Per Document .03R2, it was noted that C.Carroll resigned as the Chair of the UIM/ESN AHG. G.Pellegrino was appointed the new Chair of the UIM/ESN AHG with no objections. Document .40 was provided for information.

- **ESN Administration** – On behalf of B.Belt, J.Derr presented Document .12 as the written report. It was reported that the projected exhaust date of the 8-bit ESN manufacturer's codes remains 1Q05.

The Committee recessed for a break at 09:35 AM and reconvened at 10:00 AM.

k. TR-45 Network Architecture Group (NAG) – C.Ishman, provided Document .14 as the written report as well as materials related to the ballot of PN-3-01222-1 (TSB-151), the TR-45 Network Reference Model (NRM). TR-45 approved TSB-151 for publication as amended, without objection. The NAG was rendered dormant until such time as there is the need for a new revision to the TR-45.NRM. All were encouraged to raise any NAG related issues to TR-45.

C.Ishman resigned as Chair of the NAG per Document .03R2. TR-45 expressed thanks and appreciation to C.Ishman. The TR-45 Chair called for volunteers to Chair the NAG and as Editor of the NRM document. Regarding potentially missing interfaces as raised by TR-45.6, it was suggested that the issue be directed to either TSG-X or the NAG via TR-45.

- TR-45 Standards Development Program Report J.Alphonse volunteered to serve as the TR-45 Program Manger. It was noted that the Program Manager would review the Subcommittee work plans and development a new formatted TR-45 program report for the next TR-45 meeting in March 2004.
- 9. Regarding the continuation of old business, the following items were addressed:

a. Confirmation of OID Administration Guidelines Editor

Document .39 was provided for information. TR-45 confirmed G.Pellegrino as Editor of the OID Administration Guidelines. The Editor noted proposed changes to the Guidelines as a result of the recent ballot of J-STD-025-B. In addition, it was noted that updates were needed as a result of review by TIA.. The OID Administration Guidelines Editor to request a TIA project number to track revisions to the document

b. Ballot Comment Resolution of TSB-68 and TSB-84-A

Document .38 was provided for information. It was reported that there were no ballot comments. The withdrawal of TSB-68 and TSB-84-A were accepted without objection.

c. ITU-T SSG Draft Recommendation Q.SNFB

Document TR45/03.09.03.25 was provided for information. The Subcommittees that reviewed the Draft Recommendation Q.SNFB had no comments. It was noted that TR-45.6 plans to review Q.SNFB at its December 2003 meeting and provide comments directly to the SSG with a copyto TR-45.

d. ITU-T SSG Request to SDOs for Q.1742.3 Publication Status

Documents .36 and TR45/03.09.03.26 were provided for information. It was reported that comments from TR-45.2 and the AHAG were provided to the ITU-T SSG. It was noted that the need for cross-references would be ongoing. All of the Subcommittees were encouraged to provide cross-reference publication information as it relates to the ITU-T SSG Request to SDOs for Q.1742.3 Publication Status on an ongoing basis. P.Nurse agreed to propose a 3GGP2 / TIA cross numbering scheme at the next meeting of TR-45 in March 2004 based on a review of the 3GPP / ETSI process.

e. TR-45 Actions re: JIP for Wireless Number Portability

Several pieces of correspondence related to the JIP for wireless number portability in Documents .31, .32, TR45/03.09.03.31, and TR45/03.09.03.05a were provided for information only.

f. TR-45 Actions re: ANSI C.63

Document TR45/03.09.03.21b was provided for information. The air-interface Subcommittees that reviewed the document indicated that there were no comments. During the meeting's discussion, it was noted that there were implications to carriers and potential impacts to other groups such as TR-41 and

TR-8. TR-45 agreed to contact TIA with a request that TIA establish a relationship with ANSI C.63. There were no objections to TIA establishing the relationship. The ATIS incubator program related to Hearing-Aid Compatibility (HAC) was also noted.

10. Relative to new business, the following items were addressed:

a. cdma2000[®] trademark usage

Document .18R1 was provided on cdma2000[®] trademark usage on TIA only documents. A concern was raised relative to the clause "certifies their compliance" in the footnote. S.Hoyler and C.Blum to an action item to clarify the meaning and intent of the clause and to provide it via the TR-45 e-mail reflector. Document .18R1 was remanded to the Subcommittees and AHGs to review and take action as appropriate in the development of standards. In addition, TR-45 agreed to provide (via the e-mail reflector) language on the usage of the trademark and footnote as it relates to transposed 3GPP2 documents that differs from the usage in TIA only documents. Document .45 was provided for information.

b. Announcement of 2004 TR-45 Leadership Elections

The announcement of 2004 TR-45 leadership elections were discussed under previous agenda items 8b and 8d.

c. TIA Addenda

Documents .30 and .08 were provided for information. It was agreed that TR-45 would make a recommendation to the TIA Technical Committee to modify the TIA Addenda policy to "either / or" such that either a "delta addendum" (aka delta document) or an "enhanced addendum" should be provided without requiring a "delta addendum" for TIA publication and to allow the group to elect whether to provide a "delta addendum" or "enhanced addendum" or both. It was agreed to make the recommendation to the TIA Technical Committee at its 17 December 2003 meeting. It was noted that the policy change was being requested to facilitate publication of the TR-45.5 documents presently on hold due to the current policy.

A question was raised regarding the difference between "revision" and "addendum". TIA took an action to define "addendum" and "revision." TR-45 plans to shared with the TIA Technical Committee (at some later date) the TR-45 definitions of "addendum" and "revision". An additional concern was raised related to the enforcement of the use of "addendum" versus "revision." TIA agreed to investigate the ANSI policy and practices regarding extensive changes to documents including what constitutes extensive modifications. TR-45.5 to forward to TIA the TR-45.5 definitions used in practice. It was agreed that the TIA definitions (in conjunction with TR-45) would be shared with 3GPP2 in an effort to achieve a shared definition and usage of addenda and revisions.

d. 2004 ANSI Document Review

The attachment Document .34 was remanded to the Subcommittees and AHGs to review and take action as appropriate. TR-45 to address the TR-45.1 items and contact the outgoing TR-45.1 Chair for a guidance.

e. 3GPP2 Publication Process Relationship to TR-45

Document .42 provided an explanation of the new 3GPP2 publication process as it relates to TR-45 based on input from TIA. All were encouraged to review Document .42 and raise any additional concerns or questions for clarification to either D.Bart, C.Blum, or at the next TR-45 meeting in March 2004. It was noted that during the TR-45 Chairs meeting, S.Hoyler of TIA took an action to provide TIA training and documentation for the TR-45 Chairs on how to implement TIA ballots in the context of the new 3GPP2 publication process. TR-45 Leadership training is scheduled for the Tuesday before the TR-45 March 2004 meeting.

f. **MEID Presentation**

Document .44 was covered previously under agenda item 8i.

g. Correct Usage of ANSI Designation

Document .46 was provided for information relative to the correct usage of the ANSI designation. All were encouraged to review the document and take the appropriate action.

- 11. In terms of Liaisons, the following was reported:
 - a. **CTIA** R.Kemper provided a brief verbal report. It was reported that the FCC intends to issue an NPRM to the wireless industry for mandatory carrier outage reports.
 - b. ITU-T On behalf of D.Thompson, C.Blum noted Document .17 as the written report for information.
 - c. ITU-R There was no report. Document .28 was provided for information.
 - d. **CITEL** There was no report.
 - e. Wireless Communications Division (WCD) On behalf of B.Belt, J.Derr presented Document .19 as the written report.
 - f. **Technical Regulatory Issues Committee (TRIC)** On behalf of B.Belt, S.Hoyler presented Document .20 as the written report.
 - g. TIA S.Hoyler provided Document .21 as the written report. Documents .33 and .37 were provided for information. It was noted that the U.S. (i.e., TIA, et al) would host the GSC meeting in the 4Q05 and the next GSC meeting would be held in May 2004 in S.Korea. Documents .33 and .37 were provided for information. And, Document .18R1 was addressed previously under agenda item 10a.
 - h. **3GPP2** G.Flynn provided Document .22 as the written report for information.
 - i. **3GPP** P.Musgrove provided a brief verbal report. It was noted that individuals from China have experienced difficulties securing visas for travel into the U.S. to attend recent 3GPP meetings. Some have suggested that 3GPP not meet in the U.S. as a result.
 - j. **ATIS** E.Hall provided a verbal report. It was noted that as a result of the ATIS re-organizations, participants in the ATIS engineering committees would be required to pay ATIS membership fees going forward.
- 11. In review of assignments, a summary of the assignments are as follows:
 - 1. TIA to provide a plaque of recognition to J.Kay for his work in TR-45.1.
 - 2. TIA to provide a plaque of recognition to C.Ishman for his work in TR-45.2 and TR-45.NAG.
 - 3. TIA to provide a plaque of recognition to C.Carroll for his work in TR-45.AHAG and UIM/ESN AHG.
 - 4. The outstanding TR-45.1 work item related to SP-3-4658 (i.e., to upgrade IS-89 to ANS status) will be balloted by TR-45 once a soft copy is located. In addition, TR-45 will seek to locate any other TR-45.1 legacy documents.
 - 5. E.Hall, on behalf of ATIS, will investigate the status of the anticipated ATIS OBF response to the previous sent TR-45 correspondence on JIP.
 - 6. TR-45.2 to announce the upcoming election for TR-45.2 Chair and solicit nominations.
 - 7. TR-45 will put forth to the TIA Technical Committee a recommendation to abolish the odd/even-year election requirement.
 - 8. Regarding Document .27, S.Holyer will follow-up with D.Bart on the disposition of the proposed TR45.2 correspondence to the FCC from TIA related to SID Administration.
 - 9. TIA took an action to generate explanatory text to clarify the correct usage of the terms ANS/TIA/EIA in document titles (i.e., usage going forward) before the next meeting of TR-45 in March 2004.

- TR-45.4 to call for Chair nominations at its meeting in December 2003 and conduct the election at its meeting in January 2004. For TR-45.4 Vice-Chair, plans are to call for nominations at its meeting in January 2004 and conduct the election at its subsequently scheduled TR-45.4 meeting (i.e., either February or March 2004.)
- 11. TR-45 highly recommends that the LAES e-interface work be done collectively. TR-45 strongly encourages co-located meetings with LAES and the other SME in the relevant groups (i.e., TR45.6 and TR45.2) to facilitate expediting this work by having the TR-45.6 and TR-45.2 experts contribute directly to the work of TR-45 LAES. TR-45 leaves it to the affected group Chairs (i.e., LAES, TR45.6, and TR45.2) to negotiate the meeting logistics.
- 12. TR-45 plans to share the TR-45.AHEM scope and charter with the TIA Technical Committee (TC) and suggest that the TIA Technical Committee consider a horizontal AHG on EMD patterned after the TR-45 AHEM.
- 13. TR-45 scheduled an interim conference call meeting for Thursday 18 December at 11:00 AM ET to seek approval of PN-4465-RV1 for publication as J-STD-025-B and to seek a recommendation to move forward for ANS ballot.
- 14. TIA to investigate whether there are any requirements (such as creation, distribution, legal review, etc.) on joint meeting reports that include TR-45 AHGs.
- TR-45.LAES was encouraged to explore holding a co-located information sharing meeting with 3GPP2. G.Flynn was asked to contact the 3GPP2 Steering Committee Chair relative to the possibility of such a colocated information sharing meeting.
- 16. TR-45 UIM/ESN AHG to forward to 3GPP2 TSG-S, Document .11c, the TR45 approved amended GHA Assignment Guidelines and Procedures.
- 17. TIA to provide a list, to the UIM/ESN AHG and copyto TR-45, of manufacturers assigned ESN codes that could not be reached via previous mailings.
- TR-45 UIM.ESN AHG to distribute by Monday 08 December 2003, the correspondence in Document .11a, to the industry concerning migration information related to ESN exhaust, as approved an amended by TR-45.
- 19. The UIM/ESN AHG will work with TIA to explore conducting an industry seminar on the migration to MEID that includes the MEID presentation in Document .44 and a list of frequently asked questions and answers.
- 20. The Subcommittees and AHGs were directed to provide detailed MEID standards development status at the next TR-45 meeting in March 2004.
- 21. TR45.6 was directed to raise its concern relative to potentially missing NRM interfaces to either 3GPP2 TSG-X or the TR45.NAG via TR45.
- 22. J.Alphonse, as the newly appointed TR-45 Program Manager, to provide a modified formatted TR-45 Program Management Report to the next meeting on TR-45 in March 2004.
- 23. The OID Administration Guidelines Editor to request a TIA project number to track revisions to the document.
- 24. It was noted that TR-45.6 will review the ITU-T SSG Draft Recommendation Q.SNFB in Document TR45/03.09.03.25 at its December 2003 meeting and provide comments to the SSG directly and copyto TR45.
- 25. It was noted that TR-45.6 will review the ITU-T SSG Request to SDOs for Q.1742.3 Publication Status in Document TR45/03/09/03.26 at its December 2003 meting and provide comments to the SSG directly and copyto TR45.
- 26. P.Nurse took as an assignment to propose a TIA / 3GPP2 publication cross referencing numbering scheme at the next TR45 meeting in March 2004 based on review of the processes used by others such as ETSI.
- 27. TR-45 will contact TIA to request that TIA establish a relationship with IEEE relative to ANSI C.63.
- 28. Relative to Document .18R1, TR45 and TIA (S.Hoyler and C.Blum) took an assignment to clarify the meaning and intent of the clause "certifies their compliance" in the footnote.
- 29. S.Hoyler to provide Document .18R2 via the TR-45 e-mail exploder that addresses trademark usage for TIA only documents.
- 30. Document .18R1 (pending receipt of Document .18R2) was remanded to all the subcommittees and ad-hoc groups to follow in the development of the standards.

- 31. TR-45 will provide (via the TR-45 e-mail reflector) an explanatory text on the usage of the cdma2000® trademark and associated footnotes as it relates to TIA transposed 3GPP2 documents that differs from usage in TIA only documents.
- 32. Regarding the TIA Addenda policy, TR-45 will recommend a change in the policy at next the TIA Technical Committee meeting on 17 December 2003. TR-45 will recommend not to require the delta addenda (aka "delta documents") for TIA publication and to allow a group to elect whether to provide delta addenda or "enhanced addendum" or both.
- 33. TIA take an assignment to define the terms Addenda and Revisions. TIA will clarify the responsibility for enforcement of Addenda versus Revisions. And, TIA with TR-45 will investigate the ANSI policy regarding addenda that contain extensive changes to documents.
- 34. TR-45 will let the TIA Technical Committee know (at some later date) the TR-45 common definitions and practices relative to Addenda and Revisions.
- 35. TIA working with TR-45 will coordinate sharing with 3GPP2 the definitions of Addenda and Revisions in an effort to achieve a common understanding and usage in practice.
- 36. The attachment to Document .34, related to 2004 ANSI Document Review, was remanded to the Subcommittees and AHGs to review and take action as appropriate.
- 37. Document .42, related to the 3GPP2 Publication Process Relationship to TR-45, was provided for information to the Subcommittees and AHGs.
- 12. Review Meeting Schedules
 - a. **TR-45 2004 Schedule** The next Committee TR-45 meeting will be held March 3-4, 2004. Plans are to convene the meeting at 1:00 PM on Wednesday and re-convene on Thursday. Document TR45/03.06.05.48 was provided for information.
