- 7. The meeting report of 5-6 March 2008 numbered TR45/08.06.04.02 was reviewed. A motion was made and passed with no objections to approve the report.
- 8. The following Subcommittee and Ad-Hoc Group reports were provided:
 - a. **TR-45.2 Subcommittee** L.Milton provided Document .05 as the written report. Regarding the TR-45.2 proposal for TIA to manage a website location for the SS7 Translation Type (TT) and Subsystem Numbers (SSN), it was reported that although TIA has been developing a web page to manage the data, TIA is currently waiting on disclaimer language from TIA legal to include on the web page. TIA was requested to provide the needed disclaimer legal to include on the SS7 Translation Type (TT) and Subsystem Numbers (SSN) web page as soon as possible. Regarding the list of TR-45.2 standards still pending publication. TIA was requested to provide the status for each document including the current place in the publication process. TIA was asked to report the status report directly back to the TR-45.2 Chair. It was suggested that TR-45 draft correspondence directly to TIA Director of Standards and Technology and above to strongly request action on the outstanding publications. The TR-45 Chairs intends to contact Ed Mikoski regarding all outstanding TR-45 standards still pending publication and to invite Ed Mikoski, TIA VP of Standards and Business Development., to attend the next TR-45 meeting in September 2008 at TIA Headquarters. Documents .27, .28, .29, .30, .31, .32, .33, and .44 were provided for information.
 - b. **TR-45.3 Subcommittee** P.Musgrove presented Document .06, the written report. It was reported that update work for TDMA-SC continues to be done jointly with ATIS WTSC. Because of a recent

agreement to restructure WTSC (i.e., effectively combining WTSC G3GRA and WTSC WWINA), a new group called "WTSC RAN" is now the relevant group working the TDMA-SC updates for M.1457. It was noted that TR-45.3 will need to work closely with TIA regarding the ballot of the TDMA-SC documents for the M.1457-8 updates. TR-45.3 will contact TIA to give TIA a heads-up regarding upcoming ballots in the Sep/Oct 2008 for TR-45.3 documents needed in a tight timeframe to meet the ITU-R deadline for M.1457-8 updates.

- c. **TR-45.4 Subcommittee** G.Turnipseed provided Document .07 as the written report.
- d. **TR-45.5 Subcommittee** O.Pearson provided Document .08 as the written report with attachments .08a through .08c. It was reported that regarding M.1457-9, the Letter of Intent was submitted to the ITU-R in March 2008. In addition, it was reported that updates to M.1580, M.1581, IMT-TECH, and IMT-EVAL were completed and submitted to the ITU-R in March 2008. Documents .35, .36, and .37 were provided for information.
- e. **TR-45.6 Subcommittee** B.Hirschman provided Document .09 the written report.
- f. **Ad Hoc Authentication Group (AHAG)** F.Quick provided Document .10 as the written report. It was requested that an agenda item be added to the next Committee TR-45 meeting to recommend PN-3-0296 for publication as TIA-1141. Documents .34, .39, and .47 were provided for information.
- g. **AHG on Electronic Media Documentation (AHEM)** P.Nurse provided Document 14 as the written report. It was reported that the status of the work items remains unchanged since the last meeting. TR-45 requested that TIA provide an update on the status of the TR-45 request for electronic sign-in and webbased calendar.
- h. **AHG on ESN/UIM/MEID (EUMAG)** G.Pellegrino provided Document .11 as the written report with attachments .11a through .11c. Discussion of the contents of document .11c was deferred until agenda item 9a. It was noted that the next TR-45 EUMAG conference call meetings are scheduled for 24 June 2008 and 15 July 2008.
 - **ESN Administration** J.Derr provided Document .12 as the written report.
 - **MEID Administration** On behalf of A.Dryden, H. Cuschieri presented Document .13, the written report.
 - **UIM Administrator's Report** On behalf of A.Dryden, H. Cuschieri presented Document .41, the written report.
- i. **J-STD-025-B Series Report** There was nothing to report at this time.
- j. **OID Administrators Report** There was nothing to report at this time. The Administrator position remains vacant. TIA was asked to identify the OID Administrator.
- k. AHG on Wireless Alerts It was reported that the work of the Ad-Hoc on Wireless Alerts has been completed. The Ad-Hoc was disbanded. D.Sennett was thanked for his guidance and the work completed. TIA was requested to provide a plaque of recognition and appreciate for D.Sennett for his leadership of the Ad-Hoc Group on Wireless Alerts.

The Committee recessed for a break at 2:50 PM and reconvened at 3:15 PM.

9. Relative to old business, the following items were addressed:

a. ESN Exhaust Options Recommendation

Document .38 was presented by G.Pellegrino, Chair TR-45 EUMAG, to outline the ESN exhaust options under consideration. Document TR45/08.05.06.02 was carried-forward from the previous TR-45 meeting held on 6 May 2008. The Chair re-introduced the correspondence from TIA that requested

that Committee TR-45 detail direction that the ESN Administrator should follow going forward. Document TR45/08.05.06.03 was presented by G.Pellegrino to share the EUMAG consensus recommendation to support Option "A" as supported by 3GPP2.

Numerous documents containing correspondence regarding the ESN exhaust options recommendation were provided as follows.

- Document TR45/08.05.06.06 was noted as correspondence from SK Telecom in support of Option B.
- Document TR45/08.05.06.07 was noted as correspondence from Huawei Terminal Company in support of Option B.
- Document TR45/08.05.06.08 was noted as correspondence from Reliance Communications Limited in support of Option B.
- Document .18 presented by S.Samra for information.
- Document .19 contains correspondence from Multi-Links Telecommunications Ltd in support of Option B.
- Document .20 contains correspondence from Zapp Romania in support of Option B.
- Document .21 contains correspondence from PT Smart Telecom of Indonesia in support of Option B.
- Document .22 contains correspondence from ZTE Corporation in support of Option B. It was noted that Document .22 supersedes the correspondence previously provided in TR45/08.05.06.09.
- Document .23 contains correspondence from Electronics General Company in support of Option B.
- Document .24 contains correspondence from Bharat Sanchar Nigam Ltd. in support of Option B.
- Document .40 contains correspondence from SK Telecom in support of Option B.
- Document .42 contains correspondence from Seiko Instruments Inc. in support of Option B.
- Document .43 presented by C.Barber contains correspondence from KDDI with a compromise proposal for the use of pseudo-virgin ESNs that supports Option B for a finite period of time.
- Document .45 contains correspondence from JSC "Kazakhtelecom" in support of Option B.
- Document .46 contains correspondence from Reltel Wireless of Nigeria apparently in support of Option B.
- Document .48 with attachments .48a though .48f contains correspondence from Samsung with attachments from operators (i.e., SK Telecom, KTF, and LG Telecom) in support of Option B was presented by K.Green. Attention was drawn to the last paragraph of Document .48d in which Samsung indicated its plans to research the reclamation of Korean PCS ESNs from operators.
- Document .49 contains correspondence from Reliance that appears to support a combination of Options A and B.
- Document.52 contains correspondence from Connect in support of Option B.
- Document .52a contains correspondence from Infotel Business in support of Option B.
- Document .53 that contains a presentation from LGE in support of Option B was introduced by S.Yoon.
- Document .54 contains correspondence from LG Telecom in support of Option B.
- Document .55 contains correspondence from Sampoerna Telekomunikasi Indonesia in support of Option B.

TR-45 intends to respond to all of the incoming correspondence received regarding ESN exhaust and allocation listed above.

It was indicated by T.Johnson of ZTE that more letters regarding ESN allocation should be anticipated. M.Russell of Continental Automotive Systems was encouraged to send correspondence to TR-45 for information regarding their proposed reuse of ESNs. R. Marcel of Gemalto indicated support for Option A.

The Committee recessed for a break at 5:10 PM and reconvened at 5:35 PM.

A motion was made by Qualcomm and seconded by Samsung as follows.

"It is recommended that ESN assignments continue for a limited time beyond ESN exhaust using reclaimed ESNs identified as unused. Such assignments shall be made in accordance with guidelines and timeline developed by the EUMAG and approved by TR-45."

There were no objections to the motion. The motion was adopted with no objections.

The Committee recessed at 6:00 PM Local Time on Wednesday, June 4, 2008 and re-convened at 8:00 AM Local Time on Thursday, June 6, 2008.

Regarding Document .11c, the recommendation was that no action would be taken relative to Document .11c based on the result of the motion adopted above.

Documents .43 and .49a were remanded to the TR-45 EUMAG for consideration in the development of the guidelines and timeline per the motion adopted above.

An interim Committee TR-45 meeting (via conference call) was scheduled to approve the guidelines and timeline developed and recommended by the EUMAG per the motion adopted above. The target date is 17 July 2008 at 4:00 PM ET.

b. TIA Publication of 3GPP2 Specifications

Document .25 was provided for information. Document .50, provided by TIA, contains the TIA and ANSI standards document publication checklist. Document .51, provided by TIA, contains guidance for the transposition of 3GPP2 specifications to TIA publications. Document .51r1 was remanded to TR-45.2, TR-45.4, TR-45.5, TR-45.6, and the AHAG to take action as appropriate. TR-45 will share Document .51r1 as amended with S.Montgomery of TIA. Document .50 was remanded to all TR-45 Subcommittees and Ad-Hoc Groups to take action as appropriate.

It was suggested that Document *TR45/08.03.05.42r1* be broadened to address more than the transposition of 3GPP2 documents. Thus, Document *TR45/08.03.05.42r1* was updated and numbered Document .56. Document .56r2 will be forwarded to TIA as endorsed by TR-45 to seek TIA approval of the TR-45 Document Guidelines. Plans are for TR-45 to approve the "Document Guidelines" in Document .56r2 at the interim conf call on 17 July 2008. Thus, TIA approval is requested prior to the interim TR-45 meeting.

c. TIA Legal Review of 3GPP2 Documents

This agenda item and Document .05.06.04 will be carried-forward to the next TR-45 meeting in September 2008 in anticipation of a 3GPP2 reply to TIA.

d. ITU-T SG2 Liaison Statement on Cell Broadcast Message Identifiers Update

P.Musgrove provided a brief verbal readout on the disposition of the joint TIA/ATIS response to the ITU-T SG-2 LS on Cell Broadcast Message Identifiers. The joint response was not accepted by SG2. Any further action will be decided by the joint ATIS/TIA CMAS group.

e. Commercial Mobile Alters Service (CMAS) Joint Standards Work Update

P.Musgrove, O.Pearson, and L.Milton provided brief verbal updates on the status of the joint TIA/ATIS work on Commercial Mobile Alters Service (CMAS).

f. ITU-R SG 5 Liaison Statement on Schedule for Updating M.1457 to Revision 9

Documents .38 and .35 were provided for information. It was noted that no action is required from TIA regarding Revision 9 for the upcoming ITU-R WP5D meeting in June 2008

g. Submission and evaluation process for IMT-Advanced
