7. The meeting report of March 15-16, 2006 numbered TR45/06.06.08.02 was reviewed. A motion was made and passed with no objections to approve the report as amended with editorial corrections to agenda item numbering.

8. The following Subcommittee and Ad-Hoc Group reports were provided:

- a. **TR-45.2 Subcommittee** – D.Crowe provided Document .05R1 as the written report. TIA agreed to work with TR-45.2 to address the “red flag” issue associated with page numbering and “watermarks” on TR-45.2 ballot version of standards in PDF format. It was recommended that the Subcommittees provide TIA with documents for ballot with the required watermarks already applied. The NGN focus group will remain in TR-45.2 for now. TIA agreed to investigate inaccurate information on the TIA website as identified by TR-45.2 in Document .05R1.

It was re-iterated that this was the last TR-45 meeting for the TR-45.2 Chair, David Crowe. He indicated that he would be taking a sabbatical after his term as Chair expires in July 2006. TR-45 expressed its appreciation and gratitude and thanked him for his years of service to TIA and TR-45.2.

- b. **TR-45.3 Subcommittee** – P.Musgrove provided Document .06 as the written report. It was noted that TR-45.3 submitted via TIA an update package for Recommendation M.1457.6 to ITU-R WP8F by the 31 May 2006 deadline.
- c. **TR-45.4 Subcommittee** – G.Turnipseed provided Document .07 as the written report.

The Committee recessed for a break at 2:45 PM and reconvened at 3:05 PM.

- d. **TR-45.5 Subcommittee** – J.Alphonse provided Document .08 as the written report. TR-45.5 thanked TIA staff for its support in the submission of the TR-45.5 update to the ITU-R Recommendation M.1457.
- e. **TR-45.6 Subcommittee** – P. Yegani provided Document .09R1 as the written report. It was noted that TIA-835-D would be published soon.
- f. **Ad Hoc Authentication Group (AHAG)** – F.Quick provided Document .10 as the written report. Documents .26, .27, .28, .29, and .30 were provided for information. The AHAG agreed to contact 3GPP SA3 regarding the need to meet annually per the joint control agreement. The AHAG plans to get more information on the proposed new work item in 3GPP2 WG-4 related to Preferred Cryptographic Profiles. The AHAG agreed to provide a copy of the 3GPP2 WG-4 recommendation document at the next TR-45 meeting in September 2006. During the discussion of a possible erratum for TIA-946-1, a question was raised regarding the MD5 algorithm. The AHAG chair agreed to look into a 3GPP2 WG-4 liaison on this issue.
- g. **AHG on Electronic Media Documentation (AHM)** – P.Nurse provided Document .14 as the written report.
- h. **AHG on LAES** – G.Pellegrino provided a brief verbal report. There were no comments on the ballot of the MEID addendum to the ANS version of J-STD-025-B. The J-STD-025-B addendum was approved for publication. TR-45 agreed to submit the ANS J-STD-025-B addendum for publication, at the appropriate time. It was noted that the AHG on LAES has no meetings scheduled. It was suggested that TR-45 postpone rendering the AHG on LAES dormant until the publication of the ANS J-STD-025-B and the addendum. TR-45 plans to follow-up with TIA regarding the steps required to rescind the TIA version of J-STD-025-B. At the next TR-45 meeting in September 2006 the status and future of the AHG on LAES will be re-addressed. It was suggested that an agenda item be placed on the September 2006 TR-45 meeting agenda to address rescinding the TIA version of J-STD-025-B. Documents .31 and .33 were provided for information. It was noted that Document. 33 should have been addressed under agenda item 8e.

- i. **AHG on ESN/UM/MEID (EUMAG)** – G.Pellegrino provided Document .11 with attachments .11a through .11c as the written report. The ESN Guidelines v1.9a provided in Document .11bR1 was approved for publication as amended. The EUMAG agreed to forward the approved “*ESN Guidelines v1.9a*” to the ESN Administrator for publication. The EUMAG agreed to discuss the need for further communication with the Cdma Development Group (CDG) relative to ESN exhaust and MEID deployments.
 - **ESN Administration** – J.Derr provided Document .12 as the written report.
 - **MEID Administration** – H. Cuschieri provided Document .16 was the written report. It was noted that ARIB (Japan) has inquired about being a regional MEID administrator.
- j. **TR-45 Standards Development Program Report** – J.Alphonse provided Document .15 as the program report for information.

The Committee recessed at 5:15 PM Local Time on Thursday, June 8, 2006 and re-convened at 8:35 AM Local Time on Friday, June 9, 2006.

9. Relative to old business, the following items were addressed:

- a. **Joint ATIS/TIA Standards Development Agreement**
It was reported that there is a draft Memorandum of Understanding (MoU) being circulated within TIA for review and comment. Plans are to forward the MoU to ATIS in the near term.
- b. **Referencing Draft Documents in TIA Standards**
TR-45 agreed to continue to conduct “business as usual” regarding referencing draft documents in TIA standards. TR-45 will investigate its options for continued discussion at the next TR-45 meeting in September 2006.
- c. **GSC-11 Readout**
On overview of the GSC-11 meeting held the week of May 30 – June 2, 2006 was presented by D.Bart as contained in Document .38R1. It was noted that TIA successfully hosted the GSC-11 in Chicago, IL. The outgoing ETSI General Director Karl-Heinz Rosenbrock was honored during the meeting. All were encouraged to view the GSC website at <http://www.gsc.etsi.org/>.
- d. **Announcement of Upcoming TR-45 Subcommittee Leadership Elections**
The TR-45 Subcommittee and Committee leadership elections scheduled to take place in year 2006 were noted. The impacted Subcommittees were directed to conduct elections per the TIA Engineering Manual.

- e. **TIA Transposition of 3GPP2 Specifications**
Documents .35R1 and .36 were provided for information for consideration. During the next TIA 3GPP2 delegation meeting, TR-45 will raise the concerns outline by TR-45.4 in Document .36 related to the publication of “marked versus clean” documents. There was additional discussion regarding the possibility of publishing 3GPP2 specifications with appropriate TIA cover material - after the TIA process of transposing a specification into a TIA standard is completed. TIA will continue their investigation of this proposal, so that TR-45 can resolve this issue at the September 2006 TR-45 meeting.

10. Relative to new business, the following items were addressed:

None.

The Committee recessed for a break at 9:55 AM and reconvened at 10:15 AM.

11. In terms of Liaisons, the following was reported:

- a. **CTIA** – There was no report. However, it was mentioned that CTIA has initiated an activity related to the use of cell broadcast and SMS for Emergency Alert Service (EAS.) It was noted that it is important for TR-45 to understand the impacts of various proposals to provide EAS and what can be done in the near and long term to support EAS. G.Patel agreed to work with G.Flynn to pull together a presentation for the next TR-45 meeting in September 2006 to provide information on the CTIA activity for the Emergency Alert Service (EAS) existing capabilities that can be used for support of EAS, etc.
- b. **ITU-T** – There was no report.
- c. **ITU-R** – There was no report. However, it was mentioned that the TR-45 liaison to WP8A, contained in document .23, noted the duplication of work relative to the two questions on BWA. It was noted that WP8A did agree to the merging of the two questions.
- d. **CITEL** – There was no report. It was noted that CITEL was an Observer at GSC-11.
- e. **Wireless Communications Division (WCD)** – It was reported that Girsh Patel of Nortel was appointed the new Vice-Chair of the TIA Wireless Communications Division (WCD.)
- f. **TIA** – H.Cuschieri provided a brief verbal report. Document .39 was provided for information. It was noted that the TIA Technical Regulatory Issues Committee (TRIC) was re-activated.
- g. **3GPP2** – H.Cuschieri provided a brief verbal report. Highlights of the 3GPP2 Workshop scheduled for Brazil in October 2006 were provided.
- h. **3GPP** – P.Musgrove provided a verbal report. It was reported that the 3GPP Release 7 would be delayed to December 2006 and Stage 3 work was targeted for 1Q07.
- i. **ATIS** – The Liaison remains vacant. There was no report. However, Document .34 was provided for information.
- j. **IFAST** – E.Hall and D.Crowe provided Document .21 as the written report.
- k. **Project MESA** – Document .20 was provided for information. The 14th meeting of Project MESA will be held during the week of May 7, 2007, in Seattle, Washington, hosted by Cingular.

8. The EUMAG agreed to forward the approved “*ESN Guidelines v1.9a*” to the ESN Administrator for publication.
9. During the next TIA 3GPP2 delegation meeting, TR-45 will raise the concerns outlined by TR-45.4 in Documents .36 related to the publication of “marked versus clean” documents.
10. G.Patel agreed to work with G.Flynn to pull together a presentation for the next TR-45 meeting in September 2006 to provide information on the CTIA Emergency Alert Service (EAS).
