6. The meeting report of November 28, 2001 numbered TR45/02.03.06.02 was reviewed. A motion was made and passed with no objections to approve the meeting report with the following modifications.

The TR-45 Meeting Report of November 28, 2001 was modified and re-numbered TR45/02.03.06.02R1. It was agreed that the TR-45 Meeting Report of November 28, 2001 would be re-issued.

- 7. In terms of correspondence, the following item was addressed:
 - **Document .03** This correspondence was provided for information regarding members' removal from meeting quorum.
- 8. **TIA IPR Presentation -** P.Vishny facilitated an open discussion on IPR policy to interested members prior to the convening of the TR45 meeting.
- 9. The following Subcommittee and Ad-Hoc Group reports were provided:
 - a. **TR45.1 Subcommittee** J. Kay provided Document .04 as the written report. It was noted that TR45.1 plans a revision of TIA/EIA/TSB70-A to include changes since the publication of TIA/EIA/IS-817 and to fix known errors.
 - b. **TR45.2 Subcommittee -** T.Watts provided Document .05 as the written report. TR45.2 requested that the monthly UIM ID Administrator's Report from TIA provide information equivalent to the ESN Administrator's Report particularly the association between company name and the assigned UIM ID. Document .27, provided for information, reflected a similar request from 3GPP2 TSG-N relative to the UIM ID Administrator's Report. It was agreed that TR45 would send correspondence to TIA and to 3GPP2 to request that the UIM ID Administrator's Report provide the additional information as requested in Document .05.
 - c. **TR45.3 Subcommittee** On behalf of P.Nurse, S.Willhoff, presented Document .06R1 as the written report. It was reported that Revision D of TIA/EIA-136 would be ready-for-publication March 2002. It was noted that TR45.3 has disbanded its working group structure and now conducts all business under its Plenary.
 - d. TR45.4 Subcommittee D.Baldwin provided Document .07 as the written report. It was reported that Dale Baldwin of Sprint PCS and David Ott of Qualcomm were elected TR45.4 Chair and Vice-Chair, respectively. It was noted that TR45.4 was re-organized to align with the changes in the 3GPP2 TSG-A organizational structure.
 - e. **TR45.5 Subcommittee** C.Barber on behalf of J.Alphonse presented Document .08 as the written report. It was reported that cdma2000 Release A was published without the Sync Channel fix and cdma2000 Release B was issued for 30-day ballot without the Sync Channel fix. It was noted that a 3GPP2 Steering Committee (SC) Sync Channel Ad Hoc was formed to continue discussions with a target for resolution by March 15, 2002. It was noted that 1xEV-DV among other items were approved for inclusion in cdma2000 Release C targeted ready-for-publication May 24, 2002 and delivery to ITU-R WP 8F May 31, 2002. Document .08R1 was provided to reflected suggested amendments.

f. **TR45.6 Subcommittee** – E.Campbell provided Document .09 as the written report. Attention was drawn to the revised schedule for the completion of IS-835-B, *cdma2000 Wireless IP Network Standard*, whose ballot expired on March 5, 2002.

The Committee recessed for lunch at 1:05 PM and reconvened at 2:25 PM.

- g. **Ad Hoc Authentication Group (AHAG)** C. Carroll provided Document .10R1 as the written report. Documents .26 and .34 were provided for information. In addition, attention was drawn to Document .35, correspondence from AHAG regarding ESN reuse. The AHAG indicated no security problems associated with the re-use of ESNs.
- h. **AHG on NRM, Acronyms & Definitions, Guide to Standards (NAG)** B. Slocum provided Document .11 as the written report. The NAG re-iterated its plans to prepare correspondence to 3GPP2 TSG-S and TSG-N regarding input to the TR45 NRM.
- i. **AHG on Electronic Media Documentation** S.Hoyler provided Document .20 as a written report. It was suggested that a meeting of the AHG be held immediately following the TR45 meeting on Thursday, March 7, 2002, time permitting.
- j. AHG on UIM/ESN T.Watts provided Document .12 as the written report. It was noted that the AHG on UIM/ESN provided input to the 3GPP2 MEID JEM in February 2002. Attention was drawn to the Mobile Equipment Numbering JEM Report and Conclusions attached to Document .19. The AHG recommended the support of a 56-bit IMEI or MEID as the long term ESN replacement for Mobile Equipment Identifier for development and implementation before ESN exhaust. The concepts presented in Document .12 for ESN exhaust and replacement were supported by TR45 without objection.

Document .12 was remanded to the AHAG, the ESN Administrator, and all of the Subcommittees (except for TR45.6) for review of the recommendations and requirements and for comment back to the AHG on UIM/ESN with a copyto TR45 by May 24, 2002. TR45 to forward correspondence to the 3GPP2 SC Chair (and copyto the GSMNA and the JEM invitees as listed in Document .31R1) to request that 3GPP2 provide a recommendation that takes into consideration the recommendations and requirements in Document .12 and to request that 3GPP2 forward its recommendation to TR45 prior to the next TR45 meeting scheduled for June 5-6, 2002.

In addition, TR45 to send correspondence to both CTIA and ATIS to alert their members to the recommendations and requirements in Document .12 particularly as it relates to certification and impact to FCC 47 CFR Part 22 Section 919.

Furthermore, the AHG on UIM/ESN was directed to provide three items to the next TR45 meeting June 5-6, 2002 as follows.

- an updated version of the recommendations and requirements based on inputs received;
- a straw-man proposal of language for the FCC to replace 47 CFR Part 22 Section 919; and
- to address the need for amended or additional Administrator's Guidelines.

The ESN exhaust date was projected as 4Q04. It was recommended that a new and/or changed ESN code be implemented as soon as possible. It was agreed that TIA would issue the *Electronic Serial Number Manufacturer's Code Assignment Guidelines and Procedures, Version 1.7A* in Document .23 as amended. And, the Press Release on the revised ESN Guidelines in Document .22R1 would be amended as suggested prior to release by TIA on March 11, 2002.

Heartfelt thanks were expressed to Stephen Jones of NEC, the former Chair of TR45.4 since its inception in 1991, for his years of commitment and leadership.
