- 7. The meeting report of 29-30 November 2007 numbered TR45/08.03.05.02 was reviewed. A motion was made and passed with no objections to approve the report as amended to fix the typo from "3G3RA" to "G3GRA."
- 8. The following Subcommittee and Ad-Hoc Group reports were provided:
  - a. TR-45.2 Subcommittee L.Milton provided Document .05 as the written report. Documents .23, .26, .27, .32, and .37 were provided for information. It was noted that TIA had established a trial website location for the SS7 Translation Type (TT) and Subsystem Numbers (SSN) as requested previously by TR-45.2. TIA Staff was asked to provide status of the final implementation of the website for the SS7 Translation Type (TT) and Subsystem Numbers (SSN).

## • Action Plan on Impacts of Common IMS

Document .21 contains the TR-45.2 action plan on impacts of moving future development of Common IMS to 3GPP. Regarding the three issues and the recommended solutions presented in Document .21, TR-45 agreed without objection to the adoption of the recommended solutions with the understanding that TR45.2 would provide periodic status to TR-45 on the implementation of the recommended solution as the work moves forward. TR-45 directed TR-45.2 to move forward with the implementation of the three recommended solutions in Document .21 with the understanding that TR45.2 would provide periodic status to TR-45 on the implementation of the recommended solutions as the work moves forward. TR-45 on the implementation of the recommended solutions as the work moves forward. It was suggested that discussion of the merits of TIA becoming an OP of 3GPP be deferred to the appropriate TIA policy committee by interested member companies. Document .22 was provided for information.

- b. TR-45.3 Subcommittee P.Musgrove presented Document .06, the written report. It was reported that the main work of TR-45.3 was related to updates to M.1457 for Revision 7 and Revision 8 plus the approval of documents for publication relative to the M.1457 updates. It was noted that TR-45.3 was not negatively impacted by the failure of TIA to meet the ITU WP5D deadline because the TDMA-SC materials were submitted by ATIS before the deadline. Documents .28 and .33 were provided for information.
- c. **TR-45.4 Subcommittee** G.Turnipseed provided Document .07r1 as the written report. It was reported that George Turnipseed of Sprint was re-elected Chair of TR-45.4 by acclamation in January 2008 and

David Ott of Qualcomm was re-elected Vice-Chair of TR-45.4 by acclamation in February 2008. TR-45 confirmed the re-elections of G.Turnipseed as Chair of TR-45.4 and D.Ott as Vice-Chair of TR-45.4.

TR-45.4 reported on the completion of TR-45 remanded items as well as on TR-45.4 progress since the last TR-45 meeting in December 2007. The Subcommittee and AHG Chairs were directed to send an unsigned attendance roster with attendee changes marked to P.Bogard of TIA so that the appropriate updates to the attendance rosters can be made.

- d. TR-45.5 Subcommittee O.Pearson provided Document .08r1 as the written report with attachments .08a through .08c. TR-45.5 reported on several items including the ITU Recommendation M.1457 schedule, joint CMAS work in progress, TR-45 remanded items, as well as PN requests, standards balloted and published. TR-45 shared its plans are for the TR-45.5 Ad-Hoc Group on ITU to put in place check & balance procedures to ensure compliance with future ITU-R deadlines. It was reported that the TR-45 Chair received a telephone call from TIA President, Grant Seiffert, extending an apology for missing the deadline for submission of M.1457-8 update materials. Documents .29, .33, and .35 were provided for information.
- e. **TR-45.6 Subcommittee** On behalf of B.Hirschman, G.Flynn introduced Document .09, the written report. TR-45.6 was asked to bring to closure item 8 in Document .09 by identifying which Revision (i.e., 0 and/or A) of "cdma2000 Broadcast and Multicast Services (PN-3-0161, TIA-1041) should and will be published by TIA.

The Committee recessed for a break at 3:00 PM and reconvened at 3:15 PM.

f. Ad Hoc Authentication Group (AHAG) – F.Quick provided Document .10 as the written report with attachments .10A through .10F. Document .41 was provided to TR-45 for information. Regarding the publication of TIA-1097-A and TIA-1098-A, it was agreed that approval would be sought via e-mail by TR-45. Documents .10CR1 and .10DR1were provided for information at this time. TR-45 agreed without objection to resubmit to TIA for publication TIA-1098, TIA-1097, and TIA-1091. The Editor was directed to resubmit to TIA for publication TIA-1098, TIA-1097, and TIA-1091.

 Recommendation for Publication of PN-3-0095-RV1 as TIA-946-A TR-45 approved the outgoing correspondence in Document .10Ar1 as amended to correct a typo. TR-45 approved PN-3-0095-RV1-1 for publication as TIA-946-A. The Editor was directed to create the publication version of TIA-946-A and submit for publication. Documents .19 and .10B were provided for information.

- Recommendation for Ballot of PN-3-0296 (TIA-1141) It was noted that TR-45 approved the 30-day TIA ballot of PN-3-0296 via e-mail as reflected in Document .17. A "Recommendation for Publication of PN-3-0296 as TIA-1141" will be an agenda item for the next TR-45 meeting in June 2008. Documents .34 and .18 were provided for information.
- g. AHG on Electronic Media Documentation (AHEM) P.Nurse provided Document 14 as the written report. It was reported that the status of the work items remains unchanged. TIA was requested to provide more calendar information on the TIA website such as the date of the next Committee TR-45 meeting as well as an overview of all TIA Engineering Committee meetings so that members can plan ahead. The AHEM will forward the outstanding work item work sheets to P.Bogard of TIA to take action as appropriate.

h. AHG on ESN/UIM/MEID (EUMAG) – G.Pellegrino provided Document .11 as the written report with attachments .11a through .11c. Attention was drawn to Section 7 of Document .11 regarding the coordinated TIA & CDG outreach initiatives as well as the global presentations that continue to be provided by the CDG with TIA knowledge and coordination. It was noted that the CDG has a webinar on MEID/EUIMID migration scheduled for 7 March 2008. Furthermore, it was noted that the TIA Numbering Administrators along with the TR-45 and EUMAG Chairs visited industry entities in China during February 2008 to meet and discuss the state of MEID/EUIMID exhaust, implementation and Administration impacts. The visits were a cooperative effort mirroring similar CDG visits.

Document .11a that contained the ESN\_MEID milestone timelines was provided for information. Document .11b that contained the UIM\_EUIMID milestone timeline was provided for information. Document .11c that contained the 3GPP2 recently published version of the Mobile Equipment Identifier (MEID) GHA (Global Hexadecimal Administrator) Assignment Guidelines and Procedures (SC.R4002-0 v5.0) was provided to TR-45 for transposition for publication by TIA. TR-45 approved the publication and website posting of the Guidelines and Procedures in Document. 11c without objection as amended to remove the "draft" status. The EUMAG was directed to take the required steps to publish and post the Guidelines in Document .11d as the "*TIA MEID GHA Guidelines v5.0*".

- ESN Administration J.Derr provided Document .12 as the written report.
- **MEID Administration** On behalf of A.Dryden, G. Pellegrino presented Document .13, the written report.
- i. J-STD-025-B Series Report There was nothing to report at this time.
- j. **OID Administrators Report** There was nothing to report at this time. The Administrator position remains vacant. TIA was asked to identify the OID Administrator.
- k. AHG on Wireless Alerts There were no updates to report at this time.
- 9. Relative to old business, the following items were addressed:

#### a. TIA Publication of 3GPP2 Specifications

At the last TR-45 meeting in November 2007, TIA agreed to provide written guidelines of the new process for transposing 3GPP2 specifications to TIA publications to assist the Subcommittees in the implementation of this new process. TIA Staff agreed to provide written guidelines of the new process for transposing 3GPP2 specifications to TIA publications by end-of-March 2008. The TR-45.5 Chair agreed to consolidate any outstanding issues for TIA to address in the generation of the requested written guidelines. The TR-45.5 Chair provided Document .42r1 for review and comments by TR-45 to provide to TIA to help facilitate the generation of the written guidelines.

#### b. ITU-R WP8A Land Mobile Handbook on Deployment of BWA Systems

This agenda item was carried-forward from the last TR-45 meeting in November 2007 to follow-up on the TR-45 input to the ITU-R WP5A (formerly, WP8A) Liaison Statement (LS) on the Land Mobile Handbook on Deployment of BWA Systems. It was noted that the TR-45 input (that included UMB) was adopted at the 5A meeting in February 2008. Document .20 was provided for information. It was reported that no follow-up LS on the LMH was issued, however, there will be a Rapporteur's letter issued as an informal LS to External Organizations (EOs) to follow-up on the LMH for BWA.

#### c. ITU-T SG2 Liaison Statement on Cell Broadcast

At the last TR-45 meeting in November 2007 it was noted that additional input was solicited by the FCC relative to cell broadcast in Documents TR45/07.11.29.20 and TR45/07.11.29.20. The TR-45 Ad-Hoc Group on Wireless Alerts was requested to review the FCC request and determine if there is any input from TR-45 to SG2 by the May 2007 deadline. It was suggested that the AHG on Wireless Alerts can not do anything before the FCC provides the requirements in April 2008. Concern was raised that with the FCC requirements available in April 2008 and the SG2 input due in May 2008, that there maybe

insufficient time for the AHG to provide comments to TR-45. It was suggested that once available, the output of the AHG should be forwarded to the joint TIA/ATIS group working on CMAS.

The Committee recessed at 5:50 PM Local Time on Wednesday, March 5, 2008 and re-convened at 8:40 AM Local Time on Thursday, March 6, 2008.

## d. cdma2000 for Public Safety in U.S. Band Plan for 700 MHz Band

Document .31 was provided for information. It was noted that the TR-45 input was not accepted by 5A because it was not in response to a LS. Nevertheless, the TR-45 input did go into the meeting via a Sector Member input contribution and adopted at the 5A meeting in February 2008.

e. **ITU-R WP8F Minimum Performance Requirement and Evaluation Guidelines for IMT-Advance** Document .30 was provided for information. Concerns were raised regarding vetting and seeking approval at the TR-45 level on TR-45 responses to ITU-R Liaison Statements. The following motion was made by Ericsson and seconded by Rogers Wireless, "All Subcommittee contributions to ITU-R shall be coordinated, reviewed, and approved by TR-45 prior to submission to ITU-R." Based on a show of hands the vote on the motion was 3-Yes, 7-No, and 3-Abstain. The Motion did not carry.

### f. TIA Legal Review of 3GPP2 Documents

Document .40 was provided for information. TIA agreed to draft correspondence to 3GPP2 in response to the incoming correspondence from the last TR-45 meeting.

## g. Commercial Mobile Alerts Service (CMAS) Joint Standards Work

It was reported that TR-45.2 and TR-45.6 held a joint meeting on Monday 4 March 2008 regarding the CMAS joint standards work. There remains an open action item for TIA and ATIS staff to work together to provide access to upload and download meeting documents for the CMAS joint standards work meetings. TIA was asked to please resolve this item prior to the next joint meeting scheduled for 19-20 March 2008. Documents .24, .25, and .43r1 were provided for information.

#### h. Storage of Subcommittee Documents on the TIA ftpsite

TR-45.2 provided a proposal for the storage of Subcommittee documents contained in Document .44. Document .44 was provided for information. TIA was asked to provide write permission access to the INCOMING folder on the ftpsite for TR-45.3.

The Committee recessed for a break at 9:50 AM and reconvened at 10:15 AM.

10. Relative to new business, the following items were addressed:

## a. ITU-R WP5A Liaison Statement on M.1801 BWA Systems Below 6 GHz

Document .36 was remanded to TR-45.3 and TR-45.5 to take action as appropriate. Document .36 was remanded to TR-45.2, TR-45.4, and TR-45.6 for information.

## b. ITU-R SG 5 Liaison Statement on Schedule for Updating M.1457 to Revision 9

Document .38 was remanded to Subcommittees TR-45.3 and TR-45.5 to take action as appropriate. TR-45.5 and TR-45.3 were asked to reply to C.Langtry, SG5 Counsellor, to acknowledge the schedule for updating M.1457 to Revision 9. P.Bogard of TIA was asked to ensure that TIA is familiar with the schedule for updating M.1457 to Revision 9.

#### c. Submission and evaluation process for IMT-Advanced

It was noted that the ITU-W WP5D Circular Letter (CL) would be sent to Member States, Sector Members and Associates of Study Group 5 and external organizations as an invitation to propose candidate radio interface technologies for IMT-Advanced within the next few weeks. And, that the deadline for IMT-Advanced submissions would most likely be 16:00 hours UTC, 7 calendar days prior to

the start of the 6<sup>th</sup> meeting of WP 5D in 2009. Furthermore, it was reported that Evaluation Groups would be requested to register with the ITU-R before the end of 2008.
