- 7. The meeting report of 8-9 December 2008 numbered TR45/09.03.04.02 was reviewed. A motion was made and passed with no objections to approve the report.
- 8. The following Subcommittee and Ad-Hoc Group reports were provided:
 - a. **TR-45.3 Subcommittee** P.Musgrove presented Document .03, the written report.
 - b. TR-45.4 Subcommittee G.Turnipseed provided Document .04 as the written report.
 - c. TR-45.5 Subcommittee O.Pearson provided Document .05 as the written report.
 - d. **TR-45.8 Subcommittee** B.Covell provided Document .06 with attachment .06a as the written report. TIA agreed to activate the TIA web page on SS7 Translation Type (TT) and Subsystem Numbers (SSN) once it has completed its work. TIA agreed to look into providing support for the use of WEBx on subcommittee conference calls.
 - e. Ad Hoc Authentication Group (AHAG) F.Quick provided Document .07 as the written report. TR-45 agreed with the AHAG recommendation to move forward by making an editorial change to the CCA document in the AHAG public folder, rather than to conduct a formal publication process.
 - **Recommendation to discontinue the AKA Join Control Agreement with 3GPP SA3** It was agreed without objection to discontinue the AKA Joint Control Agreement with 3GPP SA3. Consideration should be given to having a liaison relationship with SA3. Document .07a was carried-forward for review and approval at the next TR-45 in June 2009.
 - f. **AHG on Electronic Media Documentation** (**AHEM**) P.Nurse provided Document .08 as the written report. TR-45 will provide the AHEM scope and charter to TIA. TIA will post the AHEM scope and charter to the TIA website. The TR-45 Chair will provide the comprehensive list of electronic media needs to the TIA Technical Committee (TC) at the next TC meeting in March 2009.
 - g. AHG on ESN/UIM/MEID (EUMAG) G.Pellegrino provided Document .09 as the written report with attachment .09a. Document .16 was provided for information. It was noted that the GDA (Global Decimal Administrator) has made assignments from code 35 for multi-mode codes. Calls will be planned through the year between the GDA and GHA administrators to share and provide coordination regarding multi-mode allocation. A liaison will be established between the EUMAG and 3GPP2 TSG-S WG1 to formally share information regarding EUMAG activities.
 - ESN Administration J.Derr provided a brief verbal report. ESN Exhaust (that is assignment of last virgin ESN code) occurred in November 2008. Four assignments have since been made from the exceptional code ranges (codes 127 and 221). A.Kurtzman (via telephone) provided a brief overview of the ESN-related lawsuit.

• MEID Administration – A.Dryden provided Document .11 as the written report.

b. Joint work with ATIS re: Enhanced Wireless 9-1-1 (J-STD-036)

B.Covell provided a brief verbal report. It was reported that the workplan for the development of the next revision of J-STD-036 has been drafted.
