- 7. The meeting report of 5-6 September 2007 numbered TR45/07.11.29.02 was reviewed. It was noted that "Vishny" was misspelled in the table of "Others Present". A motion was made and passed with no objections to approve the report as amended.
- 8. The following Subcommittee and Ad-Hoc Group reports were provided:
  - a. TR-45.2 Subcommittee L.Milton provided Document .05 as the written report with the TR-45.2 publication status listed in Document .05a. It was reported that TR-45.2 may have fewer face-to-face meetings and more conference call meetings in 2008 due to the integration of 3GPP2 MMD into 3GPP Common IMS. It was also noted that even though the backlog has been reduced, several TR-45.2 standards are still pending publication. Regarding the movement of work to other fora, it was noted that TR-45 will retain the responsibility to do the work that TR-45 needs to do within TR-45 in support of its membership. Regarding the anticipated movement of work to 3GPP, TR-45.2 was requested to craft an action plan by the end of January 2008 that includes what work and when the move is anticipated as well as any issues, benefits, impacts (such as regulatory, maintenance, potential for duplication of work, etc.). TR-45 will distribute to the TR-45 membership (via email) the TR-45.2 action plan for a one week review for approval then forward the action plan to TIA for legal consideration. Documents .27, .28, and .33 were provided for information.
  - b. **TR-45.3 Subcommittee** P.Musgrove provided Document .06 as the written report. It was reported that work is ongoing to provide an update to ITU-R WP5D on TDMA-SC in Recommendation M.1457-8.
  - c. **TR-45.4 Subcommittee** G.Turnipseed provided Document .07 as the written report. TR-45.4 plans to apply the new TIA Advisory Note regarding "Referencing Drafts Documents in TIA Standards" to TIA-1134 during approval for publication at its December 2007 meeting.
  - d. TR-45.5 Subcommittee O.Pearson provided Document .08 as the written report. Regarding the ITU-R WP8F Liaison Statement (LS) on the Evaluation for IMT.Advanced, TR-45.5 plans to complete its review at its December 2007 meeting. If TR-45.5 has comments on the LS, the comments will be forwarded to TR-45 for consideration for approval. TR-45 will consider the comments for approval at an interim Committee TR-45 meeting in January 2008.

- e. **TR-45.6 Subcommittee** B.Hirschman provided Document .09 as the written report. Regarding the study of WiMAX Lawful Intercept work in TIA, it was reported that TR-45.6 deemed work on WiMAX LI only not appropriate at this time. It was noted that when issues of WiMAX interworking with cdma2000® technology are proposed for work items, then those proposals would be reviewed on a case-by-case basis.
- f. **Ad Hoc Authentication Group (AHAG)** F.Quick provided Document .10 as the written report with attachments .a, .b, and .cR1. Documents .18, .19, and .30 were provided for information.

TR-45 will consider the need for a default or re-ballot of PN-3-0095-RV1, if needed, via email, conference call, or an interim meeting. The TR-45 March 2008 agenda will include a recommendation for publication of PN-3-0095-RV1 as TIA-946-A.

The Editor will revise the publication version of TIA-1098, incorporating the changes to address the TIA legal comments, and send the revised version to P.Bogard of TIA for publication. Similar action will be taken relative to TIA-1097 and to TIA-1091, if indeed the changes to address the TIA Legal comments are similarly editorial in nature only.

PN-3-0237-RV1 in Document .10a, as amended to update the reference to ATIS 29.109 with the corresponding ETSI publication, was approved for a 30-day ballot. The AHAG Chair will initiate the 30-day ballot of PN-3-0237-RV1.

TR-45 approved attaining the PN-3-0238-RV1 with no objections. PN-3-0238-RV1 in Document .10b, as amended to update the reference to ATIS 29.109 with the corresponding ETSI publication, was approved for a 30-day ballot. The AHAG Chair will initiate the 30-day ballot of PN-3-0238-RV1. TR-45 will request that 3GPP2 TSG-S extend the V&V period for one month until 15 February 2008.

TR-45 approved attaining a PN that corresponds to 3GPP2 TSG-S S.P0127 regarding "IMS Security for 2G R-UIMs" with no objections. There were no objections to the proposed TR-45 correspondence in Document .10cR1 to TSG-S requesting that further work be done on S.P0127 prior to TIA ballot. TR-45 will request that 3GPP2 TSG-S extend the V&V period for S.P0127.

- g. **AHG on Electronic Media Documentation (AHEM)** On behalf of P.Nurse, C.Blum presented Document 14, the written report.
- h. **AHG on ESN/UIM/MEID (EUMAG)** G.Pellegrino provided Document .11 as the written report with attachments .11a through .11e. Attention was drawn to the ESN Exhaust whitepaper developed under the auspices of the TIA Wireless Communications Division (WCD) in September 2007 as well as the meeting held on 16 November 2007 between TIA, TR-45 Chair, EUMAG, and the FCC Wireless Bureau to brief the commission on the state of ESN/UIMID exhaust and MEID/EUIMID implementation. It was noted that the FCC reception was positive. On behalf of the CDG, D.Crowe presented Document .37, regarding MEID industry implementation initiatives undertaken by the CDG MEID and EUIMID Task Force. Documents .23, .26, and .31 were provided for information.
  - **ESN Administration** J.Derr provided Document .12 as the written report.
  - **MEID Administration** On behalf of A.Dryden, G. Pellegrino presented Document .13, the written report.
- i. **J-STD-025-B Series Report** There was nothing to report at this time.
- OID Administrators Report There was nothing to report at this time. The Administrator position remains vacant.
- k. AHG on Wireless Alerts There were no updates to report at this time.

The Committee recessed at 5:00 PM Local Time on Thursday, November 29, 2007 and re-convened at 9:15 AM Local Time on Thursday, September 6, 2007.

9. Relative to old business, the following items were addressed:

#### a. Referencing Internet Drafts in TIA Standards – TIA Advisory

Document .29 that contains the TIA Advisory on referencing draft documents in TIA Standards was remanded to all Subcommittees and Ad-Hoc Groups of TR-45 to implement immediately. TR-45 adopts the policy as contained in Document .29. The policy is effective immediately. Documents .17, .24, .25, and .36 were provided for information.

#### b. TIA Publication of 3GPP2 Specifications

TIA will provide written guidelines to the TR-45 Subcommittees and Ad-Hoc Group (AHG) Chairs before end-of-year 2007 on the process and procedures for TIA publication of 3GPP2 specifications. All Subcommittees and AHG were instructed that the process is effective immediately.

#### c. Joint Work on Interference and Co-Existence

Documents TR45/07.03.07.33 and TR45/07.06.06.23 were provided for information. It was reported that TIA endorsed the joint work with ATIS on interference and co-existence. Subcommittees TR-45.3 and TR-45.5 will work with ATIS WTSC 3G3RA on the joint work on interference and co-existence. Document .38 was provided for information.

#### d. Voting Pool for TIA Ballots – Status

TIA noted that the plans to "scrub" the voting pools for TIA ballots as outlined at the TR-45 meeting in September 2007 are being implemented. It was reported that a redesigned TIA website will be revealed in January 2008.

### e. Readout of FCC CMSAAC Activities

C.Blum gave a brief readout on the activities of the FCC CMSAAC. It was noted that the CMAS recommendations were approved and that the CMSAAC has been disbanded. Documents .21 and .22 were made available for information to the membership of TR-45 on the password protected TIA ftpsite.

#### f. ITU-T SG2 Liaison Statement on Cell Broadcast

Documents TR45/07.09.05.21, .20 and .20a were provided for information. Documents .20 and .20a were remanded to the TR-45 Ad-Hoc Group on Wireless Alerts for review to determine if there is any input from TR-45 to SG2 by the May 2007 timeframe.

# g. ITU-R WP8A Handbook on Deployment of BWA Systems

Documents TR45/07.09.05.27, .33, .15, and .15a were provided. A motion was made to adopt the contents of Document TR45/07.11.29.15aR1 to go forward from TR-45 to ITU-R SG-8 in response to the WP8A LS on the Handbook on Deployment of BWA Systems. The motion was made by Alltel and seconded by Sprint. The motion passed with seven "yes" votes, one "no" vote, and four "abstain" votes. TR-45 will send the contents of Document .15aR1 to the ITU-R SG8 in response to the WP8A LS on the Handbook on Deployment of BWA Systems.

# h. cdma2000 for Public Safety in U.S. Band Plan for 700 MHz Band

Document TR45/07.09.05.28 was provided for information. It was reported that work is ongoing in Subcommittee TR-45.5.

# i. ITU-R WP8F Minimum Performance Requirement and Evaluation Guidelines for IMT-Advance Document TR45/07.09.05.32 was provided for information. TR-45.3 had no comments. TR-45.5 indicated that work was ongoing and that input would be provided after the Subcommittee meeting in December 2007 or January 2008.

#### j. Lawful Intercept for WiMAX

TR-45.6 recommended that TR-45 not pursue work on Lawful Intercept for WiMAX only.

#### k. TIA Legal Review of 3GPP2 Documents

TR-45 will forward the correspondence in Document .34 regarding TIA legal review of 3GPP2 documents to E.Mikoski, TIA Vice-President of Standards and Business Development, with a copy-to S.Montgomery, TIA Director of Standards and Technology. TIA agreed to provide a respond to the 3GPP2 correspondence in Document .34. TIA indicated that efforts were underway to address these issues and to develop measures to determine where additional TIA resources are needed.

10. Relative to new business, the following items were addressed:

#### a. Commercial Mobile Alerts Service (CMAS) Joint Standards Work

It was re-iterated that TIA and TR-45 endorsed the joint work with ATIS on Commercial Mobile Alerts Service (CMAS.) Document .03 was remanded to TR-45.2 and TR-45.5 to take action as appropriate relative to CMAS. TR-45.2 will be the point-of-contact for TIA TR-45 on the joint activity with ATIS WTSC G3GSN. Plus TR-45.2 will coordinate with TR-45.6 on CMAS, as needed. TR-45.5 was directed to address any changes required to cdma2000® standards relative to CMAS and coordinate with TR-45.4 on CMAS, as needed. Document .38 was provided for information.

#### b. Upcoming Subcommittee Leadership Elections

Subcommittee TR-45.4 shall hold elections for Chair in January 2008 and Vice-Chair in February 2008.

#### c. Other

Concerns were raised regarding placement of TR-45.2 and TR-45.6 documents on the 3GPP2 local meeting file server. It was suggested that the TR-45 Subcommittees place their documents on the TIA ftpsite during and/or after each meeting. It was requested that TIA Staff transfer the Subcommittee documents onto the TIA ftpsite to archive. The Subcommittees were requested to review their procedures for placing and/or archiving Subcommittee documents on local file servers versus the TIA ftpsite and to provide feedback to TR-45 to share with TIA staff.
