- 6. The meeting report of June 5-6, 2002 numbered TR45/02.09.04.02 was reviewed. A motion was made and passed with no objections to approve the meeting report with the following modification:
  - Delete one of the duplicate entries of the "Federal Bureau of Investigation (CIS)" in page 1, Quorum List, Members Absent.
- 7. In terms of correspondence, the following item was addressed:
  - **Document .03** This correspondence was provided for information.
- 8. The following Subcommittee and Ad-Hoc Group reports were provided:
  - a. **TR45.1 Subcommittee** J. Kay provided Document .04 as the written report. TR45.1 recommended that TSB-39-A be re-affirmed with proposed modifications. It was reported that ballot text was planned for October 2002 for the revision of TSB-121.
  - b. TR45.2 Subcommittee TR45 affirmed that C.Ishman was elected Chair of TR45.2 by acclamation at the August 2002 meeting of TR45.2. C.Ishman provided Document .05 as the written report. TR45.2 requested that TIA work with 3GPP2 to agree upon a set of headers and footers for documents produced as both TIA ballots/publications and 3GPP2 specifications. It was agreed that TR45.2, TIA, and 3GPP2 would work this style issue outside of the TR45 meeting. Documents .23, .29, and .30 were provided for information.
  - c. **TR45.3 Subcommittee** P.Nurse provided Document .06 as the written report. Regarding the TR45.3 workplan, it was noted that the MEID-related standards would be published initially as a separate document and incorporated into the TIA/EIA ANS-136 series of standards at a later date.

- d. **TR45.4 Subcommittee** D.Baldwin provided Document .07 as the written report. It was reported that the new release date for PN-4545 RV3 would be in 4Q02.
- e. **TR45.5 Subcommittee** J.Alphonse provided Document .08 as the written report. TR45.5 indicated that it was on target to meet the requirements for submission to ITU-R WP8F for revision 3 of M.1457 by the September 18, 2002 milestone.
- f. **TR45.6 Subcommittee** E.Campbell provided Document .09 as the written report. It was reported that the schedule for completion of IS-835-B was impacted by its re-ballot.
- g. **Ad Hoc Authentication Group (AHAG)** C.Carroll provided Document .10 as the written report. It was noted that item 5 on page 2 was in support of IS-683C and that the December 2 meeting hotel was the Biltmore. TR45.5 was directed to review the AHAG endorsed TR45.3 approach for the derivation of an ESN from a MEID and provide comments to the AHAG, TR45, and the Subcommittees (except TR45.6) no later than September 16, 2002.
- h. **AHG on Electronic Media Documentation** There was no report. S.Hoyler graciously agreed to assume the role of Chair of the AHG on Electronic Media Documentation.
- i. **AHG on UIM/ESN** There was no written report. C.Carroll assumed the role of Chair of the AHG on UIM/ESN. Document .26 was provided for information. It was noted that TIA endorsed modifications to the UIM Administrator's Guidelines to incorporate UIM contact information and annual recurring fee.
  - ESN Administration T.Caldwell provided Document .12 as the written report. 3Q05 was reported as the anticipated ESN exhaust timeframe. Concern was raised about the impact to ESN exhaust as a result of the manufacture of disposable mobile telephones. It was agreed that the recommended changes to the ESN Administrator's Guidelines provided in Document .27 would be addressed during a conference call meeting to be convened by TIA.
- j. AHG on LAES On behalf of T.Brooks, G.Pellegrino provided Document .13 as the written report. Attachments to Document .13, numbered .13a, .13b, and .13c, were provided with supporting information. The LAES J-STD-025 Rev A (PN-4464) in Document .13c was approved for a 60-day default ballot with no objections. TR45 to work with the Editor and TIA to submit PN-4464 for a de-fault ballot. In addition, it was agreed without objection that the correspondence related to the LAES J-STD-025-A in Document .13bR1 be sent to Committee T1 as amended.
- k. **TR45 Standards Development Program Report** S.Jones provided Document .14 as an updated version of the TR45 Program Management Report. It was noted that the 3GPP2 nomenclature had been removed. Document .14 was remanded to the Subcommittees for review and to provide updates directly to S.Jones. In addition, S.Jones agreed to provide the Feature Capabilities Description document to the Subcommittees to also review and provide updates directly to S.Jones.

The Committee recessed for lunch at 12:15 PM and reconvened at 1:40 PM.

- 9. Regarding the continuation of old business, the following items were addressed:
  - a. **Proposed FCC Rules Changes for ESN** Documents .37 and TR45/02.06.05.38 were provided for information. It was noted that the FCC issued a Press Release on August 8, 2002 on the streamlining of Part 22 of the FCC rules that eliminates analog service requirements after a five-year transition period and removes the manufacturing requirements governing electronic serial numbers (ESNs) in cellular telephones. It was recommended that TR45, as a courtesy, notify the FCC of the industries' intended actions relative to MEIDs and of the security and fraud recommendations provided by the AHAG. Regarding the proposed FCC rules changes for ESN provided in TR45/02.06.05.38, it was agreed that no action would be taken by TIA, pending FCC action. It was noted that depending on the FCC action, the draft TIA letter may not be needed or may need to be modified before going forward.

- b. **Standards Development Work for MEID -** Documents .31 and TR45/02.06.05.12 were provided for information. The Subcommittees indicated no anticipated deviations from the MEID recommendations and requirements in Document TR45/02.06.05.12.
- c. **MEID Administration** Document TR45/02.06.05.17 was referenced from the last TR45 meeting. It was re-iterated that TR45 endorsed TIA to serve in the role of MEID Administrator. Furthermore, it was agreed that TR45 would send correspondence to TIA to request that TIA serve in the role of MEID Global Hexadecimal Administrator (GHA) in a manner similar to the UIM Administrator with a copyto the JEM for Equipment Identifiers invitees. In addition, it was suggested that the AHAG security and fraud recommendations as well as the proposed language in the TIA letter to the FCC be shared with the 3GPP2 SC to corporation in the MEID Administrator's Guidelines.
- d. Ballot of TSB-39-A Documents .04 and .28 were provided for information for consideration. Document .20, the proposed ballot version of TSB-39-A, was provided for review. TSB-39-A was approved as amended for a 30-day ballot with no objections. TR45 to work with the Editor and forward TSB-39-A as amended to TIA to issue the ballot. The ballot version was made available in Document .22R1.
- e. **Draft ITU-T Recommandation Q.1742.1** Documents .24 and TR45/02.06.05.37 were provided for information. TR45.6 and the AHAG provided comments on the draft ITU-T Recommandation Q.1742.1 in Documents .24 and .10, respectively. TR45 to consolidate and forward the TR45.6 and AHAG comments related to the draft ITU-T Recommandation Q.1742.1 to the SSG. TIA to provide document numbers for the three AHAG cryptographic documents. And, the AHAG to provide draft text to TR45 that includes the URL addresses to the AHAG documents.
- f. Workplan and Milestones for ITU-R WP8F M.1457 Updates Documents .06 and .08 were provided for information for consideration. Both TR45.3 and TR45.5 indicated that their workplans included the steps required to submit updates to the ITU-R WP8F relative to M.1457 in accordance with the TIA Engineering Manual.
- g. **Summit on Signaling for VoIP** Documents .25R1 and .36 were provided for information. D.Thompson presented a brief overview of the TIA presentation to the Signaling for Voice Over IP (VoIP) Summit held August 12-14, 2002 in Washington, DC. It was noted that security was an area of high interest during the Summit.
- h. **Other** There was no other old business.
- 10. Relative to new business, the following items were addressed:
  - a. **TR45 GTSC/GRSC** (**formerly GSC/RAST**) **Meeting Preparation** Documents .32 and .11 were referenced for discussion purposes. D.Bart provided an overview of the outcome from the GSC7/RAST10 meetings that were held November 4-8, 2001 in Sydney, Australia. The Subcommittees were encouraged to identify topics and generate presentations for the next GSC-11 meeting scheduled for April 27 through May 1, 2003 at the Crowne Plaza Hotel in Ottawa, Canada. Attention was drawn to page 4 of Document .11 that lists topics that would be addressed at the GSC-11 meeting.
  - b. **CIS Report -** There was no report.
  - c. **TIA Emergency Network Security-related Work Activities** Document .35 was remanded to the Subcommittees and the AHAG to review and provide updates on any activities related to Emergency Network Security to D.Thompson of TIA and copyto the TR45 Secretary by September 17, 2002.
  - d. **Other** There was no other new business.

The Committee recessed for a break at 3:15 PM and reconvened at 3:35 PM.

- 11. In terms of Liaisons, the following was reported:
  - a. CTIA R.Kemper provided Document .15 as the written report. Attention was drawn to three wireless Network Security programs being addressed by CTIA that would be of interest to TR45. The programs noted were the National Security Telecommunication Advisory Committee (NSTAC), the National Infrastructure Protection Center (NIPC), and the CTIA hosted Homeland Security Critical Issues Forum scheduled for November 14-15, 2002 in Washington, DC. TR45 was encouraged to join in these efforts.
  - b. **T1P1** There was no report.
  - c. **ITU-T** D.Thompson provided Document .16R1 as the written report. ITU-T activities in SGs 2, 11, and SSG of potential interest to TR45 were presented.
  - d. **ITU-R** On behalf of M.Epstein, C.Blum presented the written report in Document .17 for information.
  - e. **CITEL**, **CCT** On behalf of G.Gardner, C.Blum presented the written report in Document .18 for information.
  - f. Wireless Communications Division (WCD) -
    - Regulatory and Policy Issues B.Belt provided Document .38 as the written report. Recent FCC filings and rulings of interest to TR45 as well as other recent WCD activities were presented. The next TIA WCD meeting was scheduled for December 2002 in Los Angeles, CA following the TR45 meeting.
    - **Technical Regulatory Issues Committee (TRIC)** B.Belt provided Document .39 as the written report. It was reported that an election of a new TRIC Chair would be held at the next TRIC meeting in September 2002 in Columbia, MD.
  - g. TIA S.Hoyler provided Document .11 as the written report. Topics highlighted were the application of the canvass method to ANSI, the status of the IPR Working Group output, the ballot of the TIA Style Manual, plans for the TIA Engineering Manual Ad Hoc Group, the Legal Summit scheduled for October 2002 in Washington, DC, and reductions to TIA standards staff. All were encouraged to review Document .11 for further information on these and other topics. Regarding the TIA TC meeting scheduled for Thursday, September 5, 2002, it was agreed that TR45 would report on the concerns expressed during the TR45 meeting relative to security and interworking with W-LANs.
  - h. 3GPP2 Document .19R1 was provided as the written report by S.Dennett. A summary and highlights of recent 3GPP2 activities were presented. It was noted that 3GPP2 encourages TIA to take the role of the Equipment Identifier Hexadecimal Administrator. In TSG-S work continues on the Equipment Identifier Administration Guidelines document. Attention was drawn to the fact that 3GPP2 would be seeking new leadership for the SC and TSGs for 2003. The output report of the 3GPP2 Vision JEM held in San Diego, CA on July 23-13, 2002 was provided.
  - i. 3GPP P.Musgrove provided a brief verbal report. It was reported that the Release 5 specifications were approved at the SA meeting in June 2002. It was noted that at the SA meeting the week of September 9 that the Future Evolution Ad-Hoc Group planned to finalize its Terms-of-Reference. Regarding the Harmonization Workshop and Recommendations, it was reported that SA took the position that IP-related work should be coordinated, that guest status should be extended, that attempts be made to avoid conflicting meeting dates, and that subscriptions to relevant e-mail lists be encouraged.
  - j. **ATIS** On behalf of E.Hall, C.Blum presented the written report in Document .21 for information. It was noted that ATIS and Committee T1 were preparing a report on the Signaling for VoIP Summit findings.

- 12. In review of assignments, the assignments were incorporated in the meeting report above.
- 13. Review Meeting Schedules
  - a. **TR45 2002 Schedule** Document .33 was provided for information.
  - b. TR45 2003 Schedule Document .34R1 was provided for information
  - c. **Subcommittees and AHG 2002 and 2003 Schedules** Documents .04, .05, .06, .07, .08, and .09 were provided for information.
- 14. Open Discussion

The disposition of Documents .22R1 and .13bR1 were discussed as reported under agenda items 9d and 8j, respectively.
