- 7. The meeting report of 4-5 June 2008 numbered TR45/08.06.04.02 was reviewed. A motion was made and passed with no objections to approve the report. The meeting report of 17 July 2008 numbered TR45/08.06.04.03 was reviewed. A motion was made and passed with no objections to approve the report. The meeting report of 01 August 2008 numbered TR45/08.06.04.04 was reviewed. A motion was made and passed with no objections to approve the report.
- 8. The following Subcommittee and Ad-Hoc Group reports were provided:
  - a. **TR-45.3 Subcommittee** P.Musgrove presented Document .06, the written report. It was reported that TR-45.3 has been focused on the RSPC updates working jointly with ATIS WTSC. Attention was drawn to the balloting of ANSI TIA/EIA-136-G documents by TR45.3 that were initiated on July 24, 2008 in order to meet the October 31, 2008 deadline to ITU-R.
  - b. **TR-45.4 Subcommittee** G.Turnipseed provided Document .07 as the written report. Document .30 was presented regarding the TIA ballot voting membership list. TIA indicated that starting with TR-45.8 a new process will be implemented such that "*If a member has missed voting on 3 consecutive ballots, they will be automatically dropped from the ballot voting list for that committee. Reinstatement will be made when the member then reselects their voting intentions on the TIA ballot website"* TR-45 plans to provide this italic text for consideration for adoption to the 5<sup>th</sup> Edition of the TIA Engineering Manual. Furthermore, TR-45 plans to provide a respond to the TR-45.4 correspondence in Document .30.
  - c. **TR-45.5 Subcommittee** O.Pearson provided Document .08 as the written report. Attachments .08a through .08d were provided for information. Particular attention was drawn to the list of TR-45 remanded items and subsequent actions taken by TR-45.5 as well as to the TR-45.5 submissions to ITU-R in Section 2 and the work on CMAS in Section 7.
  - d. TR-45.8 Subcommittee B.Hirschman provided Document .09r1 as the written report. TR-45.8 (B.Hirschman, convener) will work with TIA (S.Montgomery) to ensure that the disclaimer language from TIA legal is included on the TIA web page on SS7 Translation Type (TT) and Subsystem Numbers (SSN). Prior to the implementation of the web page, TR-45 will notify ATIS PTSC. TR-45.8 was encouraged to keep the SS7 Translation Type (TT) and Subsystem Numbers (SSN) web site on the TR-45.8 meeting agenda and determine if there are any potential impacts to the TR-45.8 scope and charter. It was reported that the election of Chair and Vice-Chair of TR-45.8 will be conducted at the 2 October 2008 meeting of Subcommittee TR-45.8. Document .16, a letter of nomination for TR-45.8 Chair, was provided for information. TR-45 expressed its appreciation to the former TR-45.2 and TR-45.6 leadership and indicated plans to have TIA provide plaques of recognition. Documents .24, .25, .26, .27, .28, .29, and .32 were provided for information. TIA agreed to provide a list of all former TR-45.2 and TR-45.8.
  - e. Ad Hoc Authentication Group (AHAG) F.Quick provided Document .10 as the written report. The AHAG noted its intention to set up a joint meeting with 3GPP SA3 in the near future to review the AKA joint control agreement.
  - f. AHG on Electronic Media Documentation (AHEM) P.Nurse provided Document 14 as the written report. It was noted that the TIA webmaster and staff have addressed the Engineering Committees' requested work items including the TR-45 work items relative to electronic sign-in and calendar. However, due to the needed TIA security and core IT updates the Engineering Committees' work items will remain dormant and be reopened again in seven months.

The Committee recessed for a break at 2:40 PM and reconvened at 3:05 PM.

- g. AHG on ESN/UIM/MEID (EUMAG) G.Pellegrino provided Document .11 as the written report with attachment .11a. The EUMAG Chair took an action item to request that TIA place a "new item" flag next to the ESN Guidelines v2.0 on the website to highlight the December 31, 2009 date. The EUMAG Chair agreed to provide suggested text to accompany the flag.
  - ESN Administration There was no report.
  - MEID Administration Document .13 was provided as the written report.
- h. J-STD-025 Series Report It was noted that J-STD-025-B is up for reaffirmation by EOY 2008. TR-45 will work with TIA to seek an extension of the shelf-life of J-STD-025-B prior to seeking reaffirmation. An agenda item regarding the extension or reaffirmation of J-STD-025-B will be carriedforward to the next TR-45 meeting in December 2008. If reaffirmation is ultimately required, TR-45 will contact ATIS to coordinate the reaffirmation balloting of J-STD-025-B.
- i. **OID Administrators Report** The Administrator position remains vacant. TIA was asked to identify the OID Administrator. TR-45 will contact the former OID Administrator (H. Cuschieri) for a copy of the current version of the OID Administration Guidelines and have the Guidelines posted in the "numbering area" of the TIA website.
- 9. Relative to old business, the following items were addressed:
  - a. Ballot of PN-3-0335 "cdma2000 Network Performance Measurement Types"

Agenda items 9a and 9b were addressed simultaneously. Documents .18 and .19 were provided for information. All were encouraged to vote on the TR-45 ballots of PN-3-0335 and PN-3-0336. An agenda item will be added to the next TR-45 meeting in December 2008 to recommend the publication of the standards for "cdma2000 Network Performance Measurement Types" and "OAM&P for cdma2000."

- b. **TIA Ballot of PN-3-0336 "OAM&P for cdma2000"** (See agenda item 9a above.)
- c. GSC-13 Closing Plenary Summary

Document TR45/08.09.03.22 was provided for information. It was noted that GSC-14 will be hosted by ITU in Geneva 13-16 July 2009.

d. Joint CMAS Standards Development

The proposed deliverables and work schedule for the CMAS standards development was provided in Document .35r1 by P.Musgrove. Plus in Document .08, TR-45.5 reported that TR-45.5 created an Ad-Hoc Group on CMAS that created a new document for the air interface to handle CMAS as well as added Services Categories to TSB-58 to support CMAS. Furthermore, it was reported that TIA-1149-0, Commercial Mobile Alert Services (CMAS) Over CDMA was approved for a 30-day Ballot during the August 2008 TR-45.5 closing plenary.

10. Relative to new business, the following items were addressed:

#### a. IMT-Advanced Submissions and Evaluation Process

Document .17 regarding IMT-Advanced submissions and evaluation process was remanded to TR-45.3 and TR-45.5 to take action as appropriate. There was general agreement that TR-45 should register as an Evaluation Group with the ITU relative to IMT-Advanced and there were no objections. TR-45 will take the necessary steps to register with the ITU as an Evaluation Group for IMT-Advanced. TR-45 will revisit how to move forward as an Evaluation Group at the next TR-45 meeting in December 2008. It was noted that the TR-45 decision to register as an Evaluation Group is independent of a TR-45 decision to submit an RIT submission.

b. ITU-R WP5D LS re: Request for Parameters of IMT RITs

Document .20 was provided for information to TR-45. TR-45.5 indicated their intent to respond directly to the WP5D request for parameters of IMT RITs. TR-45.3 indicated their plans to discuss with ATIS WTSC RAN to determine whether or not TR-45.3 will respond jointly with ATIS WTSC RAN or independently or not at all.

#### c. Portable Electronic Devices (PED) for Use Onboard Aircraft

Document .34 was provided for information. D.Bart of TIA provided a verbal overview of the issues related to use of PED onboard aircraft. TR-45 requested additional information from the TIA Wireless Communication Division (WCD) regarding next steps once the recommendations Document .34 are provided to RTCA. Also, TR-45 would like an opportunity to review the PED recommendations once available, and prior to completion.

# d. Input to ITU-T SG-19 Recommendation Q.1742-7

Document TR45/08.09.03.31 was provided for information.

#### e. Marketing TIA Standards

Document TR45/08.09.03.33 was presented by T.Walsh, TIA Vice-President Marketing and Business Development.

  - h. **3GPP** P.Musgrove provided a brief verbal report.
  - i. ATIS There was no report.
  - j. **IFAST** E.Hall presented Document .15 as the written report. The highlights noted were the end of the ATIS initiated law suit, the IFAST annual Global General Meeting, and US Cellular SID Management.
