David Aylward presented an outline of the general approach developed over several years by COMCARE to delivering consumer telematics data. The issue is whether this approach will work for other incident or sensor types. To cover the near-term situation that most emergency agencies do not have interfaces to XML standards, an "emergency incident website" could be developed to display a wide variety of incident data. **Peter Nurse** mentioned *Netvibes* that uses widgets as a distribution method, and **Dan Bart** later referred to *Trapster* as another example, and forwarded Mark Kirstein's Multimedia Intelligence Brief on "CTIA 2008 – The Mobile Industry Responds to the iPhone – Touch Screen Phones to Ship 178 Million Units by 2011."

Tom Kurihara took an action item to create and submit a TIA Vehicular Telematics Standard Project for "Emergency Information Delivery Protocol." Tom later forwarded information about the April 25 seminar¹ on "Supporting Universal Business with Open Standards" related to the use of Web Services and the OASIS Universal Business Language (UBL), and the May 21-23 Data Warehouse Conference² related to the use of data warehousing framework and identifying the data or message contexts for pushing and pulling data.

Dan Bart forwarded the draft meeting report of the ANSI-HSSP Workshop on Credentialing and Access Control (CAC) for Disaster Management on January 30-31, 2008, and a CAC Workshop contribution to the NIMS Credentialing Standards Working Group. The next CAC Workshop will be held on May 19, 2008 at Executive Conference Center in Arlington, VA.

Axel Moering, BMW Senior Engineering Project Manager for NGTP, provided an overview of the NGTP that offers a flexible solution with an open interface between the telematics delivery chain components – telematics communications units (TCUs), telematics service providers (TSPs), call centers, and content providers – and a technology-neutral "dispatcher" to communicate between the TCU and TSPs. NGTP is also compatible with existing protocols such as Global Telematics Protocol (GTP)³ that consolidated Application Communication Protocol (ACP) and Global Automotive Telematics Standard (GATS). The next NGTP teleconference will be held on Wednesday, May 28 from 10:00 AM to 11:00 PM EDT. Kevin Lu will email a reminder before the teleconference.

Tom Kurihara provided a summary of his April 2, 2008 report of the ISO TC204 WG17 (Nomadic and Portable Devices for ITS Services) meeting on March 12, 2008 in Jeju Island, Korea. ISO/TC204 has subsequently appointed **Young Jun Moon** of the Korea Transport Institute (KOTI) as Convener of WG17 as of April 18, 2007. The next WG17 meeting will be held on November 10-12, 2008 in Ottawa, ON.
