#### **1.0 ADMINISTRATIVE**

1.1 Call to Order and Welcome

The meeting was called to order at 10:20 a.m. on Wednesday, August 18, 2010, by Mr. Fred Lucas, TR-30.2 Chair. The meeting was held at TIA Headquarters, Arlington, VA. Mr. Lucas announced that a quorum was present. The Chair reported that the April 2010 meeting had been canceled.

1.2 Agenda

The agenda for the meeting (TR-30.2/10-08-003) was accepted.

1.3 Meeting Reports

The Meeting Report of the December 9, 2009 meeting (TR-30.2/10-04-002) was reviewed and approved.

1.4 Meeting Schedule

The Chair announced that the final meeting for 2010 would be December 18, 2010 at TIA Headquarters, Arlington, VA

1.5 Intellectual Property

The Chair encouraged anyone who was aware of IP that relates to the work of TR-30.2 to make the appropriate statements as early as possible in the process. The Chair directed the members to the TIA Engineering Manual, located on the TIA web site (www.tiaonline.org), for the specific requirements. The Chair indicated that this also applies to Normative References within draft standards. There were no statements submitted at this meeting.

1.6 International Meetings

The Chair indicated that the meeting of ITU-T Study Group 16 was held July 19 - 30, 2010 in Geneva, Switzerland. The next Study Group 16 meeting is scheduled for 14 - 25 March 2011. The Chair indicated that the December 2010 meeting would probably be the last chance for approving contributions to the March 2011 Study Group 16 meeting.

## 2.0 DISCUSSION

2.1 Status of SP-3-3499-RV2 Revision

The Chair indicated that, as editor of TIA-678-A, *Data Transmission Systems* and Equipment - Serial Asynchronous Automatic Dialing and Control for Character Mode DCE on Wireless Data Services (SP-3-3499-RV2), he had posted the first draft of the revised Standard (TR-30.2/10-08-004) to the ftp site. He thanked Mr. Schulz for providing additional editorial corrections and the revised draft is in document TR-30.2/10-08-004R1. The committee reviewed the draft and approved it for ballot.

2.2 ITU-T V.254, AT Commands for Assistive and Mobile Devices (V.amat)

Mr. Chu reported on the work at SG16 relating to new Recommendation ITU-T V.154, Asynchronous serial command interface for assistive and multifunctional communication devices. Document TR-30.2/10-08-005, Copy of Q14 SG16 Draft Meeting Report from July 2010, provided details of the Study Group 16 work on the new Recommendation. In addition, a copy the draft of V.154, TR-30.2/10-08-006, was provided. Mr Chu reported the draft Recommendation was sent for consent at the Study Group 16 Plenary meeting in July 2010.

## 3.0 Other Business

The Chair report that discussions are taking place in the TIA Emerging Technologies Sub-Committee that could possibly come to TR-30.2 as a new work item.

# 4.0 Adjournment

The Chair thanked TIA for providing the facilities for the meeting. The meeting was adjourned at 10:46 a.m.
