2.1 Review of Standards Needing Attention

The Chair indicated that he had sent an email to TR-30.2 on December 3, 2013, which announced that there are two documents which require action by TR-30.2.

ANSI/TIA-422-B, *Electrical Characteristics of Balanced Voltage Digital Interface Circuits*. The Chair recommended that, since TIA-423 had been changed to a TIA only Standard, it would be appropriate that TR-30.2 make the same change to ANSI/TIA-422-B. Since no quorum was present no action was taken on this recommendation.

TSB-54-B, *DTE/DCE Interface Selection Guide*. The Chair indicated that this document is very out of date and questioned if in today's world there remains a need for this Guide. Since no quorum was present no action was taken on TSB-54-B.

The Chair indicated that action on ANSI/TIA-422-B and TSB-54-B will be taken at the next meet and he will continue to monitor other Standards which may require action by TR-30.2.
