- TR30.3 will be attending the June SG12 Question 13 meeting by Teleconference.
- TR30.3 plan to continue their work on ANSI/TIA-921C Network Model for Evaluating Multimedia Transmission Performance Over the Internet Protocol. This work would most likely be associated with wireless access.
