6. Correspondence and Liaisons

Tony Noerpel (Chair) reported on ETSI activities. TIA TR-34 has a liaison with ETSI SES MARESV to review and comment on technical reports regarding antenna performance characterization for GSO and NGSO mobile applications. TIA TR-34 has a liaison with ETSI SES SCN to review and comment on technical reports regarding receiver requirements. The Chair reported on new proposed receiver requirements for GNSS receivers in ETSI and ETSI SCN liaison with 3GPP activities regards 5G evolution with respect to a satellite specific waveform addressing round trip time and other satellite characteristics.

DVB is issuing a call for technologies for future satellite standards. Only a draft of this document currently exists.

7. Ballot Results

The ANSI/TIA-5041 FUTURE ADVANCED SATCOM TECHNOLOGIES (FAST) OPEN STANDARD DIGITAL–IF INTERFACE (OSDI) FOR SATCOM SYSTEMS ballot was approved. The Chair discussed the ANSI rules associated with the approved ballot and publication of the standard.

Herald Beljour made a motion seconded by Raghu Janardhan to approve publication of the ANSI/TIA-5041 FUTURE ADVANCED SATCOM TECHNOLOGIES (FAST) OPEN STANDARD DIGITAL–IF INTERFACE (OSDI) FOR SATCOM SYSTEMS standard. The motion passed unanimously.

8. Working Group Activities

Comments were solicited as part of our liaison with ETSI SES on the drafting of receiver standards for GNSS receivers.

9. New Business

The Chair requested members to consider new activities associated with GEO, LEO satellite standards and regulatory affairs, in particular ITU's Public Consultation on 2016-2019 Strategy in which TIA TR-34 might participate. Members should consider of high altitude platforms, spectrum sharing issues, new frequency bands such as Q, V and W bands and opportunities related to 5G standardization.

Vice Chairman Lars Erup has retired. Nominations are solicited. Herald Beljour nominated Jim Hand as a candidate for the open Vice Chair position. Hand is considering the nomination.
