Participants are encouraged to notify TIA of any patents of which they are aware that are related to the practice of a TIA publication early on in the development of the TIA document to reduce the possibility for delays in the development process and increase the likelihood that the draft TIA publication will be approved for publication. Patent searches are not required to comply with the TIA IPR policy. Moreover, the Engineering Manual describes the need for members' disclosure of patents that are essential to practice TIA publications and for members to provide an indication of their willingness to license any known patents.

Draft 0.1 of TIA-570-C (TR422-2010-09-010) has been posted to the TR-42.2 FTP site. Comments related to the restructuring of the document to align with TR-42 generic standards are requested. A deadline will be set for some time in November. An Editors Task Group was formed to review any comments received in December and to produce a first ballot draft for the

February meeting. The Editorial Task Group consists of Bob Jensen, Ray Emplit and Rich Jones. A "mock ballot" is anticipated to be released after the February meeting.

Paul Kish agreed to submit a contribution for the February meeting on modern architectures. Larger conductor sizes are anticipated to carry 100 watts of power to TV sets. Massod Shariff also agreed to update the applications tables. Ray Emplit will draft liaison letters for outreach to other standards development organizations.

Compressed files shall be accessible using PKUNZIP or WINZIP (\*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting. All contributions shall be posted to the appropriate location on the TIA FTP site no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).
