2.2.2 TR-42.6 – Telecommunications Infrastructure Administration

The Committee approved the project request for ANSI/TIA-606-B (TR42-2011-02-036) without objection.

2.2.3 TR-42.12 – Optical Fibers and Cables

Mike Kinard presented TR42-2011-02-047a. Kinard further reported that TR-42.12 would be meeting in June and that TIA-455-122-B was approved for publication because the sole negative vote to the adoption ballot was ruled not germane. A motion by Kinard to schedule the closing plenary meeting on Thursday night in June failed when it did not receive a second.

2.2.4 TR-42.1 – Commercial Building Cabling

Glenn Sexton presented TR42-2011-02-041.

A project request for ANSI/TIA-568-C.0-2 (TR42-2011-02-042) was approved after adding AN-SI/TIA-568-C.4 as a keyword. The revised PAR was posted after the meeting as document TR42-2011-02-042a)

A project request for ANSI/TIA-568-C.1-2 (TR42-2011-02-043) was approved without objection.

In response to a question from the floor, Sexton stated that it was intended that both documents be submitted for ANSI ballot as soon as possible.

In response to a request from TR-42.1, a Task Group was formed to study whether the generic TR-42 standards (e.g., ANSI/TIA-568-C.0 and proposed ANSI/TIA-569-C) should be considered base documents for the various premise standards or if, in addition, they are intended to be used when no premise standard exists. Of particular concern is whether items of infrastructure

which may not be universally applicable (e.g., MUTOA and consolidation point) should be included in the generic standards. The Task Group Chair is Bob Jensen and membership consists of all subcommittee chairs and others who may be interested.

2.2.5 TR-42.2 – Residential Telecommunications Infrastructure

Ray Emplit presented TR42-2011-02-031.

A project request for ANSI/TIA-570-C (TR42-2011-02-032) was approved without objection.

2.2.6 TR-42.3 – Commercial Building Telecommunication Pathways and Spaces

Ray Emplit presented TR42-2011-02-033.

2.2.7 TR-42.4 – Outside Plant Cabling

Jamie Silva presented TR42-2011-02-006.

The following motion was approved without objection: TR-42.4 to suspend operation until a new business item is assigned.

2.2.8 TR-42.7 – Telecommunications Copper Cabling Systems

Sterling Vaden presented TR42-2011-02-045. Vaden corrected the report verbally by stating that the ballots for TSB-190 and ANSI/TIA-1183 had already closed.

A motion to publish ANSI/TIA-568-C.4 was approved without objection.

A motion to publish TSB-190 was approved after an objection from the floor and a request for a roll call vote. The motion passed with the vote 10 for, 1 against, and 9 abstain.

A project request for ANSI/TIA-568-C.2-1 "Next Generation Cabling" (TR42-2011-02-044) was approved without objection.

Vaden called to the Committee's attention a contribution detailing a possible conflict between the TIA Engineering Manual and the TR-42 Operational Guidelines (TR42-2011-02-039). A Task Group was formed, chaired by Bob Jensen, to study the issue. Jensen requested that those interested in participating contact him after the meeting.

2.2.9 TR-42.9 – Industrial Telecommunications Infrastructure

Ray Emplit presented TR42-2011-02-037.

2.2.10 TR-42.11 – Optical Fiber Systems

Paul Kolesar presented TR42-2011-02-048.

A motion to approve a project request for ANSI/TIA-568-C.3-1 was amended to read, "Move to initiate project to produce ANSI/TIA-568-C.3-1 according to TR42-2011-02-040 and authorize SP ballot" and was passed without objection.
