1.5 Intellectual Property Rights (Early Disclosure Policy)

Participants are encouraged to notify TIA of any patents of which they are aware that are related to the practice of a TIA publication early on in the development of the TIA document to reduce the possibility for delays in the development process and increase the likelihood that the draft TIA publication will be approved for publication. Patent searches are not required to comply with the TIA IPR policy. Moreover, the Engineering Manual describes the need for members' disclosure of patents that are essential to practice TIA publications and for members to provide an indication of their willingness to license any known patents.

2.1 Action item review – Bob Jensen

There were no action items to review.

2.2 Liaison letters received – Bob Jensen

There were no liaison letters received.

2.3 TR-42.8 Scope Statement

Discussion was held on revising the scope of TR-42.8. Through discussions, a motion was made to send the recommendation to TR-42 to move the work and documents of TR-42.8 into TR-42.11 and disband the TR-42.8 subcommittee. The motion passed (12 For – 2 Opposed – 4 Abstain).

2.4 OM4 Standardization Activities – Paul Kolesar

Paul reported that the OM4 standard has been published by TIA as 492-AAAD. The IEC is in the ballot stage.

2.5 Polarity – Paul Kolesar

Paul Kolesar reported that there was no action taken since our last meeting. Paul will gather the Task Group on conference call to develop a scope.

Dave Hess reported on ISO/IEC 14763-2 and its incorporation of array polarity. ISO/IEC 11801 also includes polarity, but for two fiber systems. There was some discussion as to where the polarity topic should be held, but no strong recommendations were given.

2.6 Loss budgets – Bob Jensen

Bob Jensen reported that there was no action taken since our last meeting due to the holidays.

Richard Ednay presented information on connector loss from a thesis by Mike Gilmore. The thesis was about 4-5 years old and is believed to focus on ST and SC connectors. It provided a statistical treatment of optical fiber connection performance. The contribution may be used in the Task Group.

3 New Business

3.1 Other

3.1.1 Fiber optic topics in the 568-C series standards

Several topics have been raised to include in addenda to the 568-C.3 series. The intent of bringing these to this Subcommittee is that the work would likely be held in this Subcommittee, but reporting support for these topics to TR-42.1 would be helpful. The topics raised so far include:

- 586-C.3 Addendum (including OM4)
- 568-C.0 Addendum (table 7 modifications to include OM4)
- 568-C.0 Addendum (Annex B modifications to Method C Parallel Optics)
- 568-C.0 Addendum (POL)

A motion was raised to establish a Task Group to evaluate fiber topics before informing TR-42.1. The motion passed unanimously. Bob Jensen will chair the Task Group and asked that interested members send him an e-mail.

3.2 Output documents; letters; approved standards publications (IEEE, US TAG)

There were no output documents from this meeting.
