Patent searches are not required to comply with the TIA IPR policy. Moreover, the Engineering Manual describes the need for members' disclosure of patents that are essential to practice TIA publications and for members to provide an indication of their willingness to license any known patents.

2 Old business

2.1 Liaison letters received since the opening plenary

2.2 Subcommittee reports and plenary action

2.2.1 TR-42.1 – Generic Telecommunications Cabling and Premises Cabling

Ray Emplit presented TR42-2012-02-048.

A motion to publish ANSI/TIA-568-C.0-2 was approved without objection.

A motion to publish ANSI/TIA-942-A provided that no technical or technical no comments to the default ballot are received was approved without objection.

A project request for ANSI/TIA-942-A-1 (TR42-2012-02-019a) was approved without objection.

2.2.2 TR-42.2 – Residential Telecommunications Infrastructure

Ray Emplit presented TR42-2012-02-044.

A motion to publish ANSI/TIA-570-C was approved without objection.

2.2.3 TR-42.3 – Telecommunication Pathways and Spaces

Henry Franc presented TR42-2012-02-050.

A project request for ANSI/TIA-569-C-1 (TR42-2012-02-045) was approved without objection.

Mr Franc requested that the work of the Network Security Task Group remain under TR-42 until the June meeting because of possible interest in and effect on other subcommittees. The Chair agreed. Masood Shariff was appointed as the new Chair of the Task Group.

2.2.4 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Paul Kish presented TR42-2012-02-057.

2.2.5 TR-42.6 – Telecommunications Infrastructure and Equipment Administration

Steve Huffaker presented TR42-2012-02-041.

A motion to publish ANS/TIA-606-B was approved without objection.

In response to a question from the floor, Mr Huffaker clarified that the mock ballot results for the ISO/IEC Automated Infrastructure Management language would be forwarded to the US TAG.

2.2.6 TR-42.7 – Telecommunications Copper Cabling Systems

Sterling Vaden presented TR42-2012-02-052.

A motion to publish ANSI/TIA-1183 was approved without objection.

In response to questions from the floor Mr Vaden clarified that the motivation for the development of “next generation” cabling was the work within IEEE on 40GBASE-T. The currently proposed name for this new cabling is category 8. Mr Vaden further reported that there was no discussion about adding ISO/IEC 11801 Class F (Category 7) cabling to ANSI/TIA-568-C.2.

2.2.7 TR-42.9 – Industrial Telecommunications Infrastructure

Bob Lounsbury presented TR42-2012-02-047.

2.2.8 TR-42.11 – Optical Fiber Systems

Paul Kolesar presented TR42-2012-02-056.

Mr Kolesar corrected the report by stating that the potential meeting date conflict with BICSI is for the February, 2014, meeting.

Mr Kolesar added that several standards maintained by TR-42.11 reference compilations of contributions which were formally available on FO-4 sites. These documents are now located in the TR-42.11 FTP folder and are password protected. It was agreed that TR-42.11 should move these documents to the public area of the FTP site. Another related issue is that the links in the existing documents are broken. This issue will be handled by advising users to use a web search engine to find the documents on the TR-42 site.

2.2.9 TR-42.12 – Optical Fibers and Cables

Mike Kinard presented TR42-2012-02-049.

Mr Kinard corrected the report by stating that the potential meeting date conflict with BICSI is for the February, 2014, meeting.

Mr Kinard requested that the link to view project status on the TIA web site (currently active only for Chairs) allow access by all members. Herb Congdon responded that TIA would consider that request when development of the project status reporting system, currently in beta, was completed.

Mr Kinard renewed his request that the TIA ballot system be modified to allow multiple representatives from a single company to vote. The system would accept only one vote so a later vote would cancel a previous one. Herb Congdon responded that he would conduct a conference call for those interested to explore the issue.

Mr Kinard requested that the raw data from the cabling length survey be released. The Chair denied the request because the data was disjointed and inconclusive, with the standard deviation exceeding the mean values, which could make the results misleading.

2.2.10 TR-42.13 – Passive Optical Devices and Fiber Optic Metrology

Dave Fisher presented TR42-2012-02-053.

Mr Fisher requested clarification on the need for plenary approval for new projects to revise TSB-149 and TSB-143. The Chair responded that plenary approval was not required to open a project to revise a current standard.

2.2.11 TR-42.16 – Premises Telecommunications Bonding and Grounding

Mark Harger presented TR42-2012-02-046.

A project request for ANSI/TIA-607-B-1 (TR42-2012-02-042 & TR42-2012-02-043) was approved without objection.

2.3 Proposed changes to TR-42 Operational Guidelines

Chair Bob Jensen reported that the Operational Guidelines had been updated to include the changes from the October meeting. A possible conflict between the Operational Guidelines and the TIA Engineering Manual regarding consensus remains under study.

2.4 Program of work

Bob Jensen reminded the subcommittee Vice Chairs that they were responsible for maintaining their subcommittee's entries.

2.5 Other

2.5.1 Data Center Fabric Task Group

This work was assigned to TR-42.1 and a project request was approved (see 2.2.1 re ANSI/TIA-942-A-1).

2.5.2 Network Security Task Group

This Task Group will remain under TR-42. Masood Shariff was appointed as Chair, replacing Ray Emplit. See 2.2.3.

2.5.3 Cable Length Survey Task Group

The results of the survey were inconclusive. This work was assigned to TR-42.7 for copper cabling only.

3.2.3 Energy Management System Addendum Task Group

Ray Emplit was appointed Chair of a new Task Group to study possible development of an energy managements system addendum.

- Ray Emplit to chair three new task groups (M2M, STEP, Energy Management). Mr Emplit will schedule conference calls in coordination with Herb Congdon to begin work.
- Work of the Network Security Task Group will continue under TR-42 with Masood Shariff as Chair.

All electronic files shall be provided in either Adobe Acrobat (*.PDF); Microsoft Word (*.DOC); Microsoft PowerPoint (*.PPT); or in Microsoft Excel(*.XLS). Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group’s email reflector list by the EDC within one working day of the posting. All contributions shall be posted to the appropriate location on the TIA FTP site no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).

LATE CONTRIBUTIONS:

Contributions not posted as described in the timing above shall be classified as "late contributions." They may be considered in the meeting to which they are addressed provided that an appropriate motion receives 50% or greater of a vote.
