Moreover, the Engineering Manual describes the need for members' disclosure of patents that are essential to practice TIA publications and for members to provide an indication of their willingness to license any known patents.

1.6 Chair's report and general items

Chair Bob Jensen presented the Chair's Report (TR42-2012-06-108).

2 Old business

2.1 Liaison letters received

2.1.1 TR-41

Chair Bob Jensen reported that a liaison letter had been received from TR-41 (TR42-2012-06-063) concerning intermatability of 6-position modular plugs with 8-position jacks. Mr Jensen suggested that TR-42.2 and TR-42.7 should review the letter.

2.1.2 TC Cloud Computing Subcommittee

Mr Jensen reported that a liaison letter had been received from the TC Cloud Computing Subcommittee (TR42-2012-06-102) together with a document concerning cloud computing architecture (TR42-2012-06-103).

2.2 Liaison reports

2.2.1 IEEE

Paul Kish presented TR42-2012-06-112.

Dave Hess added that the work of the Reduced Twisted Pair Gigabit Ethernet (RTPGE) Study Group was primarily focused on weight reduction for automotive applications. Mr Hess suggested that TR-42 should consider possible implementation of Gigabit Ethernet over two pairs.

Valerie Maguire added that IEEE 802.3 was working on the 2012 edition of the IEEE 802.3 Ethernet standard to be retitled *Standard for Ethernet*. The target publication date is August, 2012.

2.2.2 ISO/IEC JTC 1/SC 25/WG 3 (US TAG)

Dave Hess presented TR42-2012-06-110.

Mr Hess stated that the upcoming WG 3 development of a bonding and grounding standard should be of particular interest to TR-42. ANSI/TIA-607-B has not been submitted to WG 3 in its final form.

2.2.3 ODVA/SC65C JWG 10

There were no reports for ODVA or IEC SC65C.

2.2.4 IEC SC86A

There was no report for IEC SC86A.

2.2.5 IEC SC86B

There was no report for IEC SC86B.

2.2.6 IEC SC86C

There was no report for IEC SC86C.

2.2.7 Fibre Channel

There was no report for Fibre Channel. Bob Jensen reported that formal liaison reports should begin at the October opening plenary meeting.

2.2.8 SCTE

There was no SCTE liaison report.

2.2.9 BICSI

Jeff Silveira highlighted the following activities of the BICSI Standards Committee:

- The last Committee meeting was in February immediately following the TR-42 meeting.
- A supplement to the data center standard covering data center classes was approved and will be available as a free download on the BICSI web site.
- The proposed standard for health care facilities has undergone an ANSI ballot. A second ANSI ballot will be conducted.
- An ANSI ballot is expected for the proposed standard for electronic safety and security (ESS) systems.
- A Wireless Systems Subcommittee was formed to develop standards for wireless systems in buildings including distributed antenna systems (DAS) and wireless network systems (Wi-Fi).
- The European Standards Committee met in London. The Committee is focusing on developing a collated reference of international standards.

A written report was posted to the TR-42 FTP site after the meeting as document TR42-2012-06-116.

2.2.10 NFPA

There was no NFPA liaison report.

2.2.11 TIA

Herb Congdon presented TR42-2012-06-097, TR42-2012-06-098, TR42-2012-06-099 and TR42-2012-06-100.

Mr Congdon encouraged TR-42 members to register for the TIA 2012 Conference. A printed list of activities of interest to TR-42 members was made available. This list was posted to the TR-42 FTP site following the meeting as document TR42-2012-06-121.

A written TIA report was posted to the TR-42 FTP site after the meeting as document TR42-2012-06-118.

3.1.1 TR-42.1 – Generic Telecommunications Cabling and Premises Cabling

Ray Emplit presented TR42-2012-06-095.

3.1.2 TR-42.2 – Residential Telecommunications Infrastructure

Ray Emplit presented TR42-2012-06-096.

3.1.3 TR-42.3 – Telecommunication Pathways and Spaces

Glenn Sexton presented TR42-2012-06-111. Mr Sexton corrected the report by clarifying that the ballot comment resolution was for proposed TIA-569-C-1.

3.1.4 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Paul Kish presented TR42-2012-06-114.

3.1.5 TR-42.6 – Telecommunications Infrastructure and Equipment Administration

Steve Huffaker presented TR42-2012-06-106. Mr Huffaker clarified the report by adding that the mock ballot comment resolution was for the ISO/IEC automated infrastructure management (AIM) addendum with results to be provided to the US TAG to WG 3. Mr Huffaker further added that TIA-606-B had been submitted to TIA for publication.

3.1.6 TR-42.7 – Telecommunications Copper Cabling Systems

Sterling Vaden presented TR42-2012-06-107.

Mr Vaden further reported that TR-42.7 would add a discussion of issues related to intermatability of 6-pin plugs to 8-pin jacks (see 2.1.1) to the agenda for this week's TR-42.7 meeting. An additional interim meeting of TR-42.7 will be scheduled for the first week of December, 2012. Publication of TIA-1183 was delayed by TIA paperwork but should occur in August, 2012.

3.1.7 TR-42.9 – Industrial Telecommunications Infrastructure

Brad Woodman presented TR42-2012-06-101.

Mr Woodman added that the End-to-End Cabling Task Group has been disbanded and the work moved to TR-42.7. The 1G Noise Task Group had conducted several meetings via conference call and is making progress on the issue.

3.1.8 TR-42.11 – Optical Fiber Systems

Paul Kolesar presented TR42-2012-06-109

3.1.9 TR-42.12 – Optical Fibers and Cables

Paul Kolesar presented TR42-2012-06-113.

3.1.10 TR-42.13 – Passive Optical Devices and Fiber Optic Metrology

There was no report for TR-42.13.

3.1.11 TR-42.16 – Premises Bonding and Grounding

Rich Jones presented TR42-2012-06-105.

Mr Jones clarified that the document number for the external grounding addendum was TIA-607-B-1 and added that the Subcommittee would initiate a ballot to withdraw ANSI-J-STD-607-A. While the issuance of a revision to a standard usually results in an automatic rescission of the old edition, this case is different in that multiple standards bodies developed the A version.

3.2 Output documents to be reviewed at the closing plenary

This topic was deferred to the closing plenary.

3.3 Proposed changes to TR-42 operational guidelines

Chair Bob Jensen reviewed TR42-2012-06-086. Action on this proposal will be taken up at the October closing plenary meeting.

3.4 Proposed changes to TR-42 editors guide

Ray Emplit reviewed TR42-2012-06-062. This topic will be taken up at the closing plenary meeting.

3.5 Other

3.5.1 “D” series planning

The Chair reported that an informal planning session would be held between 1:15 and 3:00 PM. The agenda for this meeting (TR42-2012-06-093) and a spreadsheet comparing the contents of the “C” series documents (TR42-2012-06-104) are posted to the TR-42 FTP site.

3.5.2 Network Security Task Group

Masood Shariff presented TR42-2012-06-115. The latest draft of the proposed standard is posted to the TR-42 FTP site as document TR42-2012-06-092. While the draft is in the form of a standard it could be reformatted as an addendum to TIA-569-C.

3.5.3 M2M

Chair Bob Jensen reported that he was included on the TR-50 reflector and would monitor progress on this issue.

3.5.4 STEP

The Chair reported that he would propose the formation of a new STEP subcommittee at the closing plenary meeting.

3.5.5 Energy Management

The Chair requested that members consider their interest in this topic.

3.6 Action items derived from this meeting

Chair Bob Jensen requested that subcommittees consider what documents to forward to the US TAG. Committee members should review proposed changes to the operational guidelines (see 3.3) and editors guide (see 3.4).

All electronic files shall be provided in either Adobe Acrobat (*.PDF); Microsoft Word (*.DOC); Microsoft PowerPoint (*.PPT); or in Microsoft Excel(*.XLS). Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting. All contributions shall be posted to the appropriate location on the TIA FTP site no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).

LATE CONTRIBUTIONS:
