Participants are encouraged to notify TIA of any patents of which they are aware that are related to the practice of a TIA publication early on in the development of the TIA document to reduce the possibility for delays in the development process and increase the likelihood that the draft TIA publication will be approved for publication. Patent searches are not required to comply with the TIA IPR policy. Moreover, the Engineering Manual describes the need for members' disclosure of patents that are essential to practice TIA publications and for members to provide an indication of their willingness to license any known patents.

#### 2.2.2 TR-42.2 – Residential Telecommunications Infrastructure

TR-42.2 did not meet this week. There was no report.

#### 2.2.3 TR-42.3 – Telecommunication Pathways and Spaces

Glenn Sexton presented TR42-2012-06-123.

A motion to publish TIA-942-A-1 if no technical comments are received to the upcoming ANSI ballot was approved without objection.

### 2.2.4 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Paul Kish presented TR42-2012-06-133.

The Subcommittee failed to reach consensus to reaffirm TIA-440-B. The comments received for the ballot will be forwarded to TR-42.11 and TR-42.12 for incorporation into a draft revision. Action on a project request for the revision (TR42-2012-06-134) was deferred.

Mr Kish reported that he will work to get a response from TIA regarding publishing a PDF version of the working dictionary.

#### 2.2.8 TR-42.11 – Optical Fiber Systems

Paul Kolesar presented TR42-2012-06-128.

A project request for a new TSB on encircled flux launch conditions (TR42-2012-06-130) was approved without objection. Mr Kolesar reported that a working draft is available on the TR-42.11 FTP site.

A project request for a new TSB on optical connector insertion loss (TR42-2012-06-129) was approved without objection. The TSB will establish four grades for insertion loss for multimode connectors with the current standard 0.75 dB loss representing Grade C. There will be two grades with lower insertion loss and one with greater insertion loss. The rating scheme is similar to that used by IEC for single-mode connectors. The document will also provide guidance on the effect of connector insertion loss on link performance.

A project request for a revision to TSB-172 (TR42-2012-06-131) was reviewed. No plenary action is required for a document revision project.

### 2.2.9 TR-42.12 – Optical Fibers and Cables

Paul Kolesar presented TR42-2012-06-135.

#### 2.2.10 TR-42.13 – Passive Optical Devices and Fiber Optic Metrology

TR-42.13 did not meet this week. There was no report.

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting. All contributions shall be posted to the appropriate location on the TIA FTP site <u>no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contributions shall be posted to be considered</u> (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).
