Patent searches are not required to comply with the TIA IPR policy. Moreover, the Engineering Manual describes the need for members' disclosure of patents that are essential to practice TIA publications and for members to provide an indication of their willingness to license any known patents.

1.6 Chair's report and general items

1.6.1 Passing of former members

Mike Kinard reported on the passing of two former TR-42 (FO-4) members:

- Art Hudson, formerly of the Department of Defense, on September 23, 2012
- Eric Loytty, formerly of Siecor, on September 23, 2012.

Mr Kinard noted that both had made significant contributions to the development of TIA standards.

1.6.3 Chair's report

Chair Bob Jensen presented the Chair's Report (TR42-2012-10-156). Mr Jensen noted that a requested change to the meeting schedule for June, 2013, would be discussed at the closing plenary meeting on October 5.

2 Old business

2.1 Liaison letters received

2.1.1 TIA TR-41

2.1.1.1 6-position and 8-position modular jacks and plugs

Chair Bob Jensen reminded the Committee that a liaison letter had been received from TR-41 (TR42-2012-06-063) concerning 6-position and 8-position modular jacks and plugs. Mr Jensen suggested that TR-42.2 and TR-42.7 should review the letter.

2.1.1.2 References to ANSI/TIA-1096-A

Chair Bob Jensen reported that a liaison letter had been received from TR-41 (TR42-2012-10-144) regarding improper references for modular connector requirements. The letter states that some manufacturers are improperly referencing Part 68, Subpart F of the FCC rules (which no longer exist) instead of ANSI/TIA-1096-A. Mr Jensen suggested that subcommittees should review their standards to ensure the proper reference is made.

2.1.2 Fibre Channel T11.2

Chair Bob Jensen reported that a liaison letter had been received from Fibre Channel T11.2 (TR42-2012-06-125) requesting that TR-42.12 investigate development of an optical fiber for 28 Gbaud line rate (and other speeds). Mr Jensen referred the letter to TR-42.12 for response.

2.1.3 Tri-Services Electrical and Telecommunications Working Group

Chair Bob Jensen reported that an email had been received from the Tri-Services Electrical and Telecommunications Working Group (TR42-2012-10-158) concerning the new terminology in

ANSI/TIA-569-C and confusion about the movement of some pathways and spaces requirements to ANSI/TIA-568-C.1-1. Mr Jensen referred the email to TR-42.3 for response.

2.2 Liaison reports

2.2.1 IEEE 802.3

Paul Kish presented TR42-2012-10-173a.

2.2.2 ISO/IEC JTC 1/SC 25/WG 3 (US TAG)

Dave Hess presented TR42-2012-10-176.

Ray Keden provided additional information on the new work item request in WG 3 for a standard for equipotential bonding and earthing (grounding). The preliminary draft for this standard is based on a (published) CENELEC standard on the same topic. The US delegation approved the work item but requested that material be included from ANSI/TIA-607-B and (draft) ANSI/TIA-607-B-1. At the WG 3 meeting in September, an ad hoc group had been formed to consider this additional content. The ad hoc group met and resolved to change the title of the standard to cover only bonding since there was no content specific to grounding in the draft. Material related to grounding from the TIA documents will be considered for inclusion in an informative annex. The ad hoc group will meet November 12 – 13 in Frankfurt, Germany, and in January or February, 2013, in the US.

2.2.3 ODVA/SC65C JWG 10

There were no reports for ODVA or IEC SC65C.

NOTE – Liaison reports for ODVA and IEC SC65C JWG 10 were received later in the week and were posted to the TR-42 FTP site as documents TR42-2012-10-178 and TR42-2012-10-177, respectively.

2.2.4 IEC SC86A

Mike Kinard presented TR42-2012-10-172. Mr Kinard added that a joint working group had been established with IEC SC86C for hybrid cables.

2.2.5 IEC SC86B

TR42-2012-10-159 was posted to the TR-42 FTP site but was not reviewed at this meeting.

2.2.6 IEC SC86C

TR42-2012-10-168 was posted to the TR-42 FTP site but was not reviewed at this meeting.

2.2.7 Fibre Channel

There was no liaison report for Fibre Channel. TR42-2012-10-160 was posted to the TR-42 FTP site noting the liaison letter received.

2.2.8 SCTE

There was no SCTE liaison report.

2.2.9 BICSI

Ray Emplit presented TR42-2012-10-170.

2.2.10 NFPA

Bob Jensen reported that there were no major changes from Panel 16 for the 2014 *National Electrical Code*[®].

Ray Keden reported that action in Panel 3 will add requirements for cable routing assemblies to the code.

2.2.11 TIA

Marianna Kramarikova presented TR42-2012-10-169a. Ms Kramarikova also demonstrated a new feature of the TIA web site which allows members to register for multiple meetings at one time.

Chair Bob Jensen reminded members that George Gulla of ANSI would be giving a presentation about the importance of standards development on Tuesday, October 2, from 6:00 – 7:00 PM.

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting.
