Moreover, the Engineering Manual describes the need for members' disclosure of patents that are essential to practice TIA publications and for members to provide an indication of their willingness to license any known patents.

Mr Vaden corrected the report by noting that, on slide 3, the correct document number should be 1152-A (a revision of TIA-1152, not an addendum).

A motion to approve a new project (TR42-2013-10-152) for a TSB covering internally-generated cable impulse noise was approved without objection.

A motion to approve sending a liaison letter to IEEE 802.3 (TR42-2013-10-149) regarding cooperation with the Reduced Pair-count Twisted-pair Gigabit Ethernet study group was approved without objection.

Stakeholders include groups, organizations, industries (e.g. consumers, architects, engineers, nuclear facilities, etc.) who are:

- impacted by the standard
- actively involved in the project

- whose interests may be positively or negatively affected as a result of project execution or project completion
- may also exert influence over the project and its results
- contributors to the project they may provide products or services that contribute to project objectives
- recipients of products or services provided by the project
- interested in, or can influence the outcome of the project

In response to a suggestion from the floor, it was agreed that a "leadership training" meeting would be scheduled as part of the January, 2014, meetings.

3.4 Bulk upload of comments

Herb Congdon presented TR42-2013-10-151 outlining the new bulk comment upload option in the TIA ballot system.

3.5 Other

There was no other new business.

3.6 Action items derived from this meeting

Greg Sandels is to provide a project request for a new FOCIS standard for 1x16 and 2x16 MPO connectors (see 2.2.11).

Germaine Palangdao is to develop training for the new project request forms (see 3.3).

All electronic files shall be provided in either Adobe Acrobat (*.PDF); Microsoft Word (*.DOC); Microsoft PowerPoint (*.PPT); or in Microsoft Excel(*.XLS). Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting. All contributions shall be posted to the appropriate location on the TIA FTP site no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted to the 10th).

LATE CONTRIBUTIONS:

Contributions not posted as described in the timing above shall be classified as "late contributions." They may be considered in the meeting to which they are addressed provided that an appropriate motion receives 50% or greater of a vote.
