2.2 Revision of TR-42 operational guide

Greg Sandels reviewed the current draft of the TR-42 Operational Guide (TR-42-2015-06-093).

The proposal to remove the requirement for new projects to be approved by the plenary (in clause 8) did not make the 2/3+1 requirement for technical changes to the operational guide (by a vote of 7 for and 6 against). The TR-42 Operational Guide Task Group will craft compromise text regarding project approvals by the Plenary for review at the next meeting.

The committee unanimously agreed to keep consensus for technical changes to a document or draft unchanged (yes votes greater than 2*No votes). Technical changes with a TBD require a 50% majority for approval. The interpretation of the current rules is that removing the TBD requires a 2/3+1 majority. The TR-42 Operational Guide draft to be edited to note that adding or removing a TBD is a technical change (yes votes greater than 2*No votes).

The committee agreed to change the requirements for consensus for 11.1.3 administrative/procedural to be a simple majority (the same as 11.1.1).
