Comment resolution on TIA-942-B was not completed and will continue with two interim conference calls – July 14 and July 21 from 11 am to 1 pm EST.

The subcommittee will be starting work on addenda to TIA-568.0-D and TIA-568.1-D based on activities in other subcommittees (primarily TIA-568.3-D and Category 8). The initial work will be mock ballots within the subcommittee. PARs for these two projects will be completed later.
