2 Old business

2.1 Liaison letters received since the opening plenary

Documents 2016-10-114 and 2016-10-115 were received from IEEE 802.3 since the opening plenary.

2.2 TR-42 program of work: status of online tools

Ray Emplit reviewed the status of online tools for tracking the TR-42 program of work. Germaine noted that this is still in progress.

2.3 Subcommittee reports and plenary action

2.3.1 TR-42.1 – Generic Telecommunications Cabling and Premises Cabling

Henry Franc presented TR42-2016-10-145.

The Places of Assembly Task Group has been restarted and will be meeting monthly, those interested in participating should contact Cindy Montstream cindy.montstream@legrand.us

Comment resolution was completed on the committee ballot for TIA-1179-A Healthcare Facilities. The next ballot will be an industry ballot.

Comment resolution was completed on the committee ballot for TIA-942-B Data Centers. The next ballot will be an industry ballot.

The subcommittee approved the PARs for addenda to TIA-568.0-D and TIA-568.1-D. The two addenda will be issued for industry ballot and will be based on activities in other subcommittees (primarily TIA-568.3-D and Category 8).

2.3.2 TR-42.3 – Telecommunications Pathways and Spaces

Cindy Montstream presented TR42-2016-10-146.

Comment resolution was completed on the industry ballot for TIA-569-D-1 Revised Temperature & Humidity Requirements. TR-42.3 approved publication of this addendum.

Comment resolution was completed on the committee ballot for TIA-569-D-2 Pathways & Spaces for Remote Powering. The next ballot will be a committee ballot.

2.3.3 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Diane Forbes presented TR42-2016-10-147.

2.3.4 TR-42.6 – Telecommunications Infrastructure and Equipment Administration

Jonathan Jew presented TR42-2016-10-148.

Comment resolution was completed on the industry ballot for TIA-606-C. The next ballot will be another industry ballot.

The subcommittee approved the PAR for the adaption of ISO/IEC 18598 Automated Infrastructure Management. The adapted standard and TIA-606-C will be published concurrently, because content regarding AIM in TIA-606-B will be replaced by the adapted ISO/IEC standard.

2.3.5 TR-42.7 – Telecommunications Copper Cabling Systems

Wayne Larsen presented TR42-2016-10-149.

ANSI/TIA-568-C.2-1 category 8 was published since the June meeting.

Comment resolution was completed on the committee ballot of TIA TSB-184-A, supporting 1000 mA power over 4 pairs. The next ballot will be a default ballot.

Comment resolution was completed on ANSI/TIA-1152-A (category 8 field testing) and authorized publication.

Comment resolution was completed on the committee ballot of TIA TSB-5021, support for 2.5GBASE-T and 5GBASE-T using existing cabling. The next ballot will be a default ballot.

Comment resolution was completed on the mock ballot of ANSI/TIA 568.2-D. The next ballot will be another mock ballot.

Resolution of comments on 1183-A, measurement methods and test fixtures for balun-less measurements of balanced components and systems, did not occur due to lack of time

The subcommittee agreed to the PAR and industry ballot for ANSI/TIA-568.4-D, revision of ANSI/TIA-568-C.4, coaxial cabling.

TR-42.7 developed a liaison response to IEEE 802.3 on higher operating temperature of cabling - 2016-10-161 - which was reviewed and approved by TR-42. TR-42 granted Ray Emplit license to edit the liaison as appropriate.

TR-42.7 established a task group established to study the testing and applications of end plugs. The name of the task group has not yet been determined.

The TR-42 single-pair task group will be meeting on Oct 17 from 11am-1pm Eastern.

2.3.6 TR-42.9 – Industrial Telecommunications Infrastructure

Ray Emplit presented TR42-2016-10-150a on behalf of Bob Lounsbury.

TR-42.9 authorized two mock ballots for addenda to ANSI/TIA-1005-A-2012

- 1G industrial cabling for four pair (100 meters) (1000BASE-T) for E2 and E3 environments
- 1G industrial cabling for one pair Type B (40 meters) (1000BASE-T1) for E2 and E3 environments

TR-42.9 drafted the response to IEEE 802.3 regarding single pair Ethernet projects - 2016-10-160 - which was reviewed, edited and approved by TR-42. The revised draft was posted as 2016-10-160a.

2.3.7 TR-42.10 - Sustainable Information Communications Technology

Glenn Sexton presented TR42-2016-10-151.

Comment resolution was completed on TSB-5046 Sustainability for manufacturers. The document was issued for a default ballot with one comment. The subcommittee conditionally approved publication if there are no technical comments and no negative votes.

2.3.8 TR-42.16 – Premises Bonding and Grounding

Cindy Montstream presented TR42-2016-10-155 on behalf of Mark Harger.

Comment resolution was completed on TIA-607-C-1 bonding and grounding systems for multitenant buildings. The document will be issued for an industry ballot with conditional approval to publish if there are no technical comments and no negative votes.
