2 Old business

2.1 Liaison letters received since the opening plenary

2.1.1 From IEEE 802.3 re 10 Mb/s over single twisted-pair

The committee reviewed 2018-01-007 from IEEE 802.3 regarding MDI connectors. TR-42.7 was tasked this week to draft a response to IEEE 802.3 regarding both incoming liaisons.

2.2 Possible change of election timing

The committee reviewed possible changes to the timing of subcommittee elections. The committee agreed to have elections in the first meeting of the year starting with 2019. Ray Emplit will determine if changes need to be made to the TR-42 Operating Procedures.

2.3 Subcommittee reports and plenary action

2.3.1 TR-42.1 – Generic Telecommunications Cabling and Premises Cabling

Diane Forbes presented TR42-2018-01-041 on behalf of Joe Cody.

TIA-568.1-D (Commercial) addendum 1 default ballot closed without any negative votes or technical comments. It was approved by TR-42.1 for publication.

Comments were resolved on TIA-570-D (Residential). The next ballot will be a default ballot with conditional approval for publication.

Work continues with the Places of Assembly task group.

Work continues within the single-pair task group

TR-42.1 has approved a new name - Premises Telecommunications Infrastructure.

Upcoming work includes:

- An expected draft for ANSI/TIA-758-C Outside Plant
- Possible PAR for optical fiber polarity in a channel from a user perspective
- Possible PARs for to start work on revisions to ANSI/TIA-568.0-D and ANSI/TIA-568.1-D in September of 2018, same for 4966 early 2019

2.3.2 TR-42.3 – Telecommunications Administration, Pathways, Spaces, Bonding and Grounding

Cindy Montstream presented TR42-2018-01-042.

TR-42 approved publication of an errata to ANSI/TIA-606-C

Comments were resolved on TIA-569-D (Pathways & Spaces) addendum 2 on pathways and spaces for remote powering. The next ballot will be an industry ballot.

2.3.3 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Ron Tellas presented TR42-2018-01-043.

2.3.4 TR-42.7 – Telecommunications Copper Cabling Systems

Sterling Vaden presented TR42-2018-01-044.

Comments were resolved on ANSI/TIA-568.2-D (revision to TIA-568.C-2). The next ballot will be a default ballot with conditional approval for publication.

A committee ballot was authorized for TSB-184-A-1, installation guideline for power delivery over 28 AWG cord cable.

Active task groups in TR-42.7 are:

- Single pair cabling
- Category 8 short channel alien crosstalk
- TSB-184-A-1 Installation guidelines for cords in vertical cable managers
- High temperature cable performance

TR-42.7 established an initial procedure and timeline for selecting a suitable single pair connector (or connectors) for inclusion in the TIA 568.5 draft. Five connector proposals were reviewed. The target date for publishing TIA-568.5 is October 2019, with the first complete draft and ballot in October 2018.

TR-42.7 drafted a liaison to IEEE 802.3 responding to their previous liaison letters on single pair cabling and connectors (2018-01-010, edited and reposted as 2018-01-010a).

2.3.5 TR-42.9 – Industrial Telecommunications Infrastructure

Brad Woodman presented TR42-2018-01-045.

Comments were resolved on ANSI/TIA-PN1005-A-2 (Performance requirements for 1G four pair industrial cables and cabling supporting 1000BASE-T for MICE2 and MICE3 environments). The next ballot will be another committee ballot.

Comments were resolved on mock ballot for ANSI/TIA-PN-PN1005-A-3 (1G industrial cabling for one pair Link Segment Type B, 1000BASE-T1 for MICE2 and MICE3 environments). The next ballot will be another mock ballot. The committee agreed to add information for 1000 meter IEEE 802.3cg.

2.3.6 TR-42.11 – Optical Fiber Systems

Paul Kolesar presented TR42-2018-01-046.

Comments were resolved on TIA-568.3-D addendum 1. The next ballot will be the first industry (ANSI) ballot.

2.3.7 TR-42.12 – Optical Fibers and Cables

Paul Kolesar presented TR42-2018-01-047 on behalf of Mike Kinard.

Patrick Van Vickle was elected as Chair and Roman Shubochkin was elected as Vice-Chair.

TR-42.12 formed a task group to 'develop (technical) information on MMF for the purposes of WDM applications', primarily for OM3 and OM4 to determine their ability to support WDM. The task group will be lead by Bulent Kose (bko@panduit.com). The task group anticipates monthly teleconferences and collaboration across other related SDOs (e.g. IEEE, IEC, Fibre Channel, etc).

Industry ballot comments for FOTP-95 (absolute power) were resolved and it was issued for a second industry ballot.

Industry ballot comments for TIA-598-D-1 (Additional Colors for Fibers 13-16) were resolved and it was issued for a second industry ballot.

Industry ballot comments for TIA-598-D-2 (addendum for OM5 lime green jacket color) were resolved and it was approved for publication.

TR-42.12 is working on the restructuring of the TIA-492 series and is considering adaptations of IEC 60793-2, 60793-2-10, & 60793-2-50.

2.3.8 TR-42.13 – Passive Optical Devises and Fiber Optic Metrology

Greg Sandels presented TR42-2018-01-048.

Comments were resolved on FOTP 171B. It will be issued for a 4th (industry) ballot.

604-5 (MPO) and 604-18 (MPO 16) ballots don't close until 2/2/2018. All received comments were reviewed and resolved. The subcommittee agreed to distribute it for an industry ballot if no more technical or negative comments are received.

Work on the CS Connector FOCIS proposal was deferred until the June meeting.

IEC Optical Interface Adoption Proposal was reviewed. Another series is required for the IEC modular approach.

An accurate and comprehensive list of documents is desperately needed from TIA.

Masood Shariff informed the committee that the NEC Input Task Group did not meet since the last meeting so there is no report.
