2.3.1 TR-42.1 – Premises Telecommunications Infrastructure

Diane Forbes presented TR42-2018-06-091 on behalf of Joe Cody.

The comment for TIA-570-D (Residential) was resolved and the document was approved for publication.

The first ANSI/TIA-758-C Outside Plant draft was reviewed. It will be released for an industry ballot.

Work continues with the Places of Assembly task group.

Work with the single-pair task group will be put on hold to ensure that work being performed in TR-42.7 and TR-42.9 is not duplicated.

TR-42.1 has approved a new name - Premises Telecommunications Infrastructure.

Upcoming work includes:

- PAR and draft of TIA-568.0-E for review at the October meeting Ray Emplit editor.
- PAR and draft of TIA-568.1-E for review at the October meeting Ray Emplit editor.
- PAR and draft of TIA-4966 for review at the October meeting Diane Forbes editor.
- Future work on central office to data center conversion
- Future work on edge data centers

PAR for optical fiber polarity in a channel from a user perspective was reviewed and approved in TR-42.1. TR-42 reassigned the project without objection to TR-42.11. TR-42.11 was assigned to review and approve the PAR.

2.3.2 TR-42.3 – Telecommunications Administration, Pathways, Spaces, Bonding and Grounding

Cindy Montstream presented TR42-2018-06-092.

TR-42.3 approved publication of TIA-569-D (Pathways & Spaces) Addendum 2 on pathways and spaces for remote powering.

TR-42.3 approved the PAR and industry ballot for TIA-569-E.

The subcommittee agreed to send TIA-569-D-2 to USTAG JTC 1 SC 25 WG 3 and SCC.

2.3.3 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Diane Forbes presented TR42-2018-06-093 on behalf of Ron Tellas.

TR-42.5 volunteered to maintain the TR-42 document list. It will be available in the TR-42 MAIN public folders for anyone to review. Chairs are requested to update TR-42.5 on the status of their standards to ensure that the TR-42 document list is current.

2.3.4 TR-42.7 – Telecommunications Copper Cabling Systems

Default ballot comments were resolved on ANSI/TIA-568.2-D (revision to TIA-568.C. It was approved for publication.

A second committee ballot was authorized for TSB-184-A-1, installation guidelines for power delivery over 28 AWG cord cable.

TR-42.7 approved to create a PAR to an addendum to 568.2-D to specify balun requirements for category 8 testing.

TSB-190 was reaffirmed.

Active task groups in TR-42.7 are:

- Single pair cabling
- Category 8 short channel alien crosstalk
- TSB-184-A-1 Installation guidelines for cords in vertical cable managers

Voting for single-pair connectors to include in the 568.5 draft will occur at the next meeting.

Draft 0.5e of TIA-568.5 will be sent to SCC.

A letter will be sent to TIA noting that we are working on single pair cabling specs for IOT. TR-42 reviewed and edited 2018-06-102a.

2.3.5 TR-42.9 – Industrial Telecommunications Infrastructure

Henry Franc presented TR42-2018-06-095 on behalf of Brad Woodman.

Vice-Chair election will be held at October meeting due to retirement of Bob Lounsbury.

Comments were resolved on ANSI/TIA-1005-A-2 (Performance requirements for 1G four pair industrial cables and cabling supporting 1000BASE-T for MICE2 and MICE3 environments). The next ballot will be another committee ballot.

Comments were resolved on mock ballot for ANSI/TIA-PN-PN1005-A-3 (1G industrial cabling for one pair Link Segment Type B, 1000BASE-T1 for MICE2 and MICE3 environments). The
