#### 2.3.1 TR-42.1 – Premises Telecommunications Infrastructure

Diane Forbes presented TR42-2018-10-141 on behalf of Joe Cody.

The single-pair task group will be holding a conference call on Nov 4 11a-1p EST

Reaffirmation of TSB-162-A will be considered at the next meeting.

TR-42.1 approved the PAR for TIA-568.0-E *Generic Telecommunications Cabling for Customer Premises* with Ray Emplit as editor.

TR-42.1 approved the PAR for TIA-568.1-E *Commercial Building Telecommunications Cabling Standard* with Ray Emplit as editor.

TR-42.1 approved the PAR for TIA-4966-A *Telecommunications Infrastructure Standard for Educational Facilities* with Diane Forbes as editor.

TR-42.1 established a new task group on Edge Data Centers led by Henry Franc (<u>Henry.Franc@belden.com</u>) and Cindy Montstream (<u>cindy.montstream@legrand.us</u>). Please contact them to join the new task group.

# 2.3.2 TR-42.3 – Telecommunications Administration, Pathways, Spaces, Bonding and Grounding

Cindy Montstream presented TR42-2018-10-142.

TR-42.3 resolved comments on TIA-569-E and approved another industry ballot.

TR-42.3 approved the PAR for TIA-607-D to be edited by Ray Emplit and authorized an industry ballot.

#### 2.3.3 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Diane Forbes presented TR42-2018-10-143 on behalf of Ron Tellas.

TR-42.5 volunteered to maintain the TR-42 document list. Chairs are requested to update TR-42.5 on the status of their standards to ensure that the TR-42 document list is current.

#### 2.3.4 TR-42.7 – Telecommunications Copper Cabling Systems

Sterling Vaden presented TR42-2018-10-144.

Ballot comments were resolved, and a third committee ballot was authorized for TSB-184-A-1, installation guidelines for power delivery over 28 AWG cord cable.

TR-42.7 selected the IEC 63171-1 LC style connector as the single pair equipment outlet connector.

The 568.5 draft was reviewed and will continued to be developed by the single pair task group.

TR-42.7 approved for industry ballot addendum 568.2-D-1 to specify balun requirements for category 8 testing.

TR-42.7 created a task group to investigate component specifications for field term plugs.

TR-42.7 authorized 184-A TG to create a PAR for a second addendum to 568.2-D regarding normative powering requirements.

A letter will be sent to TIA noting that we are working on single pair cabling specs for IOT (2018-10-153).

TR-42 reviewed and approved TR42-2018-10-152 Outgoing Connector Selection Liaison IEEE 802.3 Oct 5. The revised draft was posted as TR42-2018-10-152a.

#### 2.3.5 TR-42.9 – Industrial Telecommunications Infrastructure

Brad Woodman presented TR42-2018-10-145.

TR-42.9 Vice-Chair election will be deferred until January to coincide with the election of the TR-42.9 Chair.

TR-42.9 selected IEC 61076-3-125 as the single pair connector for MICE2 & MICE3.

TR-42.9 approved reaffirmation of ANSI/TIA-1005-A. The chair will create the PAR.

Comments were resolved on ANSI/TIA-1005-A-2 (Performance requirements for 1G four pair industrial cables and cabling supporting 1000BASE-T for MICE2 and MICE3 environments). The next ballot will be an industry ballot.

Work continues on ANSI/TIA-PN-PN1005-A-3 (1G industrial cabling for one pair Link Segment Type B, 1000BASE-T1 for MICE2 and MICE3 environments).

## 2.3.6 TR-42.11 – Optical Fiber Systems

Phil Irwin presented TR42-2018-10-146 on behalf of Paul Kolesar.

Default ballot comments were resolved on TIA-568.3-D addendum 1 and TR-42.11 approved publication.

TR-42.11 approved the PAR for a TSB on Optical Fiber Channel Polarity.

## 2.3.7 TR-42.12 – Optical Fibers and Cables

Patrick Van Vickle presented TR42-2018-10-147.

TR-42.12 approved a PAR for ANSI/TIA-455-82-C FOTP-82C Fluid Penetration, which will incorporate applicable sections of IEC 60794-1-22.

TR-42.12 approved a PAR for ANSI/TIA-598-E Optical Fiber, Cable, and Component Color Coding, with Pete Pondillo as editor.

TR-42.12 submitted the following PARs for TIA-492-series restructuring; adaption of IEC MMF and SMF fiber specifications;

- Generic: submitted to TIA to adapt IEC 60793-2:2015 as ANSI/TIA-4920000-C
- Multimode: submitted to TIA for adapt with modifications IEC 60793-2-10:2017 as ANSI/TIA-492AAAF
- Single mode: submitted to TIA for adapt with modifications IEC 60793-2-50:2015 as ANSI/TIA-492CAA

TIA-598-D-1 Colors for elements 13-16 was approved for publication on Aug 13, 2018 but needs a title correction.
