2.3 Subcommittee reports and plenary action

2.3.1 TR-42.1 – Premises Telecommunications Infrastructure

Diane Forbes presented 2019-01-033 on behalf of Joe Cody.

TR-42.1 resolved comments for the 1st committee ballot of TIA-568.0-E *Generic Telecommunications Cabling for Customer Premises*, but deferred completion of ballot comments until the June meeting after the TO/EO Channels Task Group has met to recommend resolution of the unresolved comments.

TR-42.1 resolved comments for the 1st committee ballot of TIA-568.1-E *Commercial Building Telecommunications Cabling Standards*, but deferred completion of ballot comments until the June meeting after the TO/EO Channels Task Group has met to recommend resolution of the unresolved comments.

TR-42.1 resolved comments for the 1st Industry ballot of TIA-758-C Customer-Owned Outside Plant. The next ballot will be another Industry ballot.

The PAR for revision of TSB-162-A Wireless Access Points will be considered at the next meeting.

TR-42.1 established a new task group to develop the initial draft of an addendum to TIA-942-B. The addendum will address modifications to TIA-942-B to incorporate Edge Data Centers (EDCs). The PAR for the addendum will be created at the June meeting. The task group Editor will be Marta Soncodi and will be co-chaired by Cindy Montstream

(<u>cindy.montstream@legrand.us</u>) and Jonathan Jew (<u>jew@j-and-m.com</u>. Please contact the cochairs to join the EDC task group. A separate TSB may be created to incorporate content that the task group determines is outside the scope of TIA-942-B.

2.3.2 TR-42.3 – Telecommunications Administration, Pathways, Spaces, Bonding and Grounding

Cindy Montstream presented 2019-01-034.

TR-42.3 resolved comments on TIA-569-E and approved a default ballot with approval to publish if there are no negative votes or technical comments.

TR-42.3 resolved comments on TIA-607-D and authorized an industry ballot.

2.3.3 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Ron Tellas presented 2019-01-035.

TR-42.5 will maintain the TR-42 document list. Chairs are requested to update TR-42.5 on the status of their standards to ensure that the TR-42 document list is current.

2.3.4 TR-42.7 – Telecommunications Copper Cabling Systems

Sterling Vaden presented 2019-01-036a.

TR-42.7 approved publication of TIA-568.2-D-1 to specify balun requirements for category 8 testing pending a successful closure of the default ballot on February 3 without negative votes or technical comments.

Contributions on single-pair test procedures were reviewed and a mock ballot was approved for TIA-568.5.

Ballot comments were resolved, and publication was authorized for TSB-184-A-1, installation guidelines for power delivery over 28 AWG cord cable.

TR-42.7 reviewed progress o a second addendum to 568.2-D regarding normative powering requirements.

TR-42.7 agreed to not take any action regarding reaffirmation or revision of TSB-155-A.

TR-42.7 agreed to re-affirm TSB-5008.

TR-42.7 agreed to re-affirm TSB-1197.

TR-42 did not have consensus to send TR42-2019-01-031 Outgoing Liaison to Intertek on Field Terminatable Plugs.

2.3.5 TR-42.9 – Industrial Telecommunications Infrastructure

Brad Woodman presented 2019-01-037.

TR-42.9 approved reaffirmation of ANSI/TIA-1005-A.

The ballot for ANSI/TIA-1005-A-2 (Performance requirements for 1G four pair industrial cables and cabling supporting 1000BASE-T for MICE2 and MICE3 environments) closes on February 18.

Work continues on ANSI/TIA-PN-PN1005-A-3 (1G industrial cabling for one pair Link Segment Type B, 1000BASE-T1 for MICE2 and MICE3 environments).

2.3.6 TR-42.11 – Optical Fiber Systems

Phil Irwin presented 2019-01-038 on behalf of Paul Kolesar.

TIA-568.3-D addendum 1 was published on Jan 22, 2019.

TR-42.11 reviewed the draft for TSB-5069 on Optical Fiber Channel Polarity and approved a committee ballot.

2.3.7 TR-42.12 – Optical Fibers and Cables

Patrick Van Vickle presented 2019-01-039.

TR-42.12 resolved comments and approved publication of ANSI/TIA-455-95B (FOTP-95B), Absolute Optical Power Test.

TR-42.12 finalized a draft and approved an industry ballot for ANSI/TIA-455-82B (FOTP-82), Fluid Penetration.

TR-42.12 approved a PINS to initiate the project for FOTP-244, Temperature Cycling of Expressed Tubes. It will include applicable sections of IEC 60794-1-22 Method F18.

TR42.12 approved a PINS to initiate the project for FOTP-3, Temperature Ramps and Precision. It will harmonize with FOTP-3 and IEC 60794-1-22, Method F1.

Work continues on ANSI/TIA-598-E Optical Fiber Color Coding.

IEC published 60793-2-50 SM document; TR42.12 is developing an adaption document for a possible June 2019 vote submission.

2.3.8 TR-42.13 – Passive Optical Devises and Fiber Optic Metrology

Greg Sandels presented 2019-01-040.

TR-42.13 resolved comments and approved FOCIS 604-19 (CS connector) for a committee ballot.

TR-42.13 reviewed the IEC Optical Interfaces document structure. It is an ongoing strategy for the IEC structure to be adopted in TIA.

TR-42.11, 12, and 13 propose a 2-day block for all three subcommittees, preferably Wed & Thursday, with them running concurrently – one subcommittee will start when the other ends. TIA will provide the proper details and text for compliance to be presented at the next meeting.

Masood Shariff informed the committee that the NEC Input Task Group did not meet.

Ray Emplit suggested in the TR-42.1 meeting that we may want to modify clause 2.3.3. of the TIA Style Guide to remove the requirement for year to be included in normative references. Committees may opt to either include or not include the year in normative references. Ray Emplit suggested that we adopt the ISO/IEC text: For dated references, only the edition cited applies. For undated references, the latest edition of the referenced document (including any amendments) applies.
