#### 2.2.1 TR-42.1 – Premises Telecommunications Infrastructure

Diane Forbes presented 2019-09-126 on behalf of Joe Cody

- TR-42.1 resolved industry ballot comments for the ballot of TIA-568.0-E *Generic Telecommunications Cabling for Customer Premises* and authorized a default ballot with conditional approval to publish.
- TR-42.1 resolved industry ballot comments for the ballot of TIA-568.1-E *Commercial Building Telecommunications Cabling Standard*s and authorized a default ballot with conditional approval to publish.
- TR-42.1 resolved committee ballot comments for the revision of TSB-162-A Wireless Access Points and authorized a second committee ballot.
- TR-42.1 authorized an industry ballot for AANSI/TIA-4966-A Education Facilities.
- TR-42.1created a new task group (to be jointly lead and populated with TR-42.7) to address Building Automation & Multi-Drop single pair Ethernet.

- TR42.7 authorized a new project for requirements for Field Testers for Single Pair.

TR42.7 will consider a new project at the next meeting for Heating of Single Pair Cabling.

TR-42.9 approved a project for revising TIA-1005-A (B revision). Work will commence after the reaffirmation of TIA-1005-A.

TR-42.9 presented a draft outgoing Liaison letter to ODVA regarding Industrial Single Pair Cabling 2019-09-138.

TR-42.11 approved a project for TIA-526-D.

## 2.2.7 TR-42.12 – Optical Fibers and Cables

TR-42.12 resolved ballot comments for ANSI/TIA-455-82B (FOTP-82) *Fluid Penetration* and authorized another industry ballot.

TR-42.12 resolved ballot comments for TIA-455-244 (FOTP-244) *Temperature Cycling of Expressed Tubes* and authorized an industry ballot.

TR-42.12 reviewed the TIA-492 series restructuring and has approved an industry ballot for TIA-492AAAF and IEC-60793-2-10.

TR-42.12 approved a project for the revision of FOTP-191, IEC-60793-1-45 Optical Fibres (Parts 1-45) *Measurement Methods and Test Procedures – Mode Field Diameter)* and authorized an industry ballot.

#### 2.4.1 Treatment of Technical Comments within the ECOP

TR-42 unanimously approved the motion to request that the TSSC modify the ECOP in regards to how technical comments are addressed relative to a default ballot as follows:

- 1) Given that an approved technical comment can be resolved editorially and not impact (be included on) a default ballot;
  - a) Can we treat a rejected technical comment that was editorial (informative in nature), similarly to the situation above, that it need not be included on the default ballot.
- Given that if an comment is mislabeled (by the commenter) as editorial, it should be changed to technical by the document editor for the purposes of ballot comment resolution;
  - b) Can we change a mislabeled comment (by the commenter) from technical to editorial for the purposes of ballot comment resolution. If indeed it was an error in labelling, it made no technical changes, and agreed to by the original commenter.

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting.
