2.2.1. TR-42.1 - Premises Telecommunications Infrastructure

Diane Forbes presented TR42-2020-10-147.

TR-42.1 resolved committee ballot comments to TIA-568.0-E-1 (single balanced twisted-pair use cases and topology) and approved the 1st industry ballot.

TR-42.1 resolved industry ballot comments to ANSI/TIA-758-C (Customer-Owned Outside Plant) and approved the 3rd industry ballot.

TR-42.1 resolved committee ballot comments to TIA-862-C (Intelligent Buildings) and approved the 1st industry ballot.

TR-42.1 resolved mock ballot comments to TIA-942-B-1 (Edge Data Centers) and approved the 1st committee ballot.

TR-42.1 reviewed the disposition of ANSI/TIA-4994 and TIA TSB-5046 TR-60 agreed to take responsibility for ANSI/TIA-4994. The subcommittee will review material and relevance of TSB-5046 at the next meeting.

TR-42.1 desires to merge ANSI/TIA-568.0, ANSI/TIA-568.1, and TIA-862 with next revision cycle (568 F-series). This work will impact other areas within TR-42 and TR-42.1 wants to begin preparation for this effort as early as possibly to mitigate negative effects of this change

2.2.2. TR-42.3 – Telecommunications Administration, Pathways, Spaces, Bonding and Grounding

Cindy Montstream presented TR42-2020-10-148.

TR-42.3 reviewed and approved the project request for TIA-607-D amendment 1 to harmonize the work done by TR-14 (TIA-222) and TR-42.3 (TIA-607).

TR-42.3 reviewed and approved the project request for TIA-606-D revision of TIA-606.

TR-42.3 reviewed and approved the project request for TIA-5048-1 (AIM) adoption of ISO/IEC 18598-1 Information technology – Automated infrastructure management (AIM) systems – Requirements, data exchange and applications

TR-42.7 published ANSI/TIA-568.2-D.2 (normative version of TSB-184-A guidelines for remote powering) prior to the meeting as authorized by the default ballot during the June TR-42.7 meeting.

TR-42.7 resolved ballot comments on ANSI/TIA-568.5 (single-pair cabling) and authorized an industry ballot.

TR-42.7 resolved ballot comments on ANSI/TIA-5071 (Field testing for single-pair cabling) and authorized a committee ballot.

TR-42.7 agreed to start a project on support for power delivery over single-pair cabling. The PAR will be reviewed in January.

TR-42.9 resolved committee ballot comments to TIA-1005-B (revision to TIA-1005-A) and authorized the 2nd committee ballot.

TR-42.9 reviewed the scope of the TIA-568.7 Industrial Single-Pair Ethernet (SPE) project and two contributions. The Industrial SPE task group will meet Nov 17 at 10 AM - noon EST.

TR-42 reviewed and approved TR42-2020-10-158 TR-42 Liaison to Open Alliance on 1000BASE-T1 developed by TR-42.9. The purpose of the letter is to transmit the draft liaison agreement to the Open Alliance (TR42-2020-10-159).

TR-42.11 approved a PAR to adopt IEC 61280-4-5 (Test Procedure of MPO Cabling Plant) as a new ANSI/TIA-526 series document.

TIA-455-111 (FOTP-111), fiber curl, adoption of IEC 60793-1-34 is still in discussion and has not yet been balloted. Publication is at least a year out.

The previously planned 'Munsell sheet' round robin to understand the sources of color variability for the revision of ANSI/TIA-598-D (Optical Fiber Color Coding) has been delayed. Until the next in person meeting.

File templates are available on the TR42 FTP site for download. All contributions shall be submitted to the electronic document coordinator (EDC). All electronic files shall be provided in either Adobe Acrobat (*.PDF); Microsoft Word (*.DOC); Microsoft PowerPoint (*.PPT); or in Microsoft Excel(*.XLS). Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting.
