7. The meeting report of 3-4 June 2009 numbered TR45/09.09.02.02 was reviewed. A motion was made and passed with no objections to approve the report as amended to update assignment 5 on pages 4 and 7 to change from “copy-to the EUMAG to “copy-to TR-45.8.”
8. TR-45 Vice-Chair Election  
The Committee TR-45 Vice-Chair election was conducted. There were no nominations for TR-45 Vice-Chair from the floor. There were no objections to the motion to waive the two term limit for TR-45 Vice-Chair. Gerry Flynn of Verizon was re-elected TR-45 Vice-Chair by acclamation. Document .29 was provided for information.

9. The following Subcommittee and Ad-Hoc Group reports were provided:
- a. **TR-45.3 Subcommittee** – P.Musgrove provided Document .03 as the written report.
  - b. **TR-45.4 Subcommittee** – D.Ott, Vice-Chair TR-45.4, presented Document .04 as the written report. TIA agreed to provide a table that includes the status of all TR-45 Committee and Subcommittee documents for the Chairs to review for confirmation and to identify any additional document status needs. Feedback from the Chairs to TIA was requested by 15 November 2009. Documents .19 and .36 were provided for information.
  - c. **TR-45.5 Subcommittee** – O.Pearson provided Document .05 with attachments .05a and .05b as the written report. Documents .32R1 and .41, containing letters of support relative to the TR-45.5 leadership elections, were provided for information. TR-45 affirmed the elections of Ms. Orlett W. Pearson (Alcatel-Lucent) as TR-45.5 Chair and Mr. Ke-Chi Jang (Nortel) as TR-45.5 Vice-Chair which were by acclamation at the TR-45.5 meeting held in August 2009. Document .35 was provided for information.

TR-45.8 was instructed to direct the TR-45.8 request regarding the use of FrameMaker to the TR-45.AHEM. TR-45.8 will work with TIA regarding the TR-45.8 request to consider adopting a process for the publication of Industry Notices. Document .06a, the TR-45.8 work plan, was provided for information. Document .06b, that contains the 3GPP2 Publication Process Guidelines (SC.R1001-0), was provided for information. Documents .20 and .48 were provided for information.
  - e. **Ad Hoc Authentication Group (AHAG)** – F.Quick provided Document .07 as the written report. The AHAG Chair agreed to forward any TR-45 PN-3-0361 ballot comments to 3GPP2 TSG-S and copy-to TR-45. Document .28 was provided for information.

e. **Review and approval of EUMAG Recommendations to TR-45 re: LGE ESN Reuse for UIMID Proposal**

There was follow-up discussion relative to the recommendations and conclusions in Document TR45/09.08.27.02.

Regarding Recommendation-1:

The proposed correspondence in Document .45 was reviewed for approval. Document .45R1 as amended will be provided at the TR-45 meeting on Thursday 3 September 2009 for review for approval. Documents TR45/09.08.27.02aR1 and TR45/09.08.27.02bR1 were presented. It was reported that the R1 versions of these documents include the addition of “Expected Case Analysis in Emergency” cases related to the proposed ESN reclamation initiative for “R-UIMID use only” assignments. It was agreed that Document TR45/09.08.27.02bR1 would be beneficial reference material to attach to the correspondence in Document .45R1 and other related correspondences. The EUMAG Chair agreed to provide proposed updates to the UIM Guidelines as Document .49 at the TR-45 meeting on Thursday 3 September 2009.

Regarding Conclusion Bullet # 4:

The proposed correspondence in Document .44 was reviewed for approval. Document .44R1 as amended will be provided at the TR-45 meeting on Thursday 3 September 2009.

9. The following Subcommittee and Ad-Hoc Group reports were provided:

h. **AHG on International Mobile Telecommunications (AHIMT)** – P.Nurse provided Document .12 as the written report. Document .17 was provided for information. There were no objectives to the TR-45 Evaluation Group presenting at the ITU-R WP5D Workshop on IMT-Advanced on 15 October 2009 in Dresden, Germany. Peter Nurse, the TR-45.AHIMT Chair, graciously agreed to give the presentation at the Workshop on behalf of TR-45. Regarding the membership of the TR-45 Evaluation Group, it was agreed that all members of TR-45 are candidate members of the TR-45 Evaluation Group. The TR-45.AHIMT will provide a proposed TR-45 Evaluation Group presentation for the ITU-R WP5D Workshop on IMT-Advanced for review for approval during the interim TR-45 plenary teleconference meeting scheduled for 02 October 2009. Discussion of Document .22 was deferred until agenda item 11b.

i. **J-STD-025 Series Report** - There was nothing to report.

j. **OID Administrators Report** - The Administrator position remains vacant.

10. Relative to old business, the following item was addressed:

a. **Joint CMAS Standards Development**

Document .33 was reviewed for consideration. TR-45 endorsed the TR-45.8 recommendation that TR-45 accepts the new joint standards project with ATIS regarding the certification and testing of the CMAS C-interface. There were no objections to TR-45.8 communicating the TR-45 endorsement of the new joint standards project with ATIS regarding the certification and testing of the CMAS C-interface as provided in Document .33. Document .50 was provided for information.

b. **Joint Enhanced Wireless 9-1-1 (J-STD-036) Standards Development**

Joint enhanced wireless 9-1-1 (J-STD-036) standards development was covered previously during the TR-45.8 report under agenda item 9d.

c. **2009 TR-45 Leadership Election Affirmation**

The affirmation of the TR-45.5 leadership elections was covered previously during the TR-45.5 report under agenda item 9c. It was reported that the TR-45.3 leadership elections would be conducted during the TR-45.3 meeting scheduled for Monday 28 September 2009.

The Committee recessed at 6:00 PM Local Time on Wednesday 02 September 2009 and re-convened at 8:45 AM Local Time on Thursday 03 September 2009.

d. **GSC-14 Readout**

C.Blum provided a brief verbal report on GSC-14 held 13-16 July 2009 in Geneva. Documents .25 and .26 containing the GSC-14 Communique and the TIA Press Release on GSC-14, respectively, were provided for information. It was reported that GSC-15 will be hosted by CCSA in Beijing 30 August to 02 September 2010. It was noted that GSC-15 conflicts with the scheduled TR-45 meeting dates. C.Blum will be the TIA HoD to GSC-15.

e. **Review and Approval of EUMAG Recommendation to TR-45 re: LGE ESN Reuse for UIMID Proposal** (*continued*)

Document .44R1 was approved with no objections. Document .45R2 was approved with no objections. The proposed ESN Administrator correspondence with the UIMID Administrator regarding the UIMID proposal request will be placed on the agenda for review for approval during the interim TR-45 plenary meeting scheduled for 02 October 2009. The ESN Administrator indicated that the correspondence is under development with assistance from TIA legal. The next TR-45.EUMAG meeting is scheduled for 16 September 2009.

f. **Global Wireless Equipment Numbering Identifier Resources and Administration JEM**

The Global Wireless Equipment Numbering Identifier Resources and Administration Joint Experts Meeting (JEM) was covered previously under agenda item 9g. It was noted that JEM information is available on the TIA web site.

11. Relative to new business, the following items were addressed:

a. **ITU-R Liaison Statement on the Status of Revision 9 of Recommendation ITU-R M.1457**

Document .21 was provided to TR-45 for information at this meeting. Document .21 was remanded previously by the TR-45 Chair to TR-45.3 and TR-45.5 to review and to respond directly back to ITU-R WP5D by the 03 August 2009 due date. TR-45.3 and TR-45.5 indicated that they responded to ITU-R WP5D by the due date. Document .21 was remanded to TR-45.5 and TR-45.3 as previously directed.

b. **ITU-R Liaison Statement on Updated Information on IMT-Advanced**

The ITU-R Liaison Statement (LS) on IMT-Advanced in Document .22 contains corrections to M.2135 on channel models, updates to the ITU-R IMT-Advanced webpage, and information about the Workshop on IMT-Advanced scheduled for 8:30 AM – 12:00 PM on Thursday 15 October 2009 in Dresden, Germany. The LS was remanded previously by the TR-45 Chair to the TR-45.AHIMT for review and to take action as appropriate. Document .22 was remanded to TR-45.AHIMT as previously directed.

c. **ITU-R Liaison Statement on IMT Parameters for Band 790-862 MHz for use by JTG 5-6**

The ITU-R Liaison Statement (LS) on IMT Parameters for Band 790-862 MHz for use by JTG 5-6 is provided in Document .23. The LS is for information to TR-45. The LS was remanded previously by the TR-45 Chair to TR-45.3 and TR-45.5 to review and to take action as appropriate. It was noted that TR-45.5 continues to review the LS to determine if TR-45.5 has any input to the ITU-R. Document .23 was remanded to TR-45.3 and TR-45.5 as previously directed.

d. **ITU-R Liaison Statement on Femtocells, “Femto Access Nodes”**

Document .24 was provided for information to TR-45. Document .24 was remanded to the TR-45 Subcommittees, AHIMT, and AHAG for information.

e. **ITU-R Liaison Statement on Report M.2116 regarding BWA Systems**

Document .18 was provided for information to TR-45. Documents .18 and .18a were remanded to TR-45.3 and TR-45.5 to review and to take action as appropriate. Attention was drawn to Annex 12 of Report M.2116 and provided as Document .18a to this meeting.

g. **TIA Intelligent Devices Viewpoint**

It was reported that a conference call was held on 20 August 2009 with TIA Engineering Committee Chairs and others to discuss existing and potential work in the area of intelligent devices. It was reported that there has been discussions on the possibility of creating a new TIA Engineering Committee on "Smart Devices." A follow-up TIA Engineering Committee Chairs meeting is scheduled for 17 September 2009. Furthermore, the subject is on the proposed agenda for the upcoming TIA TC and TIA TSSC meetings scheduled for 29, 30 October 2009, respectively. Documents .34 and .46 were remanded to the TR-45 Subcommittees for information. Member companies were encouraged to provide feedback directly to the TIA VP of Standards prior to the 17 September 2009 conference call.

The Committee recessed for a break at 10:05 AM and reconvened at 10:20 AM.

h. **ARIN Presentation on IPv4 to IPv6**

Document .31 provides a presentation from ARIN on the subject of the migration from IPv4 to IPv6. John Curran of ARIN has agreed to brief TR-45 on the subject at the face-to-face TR-45 meeting in December 2009. It was noted that John Curran is scheduled to make a presentation on the subject at the 3GPP2 meeting in Hollywood, CA on Monday 21 September 2009. Document .31 was remanded to the TR-45 Subcommittees to review to determine any impacts or work needed in 2010 and report back at the next TR-45 meeting in December 2009.

i. **Cell Phones as a GPS Interference Detection and Mitigation Sensor**

Document .42 was provided for information. Attention was drawn to slide 11 in Document .42. Navsys was informed that TR-45 is an Engineering Committee of TIA thus prohibited from discussions related to financial and political issues. All discussions on the topic will be of a technical nature. Document .42 was remanded to the TR-45 Subcommittees for information.

j. **TR-45 Chair Resignation**

Cheryl Blum resigned as Chair of Committee TR-45. A plaque with a certificate of appreciation was presented from TIA TR-45 to Cheryl Blum in recognition of her years of leadership and dedication as the Chair of TIA TR-45. Document .43 was provided for information. Election of a new TR-45 Chair to serve out the remaining term is scheduled to occur during an interim TR-45 plenary meeting via teleconference on 2 October 2009.

12. In terms of Liaisons, the following was reported:

a. **CTIA** – There was no report.

b. **ITU-T** – There was no report.

c. **ITU-R** – There was no report. However, it was mentioned that the next ITU-R WP 5D meeting would be held 14-21 October 2009 in Dresden, Germany. It was noted that the proposed cut off for submissions of candidate IMT-Advanced RIT and SRIT proposals is the 14-21 October 2009 meeting of WP 5D.

d. **CITEL** – There was no report.

e. **Wireless Communications Division (WCD)** – There was no report. It was noted that the next meeting of the TIA WCD will be co-located with the TR-45 in March 2010 in Denver, CO.

- f. **TIA** – TIA will create an email reflector for TR-45 Chair. It was confirmed that TR-45 would meet in March 2010 on Tuesday and Wednesday 9-10 March 2009 in Denver, CO. A TR-45 sleeping room cost cap of \$199.00 was shared with TIA. It was noted that the ballot closed for the 5<sup>th</sup> Edition of the TIA Engineering Manual. Ballot comments were received and it is anticipated that the 5<sup>th</sup> Edition will be approved by the TIA Technical Committee during its next meeting scheduled for 29 October 2009.
