8g. AHG on ESN/UIM/MEID (EUMAG)

Document -09, the TR-45 ESN/UIM/MEID Ad Hoc Group (EUMAG) Meeting Summary w/Comments, was presented. Documents -20r1, -21r1, and -42 were provided for information. The following “TR-45 Plenary Actions” were requests from the EUMAG to TR-45 in document -09.

**<TR-45 Plenary Action #1>**

EUMAG recommends approval & publication of TR-45 091214-09b ESN Guidelines v2.1. The draft includes modifications to include clarity for return of unused ESN resources and also adds dispute resolution clarification. Also recommend application of the same changes to the specifications SC.R4002 (GHA) and SC.R4004 (UIMID) guidelines that are currently undergoing updates to 3GPP2 TSG-S.

Regarding updates to the ESN Guidelines documents -61 and -67 were reviewed for consideration relative to the last date for receipt of an ESN MFR Code block request.

**Decision 09/12-02**

TR-45 agreed without objection to extend the last date from “31 December 2009” to the new date “30 June 2010” for receipt of an ESN MFR Code block request. The ESN Guidelines (section 5.13) will be updated to reflect the new date.

**Decision 09/12-03**

TR-45 approved the EUMAG recommendation to publish the ESN Assignment Guidelines and Procedures v2.1 as amended as provided in document -09br3 and to request respective updates to the 3GPP2 TSG-S documents.

**Action 09/12-07**

The Editor will provide a clean copy of the ESN Assignment Guidelines and Procedures v2.1 (provided in document -09br3) to the Chair to request that the TIA ESN Administrator post on the TIA website.

**Action 09/12-08**

Document -09br3 (ESN Assignment Guidelines and Procedures v2.1) will be forwarded to 3GPP2 TSG-

TSG-S, noting that changes to the TSG-S documents (as determined by the TSG) may be needed. Both a clean and a marked copy of the Guidelines will be sent to 3GPP2 TSG-S.

#### **Action 09/12-09**

TR-45 will respond to the correspondences in documents -61 and -67. TR-45 will provide a reply to ZTE via email (with copy-to CDG and TIA) regarding the TR-45 decision to extend the ESN assignment deadline to 30 June 2010 and the updated version 2.1 of the ESN Guidelines. A response similar to that being forwarded to ZTE will be emailed to Huawei with a copy-to the CDG and TIA.

#### **<TR-45 Plenary Action #2>**

Determine if the recommended LGE proposal should move forward with committee correspondence citing the clear conditions of implementation, including publication of the drafted UIMID and ESN guidelines updates.

Documents -60 and -64 were reviewed for consideration regarding the "LGE Proposal" for ESN reuse for UIM\_ID assignment.

#### **Action 09/12-10**

The TR45.EUMAG Chair agreed to draft proposed TR-45 correspondence to the TIA ESN Administrator, manufacturers, and others to summarize the TR-45 endorsed proposal for ESN reuse for UIM\_ID. The draft correspondence was provided in document -65r2 for TR-45 review and approval.

#### **Decision 09/12-04**

TR-45 endorsed the proposal for ESN reuse for UIM\_ID assignment as provided in document -65r2.

#### **Action 09/12-11**

Document -65r2 was approved to be forwarded to the TIA ESN Administrator and copied-to the CDG, IFAST, 3GPP2, 3G America, Rural Cellular Association, TIA, and UIM\_ID Administrator.
