7. Review of Meeting Report from Previous Meetings

The TR-45 Committee meeting report of 12-13 December 2011 numbered TR45/12.03.07.02 was reviewed. An error in the meeting report on page 5 of 11 under agenda item 9.h sub-bullet 2 was noted. The meeting report was amended to correct the description from "It was noted that the J-STD-025-B AD-3 ..." to "It was noted that the J-STD-025-B (including AD1 & AD2) ..." A motion was made by G. Pellegrino and seconded by C.Barber to approve the revised (R1) meeting report provided in document .33a. The motion passed with no objections. The Chair will provide document .33a to TIA for legal re-review prior to distribution of the revised report of the TR-45 meeting held 12-13 December 2011.

Action TR45-2012/03-01

The Chair will provide document .33a, the revised 12-13 December 2011 TR-45 meeting report, to TIA for legal rereview prior to distribution and posting on the TIA website.

8. Reports

8a. TR-45.3 Subcommittee

On behalf of P.Musgrove, J.Ragsdale, TR-45.3 Vice-Chair, provided document .03 as the TR-45.3 report to TR-45 for information. It was reported that Peter Musgrove of AT&T was reelected Chair and Jim Ragsdale of Ericsson was reelected Vice-Chair of TR-45.3 by acclamation during the TR-45.3 meeting held on 19 December 2011. TR-45 confirmed the TR-45.3 Chair and Vice-Chair elections of P.Musgrove and J.Ragsdale, respectively.

8b. TR-45.4 Subcommittee

On behalf of D.Ott, S. Sayeedi, TR-45.4 Vice-Chair, presented document .04 as the TR-45.4 report to TR-45 for information. It was reported that five TR-45.4 standards were approved by TR-45.4 for reaffirmation and one for withdrawal and TR-45.4 plans to take the necessary steps to inform TIA.

8c. TR-45.5 Subcommittee

O. Pearson presented document .05 as the written TR-45.5 report to TR-45 for information. TR-45.5 reported that there is the need to ensure that TR-45.5 is on the contact list for ITU-R WP5D Liaisons Statements (LS) to External Organizations (EO). The TR-45.5 Chair requested an update from TIA on project requests for existing projects and changing numbers "midstream." Both of these TR-45.5 concerns were addressed during

subsequent agenda items, 10.c and 9.d, respectively. Document .21 regarding a liaison from TR-45.5 to TIA on "multiple colors codes" in standards such as TIA-856-B-1 was provided for information.

8d. TR-45.8 Subcommittee

B. Covell provided document .06r1 and its attachments as the TR-45.8 report to TR-45 for information.

8e. Ad Hoc on Authentication Group (AHAG)

There was no written Authentication Group Ad Hoc (AHAG) report.

Recommendation to Vote for Publication of TIA-PN-1053-RF1 (as TIA-1053, Broadcast/Multicast Security Framework - Reaffirmation)

It was noted that the reaffirmation ballot of TIA-PN-1053-RF1 closed and passed on 09 February 2012 with no comments. A motion was made by F.Quick and seconded by G.Flynn to approve for publication the reaffirmation of TIA-PN-1053-RF1 as TIA-1053 "*Broadcast/Multicast Security Framework*", as provided in document .51. The motion passed with no objections.

Action TR45-2012/03-02

The AHAG Chair will submit to TIA the Authorization for Publication Form for TIA-PN-1053-RF1 as TIA-1053 "*Broadcast/Multicast Security Framework*" - Reaffirmation.

• Recommendation to Vote for Publication of TIA-PN-1085-RF1 (as TIA-1085, IP-Based LCS Security Framework - Reaffirmation)

It was noted that the reaffirmation ballot of TIA-PN-1085-RF1 closed and passed on 09 February 2012 with no comments. A motion was made by F.Quick and seconded by C.Barber to approve for publication the reaffirmation of TIA-PN-1085-RF1 as TIA-1085 "*IP-Based LCS Security Framework*", as provided in document .52. The motion passed with no objections.

Action TR45-2012/03-03

The AHAG Chair will submit to TIA the Authorization for Publication Form for TIA-PN-1085-RF1 as TIA-1085 "*IP-Based LCS Security Framework*" - Reaffirmation.

8f. AHG on Electronic Media Documentation (AHEM)

- P. Nurse provided document .08 as the AHEM report to TR-45. The AHEM recommended that
 - i. TR-45 oppose TIA Standards Information Alert #003, "Use of Links in Standards."
 - ii. TR-45 community provide feedback on a webdav enable site to replace ftp access
 - iii. TR-45 reflect the contents and discussion arising from document .08 in the TR-45 report to the next TIA TSSC and Technical Committee meetings in April 2011.

The AHEM recommendations were addressed as follows:

- i. The recommendation was amended as follows:

 TR-45 recommends that TIA rescind for further study
 - TR-45 recommends that TIA rescind for further study and refinement the TIA Standards Information Alert #003, "Use of Links in Standards." There were no objections to approve this recommendation as amended.
- ii. TR-45 community provide feedback on a webdav enable site to replace ftp access It was noted that switching to webdav does not fix the problem. This recommendation was rendered moot and withdrawn.
- iii. TR-45 reflect the contents and discussion arising from document .08 in the TR-45 report to the next TIA TSSC and Technical Committee meetings in April 2011.
 - TR-45 adopted this recommendation with no objections.

Action TR45-2012/03-04

The Chair supported by the AHEM Chair will draft text that reflects the contents and discussion arising from document .08 for inclusion in the TR-45 report to the next TIA TC and TSSC meetings in April 2012 for TR-45 review.

8g. AHG on ESN/UIM/MEID (EUMAG)

Document .09 and its attachments were provided by G.Pellegrino as the TR-45 ESN/UIM/MEID Ad Hoc Group (EUMAG) report to TR-45 for information. Documents .11, .31, and .37 regarding MTS India questions on MEID standards were provided for information. The proposed outgoing TR-45 correspondence provided in document .09aR2 to MTS India regarding support of EIR and availability of handset identifier in the call flow was approved with no objections.

Action TR45-2012/03-06

The Chair will send the TR-45 correspondence in document .09aR2 to MTS India regarding support of EIR and availability of handset identifier in the call flow.

MEID Administrator's Report

J. Derr provided document .12, the MEID Administration Report, for information. Regarding ESN assignments, it was noted that nothing had changed since the last TR-45 meeting held 12-13 December 2011.

UIM_ID Administrator's Report

J.Derr provided a brief verbal report.

8h. J-STD-025 Series Report

Document .54r1, the J-STD-025 Series status table, was provided for information by G.Pellegrino. Per Action TR45-2011/12-09, TIA confirmed that at the end of 10 years, ANSI administratively withdraws a document, if it has not been reaffirmed or withdrawn. However, ANSI does not always do so in all cases.

Status of J-STD-025, J-STD-025A

Once again, TR-45 agreed to take no action on J-STD-025.

Action TR45-2012/03-07

TIA will ask ANSI what is the status of J-STD-025-A.

Recommendation to Vote to Ballot ANSI/J-STD-PN-025-A-RF1 (J-STD-025-A, "Lawfully Authorized Electronic Surveillance" - Reaffirmation)

A motion was made by G.Pellegrino and seconded by B.Covell to approve a 45-day ANSI reaffirmation ballot of ANSI/J-STD-PN-025-A-RF1 "Lawfully Authorized Electronic Surveillance" (to be published as the reaffirmation of J-STD-025-A) as provided in document .49. The motion passed with no objections.

Action TR45-2012/03-08

The Chair will submit to TIA the Ballot Authorization form for the reaffirmation of ANSI/J-STD-PN-025-A-RF1, as J-STD-025-A, "Lawfully Authorized Electronic Surveillance" – Reaffirmation.

It was re-iterated that TIA agreed to contact ATIS to coordinate the reaffirmation ballots of this joint TIA/ATIS standard. In addition, it was re-iterated that ATIS previously agreed (see TR45/11.09.07.17) to the reaffirmation of J-STD-025-A.

• Status of J-STD-025B AD-3

Even though the text for Addendum 3 to J-STD-025-B was approved by TR-45 for ballot on 07 June 2011 and the Ballot Authorization form was submitted as SP-3-4465-RV2-AD3 on 09 September 2011, it was reported that a new TIA and ANSI project has to be initiated for Addendum 3 to ANSI/J-STD-025-B. It was reported that the ANSI PINS process will take between 30-57 days before the new project number is available. TR-45 can take action at that time to initiate the ballot of Addendum 3 to ANSI/J-STD-025-B. It was noted that the TR-45 approved ballot ready text for Addendum 3 to ANSI/J-STD-025-B (Lawfully

Authorized Electronic Surveillance (LAES) Addendum 3 - Addition of BSID or Subnet) was available in TR45/11.06.01.22ar1.

- Recommendation to Vote to Initiate ANSI Project for ANSI/J-STD-PN-025-B-3 (Addendum 3 of J-STD-025-B, "Lawfully Authorized Electronic Surveillance Addition of BSID or Subnet")
 A motion was made by G.Pellegrino and seconded by O.Pearson to initiate an ANSI project for Addendum 3 of J-STD-025-B, "Lawfully Authorized Electronic Surveillance Addition of BSID or Subnet." The motion passed with no objections.
- Recommendation to Vote to Ballot ANSI/J-STD-PN-025-B-3 (Addendum 3 of J-STD-025-B, "Lawfully Authorized Electronic Surveillance – Addition of BSID or Subnet")

A motion was made by B.Covell and seconded by M.Beinn to approve a 45- day ANSI ballot of Addendum 3 of J-STD-025-B, "Lawfully Authorized Electronic Surveillance – Addition of BSID or Subnet" with three caveats:

- that the ballot close date be coordinated between TIA and ATIS
- pending the ANSI project initiation of J-STD-025-B AD3
- pending the reaffirmation publication of J-STD-025-B including AD1 and AD2

The motion passed with no objections.

Action TR45-2012/03-30

TIA will initiate the ANSI project for Addendum 3 of J-STD-025-B.

Action TR45-2012/03-09

The Chair will submit the Ballot Authorization form for Addendum 3 of J-STD-025-B as provided in document TR45/11.06.01.22ar1 once the ANSI project has been initiated and the reaffirmation publication of J-STD-025-B including Addendum 1 and Addendum 2 are completed.

Action TR45-2012/03-10

TIA will coordinate with ATIS on the close date of the ballot of Addendum 3 to J-STD-025-B.

It was noted that the J-STD-025-B reaffirmation is ready for ANSI publication. However, the Addendum 1 and Addendum 2 of J-STD-025-B reaffirmations were still pending ANSI publication. Nevertheless, there were no objections to concurring with S. Barclay of ATIS to request that ANSI move forward with the reaffirmation publication of J-STD-025-B with the understanding that the ANSI reaffirmation publication of Addendum 1 and Addendum 2 of J-STD-025-B will follow shortly.

8i. OID Administrators Report

There was nothing to report. It was noted that S.Montgomery will replace V.Mitchell as the TIA contact point for OID Administration. The agenda will be updated to reflect the TIA contact change.

Action TR45-2012/03-11

TIA plans to setup a call with G.Pellegrino to bring S.Montgomery up to date on the OID Administration issues.

9. Old Business

9a. Joint CMAS Standards Development Status

There was no additional information to report beyond that which was provided in document .06r1, the TR-45.8 report to TR-45. The Spanish language work is moving forward in ATIS WTSC only. There are no plans to do the Spanish language work in the JCMAS group. Plans are in place to develop addenda to the published JCMAS standards to address needed editorial and bug fixes. Overall work is winding down in JCMAS.

9b. Joint Co-Existence and Interference Standards Development

J. Ragsdale provided a brief verbal report on the status of the joint co-existence and interference standards development work. Plans are to baseline Phase I in 2Q2012. The next two meetings of JCOEXIST are scheduled
