7. Review of Meeting Report from Previous Meetings

The TR-45 Committee 6-7 December 2012 meeting report numbered TR45/12.12.06.02 was reviewed. A motion was made by B.Covell and seconded by G. Pellegrino to approve the meeting report provided in document .02. The motion passed with no objections.

8. Reports

8a. TR-45.3 Subcommittee

J.Ragsdale presented document .03 as the TR-45.3 report to TR-45 for information.

8b. TR-45.4 Subcommittee

D.Ott presented document .04 as the TR-45.4 report to TR-45 for information.

8c. TR-45.5 Subcommittee

O. Pearson presented document .05r1 as the TR-45.5 report to TR-45 for information. Regarding the joint ATIS/TIA Standard on Coexistence and Interference Issues in Land Mobile Systems work, it was reported that work continues jointly with ATIS to discuss the ATIS/TIA Coexistence and Interference Standard P0017-v0.792. The document was approved and sent out for a 30-Day ballot. Joint sessions will be held after the 21 March 2013 ballot close date to address ballot comments, if any.

8d. TR-45.8 Subcommittee

B. Covell provided document .06r1 with attachments A-C as the TR-45.8 report to TR-45 for information. It was reported that TR-45.8 held elections for Chair at the meeting held 14 December 2013. Betsy Covell of Alcatel-Lucent was re-elected as Chair by acclamation. TR-45 confirmed the election the Betsy Covell as Chair of Subcommittee TR-45.8.

Regarding JCMAS, J-STD-100.a Joint ATIS/TIA CMAS Mobile Device Behavior Specification, J-STD-101.b Joint ATIS/TIA CMAS Federal Alert Gateway to CMSP Gateway Interface Specification, and J-STD-102.a Joint ATIS/TIA CMAS Federal Alert Gateway to CMSP Gateway Interface Test Specification, were published on 01 February 2013. It was reported that no contributions have been submitted yet for the Spanish language JCMAS project.

Regarding JSMS911, it was reported that J-STD-110 Joint ATIS/TIA Native SMS TO 9-1-1 Requirements and Architecture Specification was submitted for ballot on February 4, 2013. Ballot comment resolution is scheduled to be held via conference call on 11-12 March 2013. During the development of J-STD-110, it was determined that updates were required to J-STD-036-C to add position source codes for texting to 9-1-1 and small fixed cells. Accordingly, at the March 21 meeting TR-45.8 will initiate a new joint project with ATIS WTSC SN¹ to develop an addendum to J-STD-036-C.

8e. Ad Hoc on Authentication Group (AHAG)

Document .07r1 was provided by F.Quick as the AHAG report to TR-45 for information. Document .19 was provided for information.

- Recommendation to Vote for Reaffirmation of TIA-946-A “Enhanced Cryptographic Algorithms”
There was a vote to reaffirm TIA-946-A (PN-3-0361). A motion to reaffirm TIA-946-A was made by F.Quick and seconded by G.Pellegrino. There were no objections and there were no abstains to the motion.

P.Nurse provided correspondence in document .08 to resign the positions of AHM Chair and AHIMT Chair. TR-45 expressed appreciation and extended thanks for the years that Peter Nurse has contributed and supported TR-45 in his roles as Chairs of the AHM and AHIMT. There were no objections to disbanding the AHM.

There were no objections to endorse SC R4002-0 v8.3 GHA Assignment Guidelines and Procedures for MEID_ draft [editor] as provided in document .09a to be provided to 3GPP2 for consideration for publications as v9.0.

8h. **J-STD-025 Series Report**

Document .11r2, the J-STD-025 Series TR-45 activity status table, was provided for information by G.Pellegrino. It was reported that TIA submitted ANSI/J-STD-025-B-3 to ANSI and is awaiting publication confirmation.

9. **Old Business**

9a. **Resubmission of Text for Publication**

To re-iterate, TIA agreed to the use of the same Authorization for Publication online entry form with a note in the comment field regarding the resubmission of updated publication text prior to actual publication. TIA noted that an additional button to replace the need for an explicit comment is being worked.

9b. **TIA TSB-10 "Interference Criteria for Microwave Systems"**

TSB-10 "Interference Criteria for Microwave Systems" was transferred from the former TR-14.11 to TR-45 for revisions. It was proposed that a new non-formulating Working Group (WG) be established in TR-45 to conduct the work. The proposed Working Group would be as follows:

Name: Microwave Systems Working Group (MSWG)

Scope: The development of recommendations for performance of microwave systems.

Chair < to be determined >

Convener: Patrick Picquet of Alcatel-Lucent

It was noted that the Chair of the WG does need to be a member of TIA or one of the TR-45 Subcommittees. However, Subject Matter Experts (SMEs) can participate as guest to contribute to the WG. In addition, the WG could conduct co-located meetings with NSMA WG-3. Document .31 was provided for information.

- **Recommendation to Establish a TR-45 Working Group for Microwave Systems**

A motion was made by G.Pellegrino and seconded by B.Covell to establish a TR-45 Working Group on Microwave Systems. There were no objections to the motion.

The Chair will work with P.Picquet to schedule and conduct the kick-off meeting of the new TR-45 Microwave Systems Working Group (MSWG).

Through TIA, TR-45.5 provided inputs to the GSC Task Force Report on Emergency Communications. In January 2013, TIA worked with ATIS to review and coordinate inputs to sections of the Report relative to the U.S. The cut-off date for Report inputs was 8 March 2013. The TF plans to submit the final version of the Report on Emergency Communications into the next GSC meeting. The next meeting of GSC (GSC-17) is scheduled for the week of 13 May 2013 in S.Korea on Jeju Island. Documents .18, .23, .32, and .24 were provided for information.

9d. TIA Comments to NIST on Draft Guidelines on Hardware-Rooted Security in Mobile Devices

Document .25 was provided for information.

9e. Common IMS Documents

It was agreed that concerns and questions relative to the transfer of Common IMS documents from 3GPP2 to 3GPP should be addressed within 3GPP2. Unless there is incoming correspondence from 3GPP2 this item will be consider closed at this time.

The modified TR-45 scope & charter to accommodate the formation of the new Working Group on Microwave Systems was provided in document .21r1 was reviewed and decision. It was noted that the proposed modification were based on the former scope of TR-14 prior to April 2012. There were no objections to approving the modified TR-45 scope & charter as provided in document .21r1.

Document .17 contains the timeline, milestones, and deliverables for the new update process for M.1457. The new process goes into effect as of the 16th meeting of 5D in July 2013.

It was noted that there are two deliverables for “meeting-x” 10 July 2013.

1. “Exceptional Form A”
2. Initial Announcement of Revision to M.1457 (i.e., Letter of Intent)

The “Exceptional Form A” is required to reconfirm the GCS Proponent for each of the current IMT-2000 technologies. “Exceptional Form A” as provided in Annex 1 of document .17a must be completed, signed, and returned to 5D by 16:00 hours UTC on 3 July 2013 (7 days before the 16th meeting of WP 5D) by the appropriate GCS Proponent. The GSC Proponent for

- IMT-2000 CDMA Multi-Carrier (MC) is ARIB, CCSA, TIA, TTA, and TTC (on behalf of 3GPP2)
- IMT-2000 TDMA Single-Carrier (SC) is ATIS and TIA

TIA will need to complete two separate “Exceptional Form A” one for CDMA-MC and one for TDMA-SC in coordination with the associated GSC Proponent.

Action TR45/2013-03-12

Relative to the milestones in document .17, the Chair agreed to work with TIA and 3GPP2 to ensure that the Exceptional Form A and Letter of Intent for CDMA-MC are submitted to 5D prior to “meeting-x” 3 July 2013.
