7. Review of Meeting Report from Previous Meetings

The TR-45 Committee 10 June 2013 meeting report numbered TR45/12.09.04.02 was reviewed. A motion was made by F.O'Brien and seconded by G.Pellegrino to approve the meeting report provided in document .02. The motion passed with no objections.

8. Reports

8a. TR-45.3 Subcommittee

J.Ragsdale presented document .03r1 as the TR-45.3 report to TR-45 for information.

8b. TR-45.4 Subcommittee

It was noted that TR-45.4 had not met since the last TR-45 meeting. The next TR-45.4 is scheduled for the week of 09 September 2013. It was noted that a new Project Number on Wireless Priority Services for interoperable services is anticipated.

8c. TR-45.5 Subcommittee

O. Pearson presented document .05 as the TR-45.5 report to TR-45 for information. Regarding the joint ATIS/TIA Standard on Coexistence and Interference Issues in Land Mobile Systems, it was reported that the ATIS/TIA Coexistence and Interference Standard (J-STD-111) was approved for re-ballot in May 2013. The re-ballot closed and the ballot comments were addressed. Plans are for both TIA TR-45.5 and ATIS WTSC to approve the joint standard for publication at their respective meetings in September 2013.

8d. TR-45.8 Subcommittee

B. Covell provided document .06 with attachments a-c as the TR-45.8 report to TR-45 for information. Document .21 was provided for information.

Regarding JCMAS, it was reported that the joint project to add Spanish language alerts to JCMAS is on hold. ATIS completed their work to add Spanish language alerts to CMAS. Recently, FEMA has recommended an alternate approach to the approach WTSC-SN standardized for CMAS Spanish-language support which may affect the joint project. In addition, the joint project on Canadian Commercial Mobile Alerts Service (CMAS) is on hold, pending input on Canadian CMAS requirements.

Regarding JSMS911, it was reported that an addendum to J-STD-110 has been approved by both TIA and ATIS to address the implementation issues that have arisen following the publication of J-STD-110 earlier this year. In addition, work continues on CMRS and TCC Provider Implementation Guidelines for the Joint ATIS/TIA SMS to 911 Standard (J-STD-110).

8e. Ad Hoc on Authentication Group (AHAG)

Document .07 was provided by F.Quick as the AHAG report to TR-45 for information. A motion was made by F.Quick and seconded by G.Pellegrino to pre-approve the ballot of TIA-PN-4999 "Security Framework for Binding of Access Subscription with Device(s)" (3GPP2 S.P0152). The motion passed with no objections. It was noted that a description of TIA-PN-4999 is available in document .29.

29 revision 12 updates of M.1457 (IMT-2000) was reviewed. There was lengthy discussion regarding the
30 deliverables for meeting "X+1" (October 2013) and either meeting "X+2A" (February 2014) or "X+2B" (June
31 2014). It was noted that the GCS Proponents need to select either meeting "X+2A" or "X+2B". Based on the
32 TR-45 meeting's deliberations, it was agreed that meeting "X+2B" in June 2014 is preferable due to the 3GPP2
33 meeting schedule for 2014. In addition, TIA volunteered to continue to submit the deliverables for updates to
34 M.1457 for CDMA-MC on behalf of the GCS Proponents.

TR-45 members were encouraged to review the “White Papers” provided and to provide feedback to CTIA. Updates to the “White Papers” are planned.

10i. FCC Request for Air Interface Standards

On Wednesday 21 August 2013 members of TR-45 participated on a conference call with representatives from the FCC, TIA, and TR-45 to address an FCC request for information on air interface standards. The TR-45 representatives on the call were J.Ragsdale/Chair TR-45.3, O.Pearson/Chair TR-45.5, and J.Brownley/Chair TR-45. The FCC wanted to: 1. identify air interface standards on receiver and transmitter performance

specifications, 2. identify any standards on interference criteria, 3. understand the process of coordination between TR-45 and other SDOs, and 4. identify current work items on these topics of interest. The catalyst for this request was an FCC Technical Advisory Council (TAC) recommendation to the Commission to consider adding references on the FCC spectrum dashboard to industry standards on receiver and transmitter and related performance specifications. TIA plans to consolidate the list of air interface standards provided by TR-45 and other TIA Engineering Committees to share with the FCC. A copy of the consolidated list will be provided to TR-45 at the next TR-45 meeting in December 2013.

The TIA TSSC provided a preview and overview as well as a diff-marked version of the upcoming 6th Edition of the TIA Engineering Manual. In general, the Manual will be revised into two separate documents. The Engineering Manual will focus on compliance with ANSI Essential Requirements and the Operations Manual will focus on TIA requirements, procedures and policies. Plans are for final review and comments in early October 2013 with TSSC and TC approval in late October 2013. Documents .25 and .26 were provided for information.

The ANSI Standards Action Newsletter, in document .28, was provided for information only.
