MEETING REPORT TIA TR-51 Smart Utility Networks Monday, May 6, 2013 Teleconference Meeting

1. Call to Order

6. Review and Approve the March 22, 2013 Meeting Report

The March 22, 2013 Meeting Report, TR51-20130322-003r0, was reviewed and approved.

7. Publication status of ANSI/TIA PN-4957 Standard

Everything but the Overview and Architecture has been published. The Overview and Architecture is awaiting a title change.

Jeff pointed out that the title is Overview and Architecture. The suggested change is to "Architecture Overview for the Smart Utility Network".

For the MHDS specification, the title is ANSI/TIA-PN-4957.210 Multi-hop Delivery Specification of a Data Link Sub-Layer, and the recommended change is to "ANSI/TIA-PN-4957.210 Multi-hop Delivery Specification of a Data Link Sub-Layer for the Smart Utility Network".

For layer 3, the title is ANSI/TIA-PN-4957.300 Network Layer Specification, and the recommended change is to "ANSI/TIA-PN-4957.300 Network Layer Specification for the Smart Utility Network".

For layer 4, the title is ANSI/TIA-PN-4957.400 Transport Layer Specification, and the recommended change is to "ANSI/TIA-PN-4957.400 Transport Layer Specification for the Smart Utility Network".

8. Submission of 4957 Series to ISO

There was discussion of how to take the next step. Contacting INCITS to promote the TIA 4957 standard is next. The contact is Phil Wennblom. Jeff will take the action to make the initial contacts with INCITS.

9. Submission of 4957 Series to IEC

The pursuit of IEC is on hold pending the outcome of pursuing ISO publication.

10. Any Other Business

The discussion centered on the meeting facilities for the scheduled Geneva meeting of TR-51 in July. The issue is finding a meeting room that is suitable. Jeff Hannah is in discussion with Dawn Slykehouse of Face to Face Events to try to identify the best room.

There was discussion about the meeting after July 2013. Jeff suggested meeting with the TIA 2013 meeting during October 8-10, 2013 in Washington, D.C. Tom Herbst indicated that he would have to dial-in to the call.

Jeff Hannah asked the Secretary to add an agenda item for Geneva to address the opportunity to submit the 4957 series to SGIP2.
