Patent searches are not required to comply with the TIA IPR policy. Moreover, the Engineering Manual describes the need for members' disclosure of patents that are essential to practice TIA publications and for members to provide an indication of their willingness to license any known patents.

2 Old business

2.1 Liaison letters received since the opening plenary

No liaison letters were received.

2.2 Subcommittee reports and plenary action

2.2.1 TR-42.1 – Commercial Building Cabling

Glenn Sexton presented TR42-2011-10-149.

A motion to approve TIA-568-C.1-1 for publication was approved without objection.

A motion to approve a new project for Educational Buildings (TR42-2011-10-150 and TR42-2011-10-151) was approved without objection.

2.2.2 TR-42.2 – Residential Telecommunications Infrastructure

Ray Emplit presented TR42-2011-06-087.

2.2.3 TR-42.3 – Commercial Building Telecommunication Pathways and Spaces

Ray Emplit presented TR42-2011-10-138.

A motion to approve TIA-569-C for publication was approved without objection.

2.2.4 TR-42.5 – Telecommunications Infrastructure Terms and Symbols

Paul Kish presented TR42-2011-10-148.

2.2.5 TR-42.6 – Telecommunications Infrastructure Administration

Steve Huffaker presented TR42-2011-10-139.

2.2.6 TR-42.7 – Telecommunications Copper Cabling Systems

Sterling Vaden reported that elections were held and that Mr Vaden was elected Chair for TR-42.7 with Val Maguire being elected Vice Chair.

Mr Vaden then presented TR42-2011-10-142.

Mr Vaden clarified that the Next Generation Cabling project had baseline objectives, not requirements. These can be found in TR-42.7 document number TR427-2012-02-003.

In response to a question from the floor, Mr Vaden explained that the major considerations for copper cabling using the expanded ASHRAE HVAC envelopes for data centers would be the effect on cable insertion loss, detailed in ANSI/TIA-568-C.2, and possible reduction in maximum power to be delivered over the cable (PoE), detailed in TSB-184.

Following discussion it was decided to expand the scope of the BICSI cabling survey to include fiber optic cabling. TR-42 Chair Bob Jensen requested that the survey be initiated by TR-42. TR-42.7 will provide an updated survey which will be reviewed via conference call before being sent to BICSI.

Following the meeting an updated report was posted to the TR-42 FTP site as document TR42-2011-10-142a.

2.2.7 TR-42.9 – Industrial Telecommunications Infrastructure

Brad Woodman presented TR42-2011-10-143a.

A motion to approve TIA-1005-A for publication was approved without objection.

Mr Woodman also reported that TR-42.9 members expressed interest in the following potential TR-42 task groups: Energy Efficiency and Network Security.

Following Mr Woodman's report several TR-42 members expressed interest in joining the new TR-42.9 task group for 1G noise testing.

2.2.8 TR-42.11 – Optical Fiber Systems

Paul Kolesar reported that he had been reelected as Chair of TR-42.11 and Dave Mazzarese had been reelected as Vice Chair.

Mr Kolesar then presented TR42-2011-10-146.

Following the meeting an updated report, correcting the quorum information and adding the election results, was posted to the TR-42.FTP site as document TR42-2011-10-146a.

2.2.9 TR-42.12 – Optical Fibers and Cables

Mike Kinard presented TR42-2011-10-147. Mr Kinard corrected the report by noting that the IEC document to be adopted (see page 3) is IEC 60794-1-44.

In response to questions from Mr Kinard about the approval processes for new projects and for publication of documents a training session will be added to the meeting schedule for the February TR-42 meeting.

Mr Kinard stated that he felt the approval process outlined in the TR-42 Operational Guidelines was too cumbersome considering the large number of documents processed by the former FO-4 subcommittees. In response TR-42 Chair Bob Jensen indicated that the process should be followed and that proposed revisions to streamline the process are welcome. Mr Jensen will organize a conference call with the Chairs of TR-42.11, TR-42.12 and TR-42.13 to discuss the issue.

A motion to approve TIA-455-C for publication was approved without objection.

2.2.10 TR-42.13 – Interconnecting Devices and Passive Components

Dave Fisher presented TR42-2011-10-144.

During the presentation two project requests (see TR42-2011-10-145) for TIA-455-224 and TIA-455-226 were approved without objection.

Mr Fisher noted that, on slide 9 of the report, the correct document number for the likely adoption of the IEC version of TIA-604-10A would be TIA-604-10C.

2.2.11 TR-42.16 - Bonding and Grounding

Rich Jones reported the following activities at this week's TR-42.16 meeting:

- The issue about the new cable tray requirements in the *National Electrical Code®* was referred to the BICSI Codes Committee.
- Work will begin on a new addendum to TIA-607-B for external grounding and testing. A draft and project request is expected for the February meeting.

Following the meeting a report was posted to the TR-42 FTP site as document TR42-2011-10-152.

2.3 Proposed changes to TR-42 Operational Guidelines

2.3.1 Proposal for ballot documents and ballot resolution documentation

The proposed changes to the TR-42 Operational Guidelines as documented in TR42-2011-10-106 were approved without objection. TR-42 Chair Bob Jensen will make the changes to the Operation Guidelines which will then be posted to the TR-42 FTP site.

2.3.2 Operations Guide conflict re consensus

Bob Jensen reported that the task group formed to study the issue had not met since the June TR-42 meeting. Mr Jensen will schedule a conference call to begin work.

2.3.3 Operational efficiency

Operational Efficiency Task Group Chair Ray Emplit presented TR42-2011-10-120. Mr Emplit reported that the Task Group recommended no changes to the Operational Guidelines and requested that the Task Group be disbanded. This request was approved without objection.

2.4 Program of work

Bob Jensen reminded the subcommittee Vice Chairs that they were responsible for maintaining their subcommittee's entries.

2.5 Other

There was no other old business.

3 New business and output documents

Ray Emplit will chair a task group to study this issue. Interested parties are encouraged to contact Mr Emplit.

- Bob Jensen to organize conference call to discuss possible changes to Operational Guidelines (see 2.2.9).

- Jonathan Jew to chair task group considering a possible data center fabric addendum (see 3.2.1).
- Ray Emplit to chair a task group to consider new work on network security (see 3.2.5).

Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting. All contributions shall be posted to the appropriate location on the TIA FTP site no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).
