## 1 Administrative

1.1 The Meeting

The Chair, Mr. Fred Lucas, called the meeting to order at 10:40 a.m. on Friday, April 11, 2003. The meeting was held at TIA Headquarters, Arlington, VA. The meeting was hosted by TIA. Mr. Lucas announced that a quorum was present.

1.2 The Meeting Report

The Report of Meeting Number 218 (TR-30/03-04-003), February 21, 2003, was reviewed and approved.

#### 1.3 IPR Statements

The Chair encouraged anyone who was aware of IP that relates to the work of TR-30 or its subcommittees to make the appropriate statements as early as possible in the process. The Chair directed the members to the TIA Engineering Manual, and the TIA web site (www.tiaonline.org), for the specific requirements.

## 2 International Meetings

Upcoming international meeting related to TR-30 and its subcommittees is the 20 - 30 May 2003 ITU-T Study Group 16 meeting in Geneva, Switzerland. The Chair announced that the ITAC-T Study Group D meeting for Study Group 16 will be held at the TIA Washington, DC office at 11:00 am on May 6<sup>th</sup>. Mr. Steve Pershau will be chairing that

meeting and has requested that all contributions for Study Group 16 be sent to him before April 21, 2003 since he will be traveling from that date until May 5<sup>th</sup>.

#### 3 Subcommittee Activities

4.1 TR-30.1

Mr. Chu brought forth two contributions from TR-30.1 which were proposed US contributions to ITU-T Study Group 16 for Study Group D approval:

TR-30/03-04-005, Request for a new Recommendation defining VBD-only Gateways

TR-30/03-04-006, Use of Recommendation T.140 in V.ToIP

TR-30 unanimously approved these as proposed US contributions.

Mr. Chu also reported that at least two company contributions, from Cisco Systems, would be going to Study Group D.

4.2 TR-30.2

Mr. Lucas reported that there would be one company contribution, from 3Com, going to the Study Group D meeting.

4.3 TR-30.3

Mr. Lucas reported that TR-30.3 had held a joint meeting with TR-30.1 and TR-30.5 on Wednesday morning, April 9<sup>th</sup>. During that meeting the latest draft of PN-3-0062, Network Model for Evaluating Modem Over Internet Protocol Transmission Performance (TR-30/03-04-004) was reviewed by the joint meeting. It was agreed to keep the groups informed of the progress on this work.

4.4 TR-30.5

On behalf of the TR-30.5 Chair, Mr. Geary, Mr. Chu brought forth two contributions from TR-30.5 which were proposed US contributions to ITU-T Study Group 16 for Study Group D approval:

TR-30/03-04-007, Proposed Correction to T.38(2002) Regarding ASN.1 Syntax compatibility

TR-30/03-04-008, Proposed Correction to T.30 Amendment 1 (02/2000) Regarding Table 2, Bits 112-115

TR-30 unanimously approved these as proposed US contributions.

Mr. Chu also reported that there were a number of company contributions reviewed going to Study Group D.

#### 5.4 Meeting Participation
