

1 Administrative

1.1 The Meeting

The Chair, Mr. Fred Lucas, called the meeting to order at 5:20 p.m. on Friday, August 10, 2004. The meeting was held at the Hamilton Crown Plaza, Washington, DC. The meeting was hosted by TIA. Mr. Lucas announced that a quorum was present.

1.2 The Meeting Report

The Report of Meeting Number 224 (TR-30/04-08-004), June 11, 2004, was reviewed and approved.

1.3 IPR Statements

The Chair encouraged anyone who was aware of IP that relates to the work of TR-30 or its subcommittees to make the appropriate statements as early as possible in the process. The Chair directed the members to the TIA Engineering Manual, and the TIA web site (www.tiaonline.org), for the specific requirements.

2 International Meetings

The Chair reported that the next international meeting related to the work of TR-30 will be a joint Question 11/16 Rapporteurs meeting following the TR-30 meetings August 11 – 13.

The next ITU-T Study Group16 meeting will be November 16 – 26, 2004 in Geneva, Switzerland. The US ITAC-T Study Group B preparatory meeting is tentatively scheduled for October 26, 2004.

3 Subcommittee Activities and Actions

4.1 TR-30.1

Keith Chu, TR-30.1 Chair, indicated that TR-30.1 had completed the technical work on draft standard TIA-1001, *Transport of TIA-825-A Signals over IP Networks*. He also indicated that the editor was doing the final "clean-up" on the draft text in preparation for ballot. TR-30.1 has approved going to ballot after allowing a final review, via email, of the draft text by the committee. TR-30 agreed to the TR-30.1 approach and also approved going to TIA ballot.

Mr. Chu asked permission to hold an interim conference call prior to the US ITAC-T Study Group B meeting. The meeting would be to approve contributions to the ITU-T Study Group 16 meeting in November that need the approval of US Study Group B. A tentative date of the week of October 18th was proposed. TR-30 approved this interim call. Mr. Lucas indicated that TR-30 would also participate in the call to provide final TIA approval for the contributions.

Mr. Chu announced thatTR-30.1 agreed to accept the work that had been within TR-30.5. TR-30 had approved this change at the June meeting contingent upon TR-30.1's acceptance. Mr. Lucas indicated that he will make the appropriate changes with TIA to move this work.

4.2 TR-30.2

TR-30.2 did not meet during this week. There were no action items.

4.3 TR-30.3

Jack Douglass, TR-30.3 Chair, indicated that they were looking at the possibility of submitting their draft standard for IP Network Test Suites to ITU-T Study Group 12 for information. The possible issue of copyright was raised. Mr. Lucas indicated that he consult with TIA regarding this issue.

Mr. Douglass requested approval for an interim meeting for TR-30.3. This would probably be via conference call. TR-30 approved the interim meeting which was tentatively scheduled for October 4, 2004.

4.4 TR-30.5

The work of TR-30.5 has now been moved to TR-30.1.
