1 Administrative

1.1 The Meeting

1.2 Agenda

1.3 The Meeting Report

The Report of Meeting Number 233 (TR-30/06-12-008R1), September 28, 2006, was reviewed and approved.

1.4 IPR Statements

The Chair encouraged anyone who was aware of IP that relates to the work of TR-30 or its subcommittees to make the appropriate statements as early as possible in the process. The Chair directed the members to the TIA Engineering Manual, and the

TIA web site (www.tiaonline.org), for the specific requirements. The Chair indicated that IPR statements also apply to Normative references in draft standards.

1.5 Leadership Change at TIA

The Chair announced that Dan Bart, TIA Vice-President of Standards was retiring at the end of December but would be continuing as a consultant to TIA.

2 International Meetings

The Chair announced that the meetings of ITU-T Study Group 16 were held November 14 – 24, 2006 in Geneva, Switzerland. The next meeting of ITU-T Study Group 16 is scheduled for June 25 – July 6, 2007 in Geneva Switzerland.

3 Subcommittee Activities and Actions

3.1 TR-30.1

Mr. Chu, TR-30.1 Chair, indicated that there might be a need for TR-30.1 to hold interim conference calls to start to resolve comments which might be received on TIA ballot PN-3-4643. TR-30 approved TR-30.1 holding as many conference calls as needed prior to the April 2007 TR-30 meetings.

3.2 TR-30.2

Mr. Lucas, TR-30.2 Chair, indicated that TR-30.2 had no action items. Mr. Lucas did indicate that TR-30.2 had approved reaffirmation ballots on 6 standards.

3.3 TR-30.3

Mr. Lucas introduced a contribution (TR-30/06-12-010) from TR-30.3 indicating that they had approved reaffirmation of TIA/EIA-793, *North American Telephone Network Transmission Model for Evaluating Analog Client and Digitally Connected Server Modems*. Mr. Lucas indicated that if this were just a TIA standard the reaffirmation could have taken place in TR-30.3 however, since this is an ANSI standard it must go through a reaffirmation ballot. Mr. Lucas indicated that he has informed the TR-30.3 Chair, Mr. Douglass, of this. Mr. Douglass has informed the TR-30 Chair that he will initiate the required ballot.
