

#### 1 Administrative

#### 1.1 The Meeting

The Chair, Mr. Fred Lucas, called the meeting to order at 10:40 a.m. on Friday, July 25, 2003. The meeting was held at the Adam's Mark Hotel, Dallas, TX. The meeting was hosted by TIA. Mr. Lucas announced that a quorum was present.

#### 1.2 The Meeting Report

The Report of Meeting Number 219 (TR-30/03-07-009), April 11, 2003, was reviewed and approved.

#### 1.3 IPR Statements

The Chair encouraged anyone who was aware of IP that relates to the work of TR-30 or its subcommittees to make the appropriate statements as early as possible in the process. The Chair directed the members to the TIA Engineering Manual, and the TIA web site (www.tiaonline.org), for the specific requirements.

#### 1.4 TIA Changes

The Chair reported on recent changes at TIA as a result of staff reductions.

#### 1.5 Meeting Hotel Reservations

This was the first meeting where hotel reservations were to be made through the TIA meeting planner. The Chair thanked those who had followed directions and made their reservations in the proper way. All attendees who had made these reservations found the process poor. Complaints were unanimous that when they sent their information to the meeting planner they receive no confirmation that it was ever received. In addition, confirmation numbers were only received the Friday prior to the meeting. It was agreed that this was unacceptable. The Chair was asked to work with TIA to assure that the planner respond immediately to the members to confirm receipt of their reservation and that confirmation numbers be distributed no more than 5 working days after the cut-off date. If this was not possible then members indicated that they will make reservations directly with the hotels.

#### 2 International Meetings

The Chair reported that the Study Group 16 meeting had been held in May in Geneva, Switzerland. The next Study Group 16 meeting is tentatively scheduled for January 20 – 30. 2004.

#### 4.1 TR-30.1

The TR-30.1 Chair, Mr. Chu, reported that TR-30.1 would like to schedule a joint meeting with TR-41.4 during 2004.

#### 4.2 TR-30.2

The TR-30.2 Chair, Mr. Lucas, reported that TR-30.2 will not have a meeting during the September TR-30 meeting week.

#### 4.3 TR-30.3

TR-30.3 did not meet during this week therefore, there were no action items for consideration.

#### 4.4 TR-30.5

Mr. Lucas reported that TR-30.5 had agreed that TIA/EIA-668-A – *High Frequency Radio Facsimile*, should be reaffirmed. TR-30 unanimously agreed to submit the standard for reaffirmation.
