

1 Administrative

1.1 The Meeting

1.4 TR-30.5

1.5 TR-30 Names and Scopes

The Chair reported that the TIA Technical Committee had approved the name change for TR-30. He then presented TR-30/04-03-002 as a working proposal for the revised scope for TR-30. The committee discussed the proposal and agreed upon the following new scope:

Responsible for access, protocol and interface standards for Modems, Facsimile Systems and Multimedia Platforms pertaining to wired telecommunications networks. Standards include those for functional characteristics, interfaces, interworking (including protocols), electrical and mechanical characteristics, and network models and evaluation procedures. The committee is also responsible for the development of proposed U.S. contributions, relating to this work, to international standards fora. In addition, it provides a venue for discussion of company contributions to these fora.

1.6 Creation of a new Sub-Committee

The Chair proposed the creation of a new sub-committee to provide a venue for the discussion of technical contribution which would be going to WP2 of Study Group 16. Mr. Paul Jones, Cisco Systems, objected to the creation of this sub-committee. The Chair was asked to contact the chair of ITAC-T Study Group B asking if it is still felt that there should be a US technical forum for consideration of WP2 contributions prior to Study Group B consideration.

2 International Meetings

The Chair reported that the next international meeting related to the work of TR-30 will be a joint TR-30.1/Question 11/16 Rapporteurs meeting the week of August 9th.
